NPC, PAPI call on BBM to strengthe n media task force The National Press Club of the Philippines has passed a special resolu-

tion calling on the incoming Marcos administration to continue supporting the operation of the Presidential Task Force on Media Security (PTFoMS)



"As one of the national media organizations actively engaged as mediapartner and stakeholder of the task force since its creation by President Duterte in 2016, we have seen how effective the task force has been in fulfilling its mandate of giving protection to the life, liberty and safety of all media workers," NPC president Lydia Bueno said in a news release on Friday.

"We believe its con-

tinuation under the Marcos administration would send the strong message to the world that it is just as committed, if not more, in upholding a free and responsible press that was started by the Duterte administration," she added.

Under Special Resolution No. 1, series of 2022, the NPC noted that since the creation of the PTFoMS in October 2016, media workers

have relied on the task force as their direct line to the Office of the President for prompt action on their concerns.

Bueno also noted that despite its limited resources as an ad-hoc body, the task force has made significant impact in the country's media landscape and it is now also the repository of the most authoritative and documented reports on all cases of media-re-NPC, PAPI • 2

lated violence in the country.

In the May 9 elections, Bueno noted that through the joint effort of the task force, its media partners and other government agencies, not a single media-related violence was recorded by the Philippine National Police.

"The lack of media-related violence in the May 9 national and local elections is not only a testament to the success of the task force but it is also a first in the history of our elections and something that we should all be proud of," Bueno added.

The NPC urged President-elect Ferdinand Marcos Jr. to consider strengthening the task force further by issuing an executive order converting it into a Presidential commission for media security that will "broaden its power in effectively addressing all concerns related to the country's media sector".

The NPC endorsed **PTFoMS Executive Direc**tor, Undersecretary Joel Sy Egco, as chair of the proposed body.

Egco is also a former NPC president.

"We are confident that Undersecretary Egco would be able to fulfill the new President's instructions and expectations when it comes to the safety and well-being of all members of the

press," Bueno added. Meanwhile, the Pub-

lishers' Association of the Philippines, Inc. (PAPI) also believes that the power of the PTFoMS can be enhanced with the formation of a fullpledged commission.

"We likewise believe that president-elect Ferdinand Marcos Jr. will surely welcome this latest development in the journalism industry into his administration," Nelson Santos, PAPI president, said in another statement.

"PAPI would also like to endorse Undersecretary Egco, given his sterling record and effective leadership that earned the respect and admiration of the media and media organizations here and abroad," Santos said. (PNA)

Comelec ready to hold special polls for Remulla post

The Commission on Elections (Comelec) on Monday said it can hold special polls for the position of Cavite 7th District Rep. Jesus Crispin "Boying" Remulla once he assumes the job as secretary of the Department of Justice (DOJ) in the next administration.

Comelec Commissioner George Garcia said it is up to the House of Representatives to decide if it would appoint a caretaker solon or declare a vacancy and call for a special election.

"We will wait for Congress. If Congress says we will fill up the position to conduct a special election, we will conduct the special election," he said in a press briefing. "But usually, the Congress just appoints a caretaker to handle the concerns of the district."

Remulla, who was reelected to the post in the May 9 elections, reportedly accepted the offer of presumptive president Ferdinand "Bongbong" Marcos Jr. to head the DOJ.

"We call those incompatible offices. You cannot accept one and at the same time accept the other. You have to give up one and accept the other," Garcia said. (PNA)

In 2021, more than 37,000 museums participated in the event.

According to UNESCO, the current estimated total number of museums worldwide is around 104,000. Western Europe and North America have around 61 percent of museums as of March 2021. The United States accounted for nearly one-third of that number and tops the list of the countries ranked by the number of museums.

In the Philippines, the important role of museums is reflected in the work of the National Committee on Museums (NCOM) who reported that there are now 161 museums in the country – 56 in the National Capital Region; 22 in Northern Luzon; 36 in Southern Luzon; 36 in the

That's because millions of young people are missing from public life. With the climate crisis, global conflict and generational inequalities running rampant, the inputs, perspectives and representation of youth are needed more than ever.

Almost half the world's population is under 30. Yet, they make up only 2.6% of parliamentarians around the world. The average age of a world leader is currently 62. Of all the parliaments in the world, 37% do not have a single Member of Parliament (MP) under age 30 and less than 1% of these young MPs are women.

Young people have the right to be included in political decisions that affect them, however, numerous barriers prevent their participation. The Body Shop and the Office of the United Nations Secretary-General's Envoy on Youth are collaborating to change this through the global Be Seen Be Heard campaign to amplify youth voices in public life.

The campaign seeks to create long-term structural changes to decisionmaking to be more inclusive of young people. It was launched last May 11 with the release of a joint report, 'Be Seen Be Heard: Understanding young people's political participation'. The report which includes findings from the largest-ever survey carried out by The Body Shop in December 2021, covering 26 countries with 27,043 respondents in total, over half of which were under age 30.

The research found that 82% of people surveyed agree that political systems need drastic reform to be fit for the future. Across the board, 84% of people described politicians as 'self-interested' and 75% of people surveyed think politicians are corrupt.

The majority, two in three people, also agree that the age balance in politics is wrong, with 8 in 10 people of all ages believing the ideal voting age (the age when someone can first vote) is 16 to 18, despite that in most countries around the world the voting age is 18 or over. A
