

CHR backs DepEd plan for 100% resumption of F2F classes

The Commission on Human Rights (CHR) on Tuesday welcomed the latest pronouncement of the Department of Education (DepEd) to fully open face-to-face (F2F) classes by June.

In a statement, CHR equalizer, has posed to executive director Jacqueline Ann de Guia, said the "right to education is intrinsic to the exercise of other human rights", hence the agency's "staunch support" to DepEd.

"In the third year of the Covid-19 pandemic, the Philippines remains one of 23 countries that have yet to fully reopen schools. Education, supposedly the greatest

further divide and alienthe most marginalized children in our society, placing them at greater risk of exploitation and a lifetime of poverty," de Guia said.

On Tuesday, DepEd Secretary Leonor Briones said the 100 percent reopening of actual classes will depend on the advice of the Department of Health, preparations of local government units,

and consent and participation of parents.

Citing a report from DepEd, de Guia said 73 percent of public schools have returned to face-toface classes.

Private institutions, however, remain wary as only 676 of 16,000 schools have reverted to in-person learning.

Political Dynasties 2022: Revillas now the largest in Cavite CAVITE, Philippines – The Revilla clan headed by Senator Bong Revilla is now officially the biggest dynasty in Cavite, with six family members classed to local positions while two others await if the party lists that

elected to local positions while two others await if the party lists that nominated them would be getting seats in Congress.



Closely following the Revillas in expanding their power base is the Tolentino family, headed by another senator, Francis Tolentino. Five family members have been elected locally.

Meanwhile, one of the most influential political families in the province, the family of reelected Govenor Juanito Victor "Jonvic" Remulla, only had three immediate members who ran and got elected, although a relative who shares the surname clinched a seat in a city council.

Cavite is the second most vote-rich province in the Philippines, with 2,302,353 voters registered for 2022

In the presidential and vice presidential races, Cavite delivered a landslide victory for Ferdinand Marcos Jr. and Sara Duterte, respectively. The tandem, children of Philippine presidents, were endorsed by these three political families: the Remullas, Revillas, and Tolentinos. The tandem won in all 23 towns and cities.

Senator Revilla's wife, Lani Mercado-Revilla, is back as congresswoman of the 2nd District (Bacoor) after serving as the city's mayor.

The couple's son Jolo,

finishing his term as provincial vice governor, will ioin his mother in the House of Representatives as congressman of the 1st District (Kawit, Noveleta, Rosario, Cavite City).

Another son, Ram Revilla, has been elected provincial board member, representing the 2nd District.

Bacoor, which comprises Cavite's 2nd District, is now completely under the family. Senator Revilla's brother Strike is returning as mayor, exchanging his congressional seat with sister-inlaw Lani.

Strike's vice mayor is his older sister, Rowena Bautista-Mendiola, who is wrapping up her third term as city councilor. Rowena started her political career as a councilor in the neighboring city (then still a municipality) of Imus, where their late father, former senator Ramon Revilla, traced his roots.

In Imus, the older Revillas' nephew, Igi Revilla-Ocampo, clinched the last slot in the 12person city council. He is the son of their sister Princess, a former actress.

Bacoor became the second congressional district after it was

carved out of the 1st District in 2010. But just when the Abayas thought the Revillas would leave them alone in what remained of the original district, Jolo ran for congressman in 2022

Because the Abayas had controlled the 1st District for 27 years beginning with their father, Plaridel - the congressional race here became the Revillas' only difficult election in 2022. While the family members who ran in Bacoor got 82.69% (Rowena) to almost 89% (Strike) of the votes in their respective races, Jolo barely made it with 52.32% of the votes in the 1st District in a one-on-one against Paul Abaya, brother of outgoing Representative Francis Gerald Abaya.

Revillas in the party list In the national polls, two more Revilla family members are nominees of different party-list organizations.

Based on the nominations submitted to the Commission on Elections (Comelec) when their groups applied for accreditation, Marlon Bautista, Senator Bong Revilla's older brother, is the third nominee of 1-Pacman, while the senator's oldest son

There are recent reports, however, that Bryan is now the first nominee of Agimat, placing him closer to a congressional seat, should the organization get the required minimum 2% of the votes. We will update this report once the Comelec confirms any

The newly-elected vice mayor of Pasig City, Dodot Jaworski, a former congressman and son of a former senator, is a nephew of the Revillas. His mother is the older half-sister of Senator Bong.

PEZA signs

MOU aims to pursue the establishment of SEZs in potential areas within the jurisdiction of DENR suitable for development as agro-industrial, agro-forestry, mineral processing ecozones, and the ecotourism special economic zones (SEZs) nationwide.

(AO) No. 18, the signed

According to PEZA Chief Plaza, "The MOU will be followed by a Memorandum of Agreement (MOA) for every region where production areas are identified to become or to be converted into different types of economic zones. This is PEZA's way of fully industrializing yet protecting, not destroying, our environment."

Senator Imee Marcos also shared the same sentiment expressing, "Today is a very important MOU between PEZA and DENR. We know that landholdings have been a constitutional question for many decades and now, this is one way of finally bringing foreign investments to the countryside, ideally also to agriculture, timberland, our marine resources, and the mining sector."

It can also be recalled that the Senate recently approved the amendments to investment-related laws to enhance the country's investment competitiveness and contribute to economic recovery. These amended laws are the Foreign Investment Act (FIA), Retail Trade Liberalization Act, and the Public Service Act (PSA).

With the signed MOU, the DENR will provide PEZA with an inventory of potential areas under its jurisdiction that are viable for development into Special Economic Zones. For the requirements, manufacturing/mineral

processing ecozones require a minimum of 25 hectares of land area while a minimum of 5 hectares are required for agro-industrial, agro-forestry, and eco-tourism ecozones.

Meanwhile, PEZA will lead the conduct of site assessment of potential areas identified by DENR, with the provision of the corresponding budgetary requirement. PEZA will also present and submit to DENR the proposed management and development plans for each potential area to become a SEZ.

CARAGA as pilot area

PEZA and DENR, under the MOU, identified the CARAGA region as the pilot area.

DENR Secretary Sampulna expressed, "We have jointly decided [with PEZA] to pursue the immediate development of proposals for the CARAGA region because of its greatest potential to contribute to the economic development as it is the timber and mining capital of the Philippines."

Further, DENR Assistant Secretary Michelle Angelica D. Go said, "We are already in the advanced stage of identifying the potential ecozone areas in CARAGA there are seven (areas) and we are hoping to forge a MOA with PEZA before June 30, 2022."

On sustainable development

Through sciencebased strategies, DENR Secretary Sampulna mentioned, "The critical role of the environment and natural resources in the sustainable development of our country and its significant contributions to our economy cannot be overstated."

"The DENR will not compromise in ensuring that the ecological integrity of the environment is preserved and sustaining biodiversity and ecosystem services," Sampulna added.

Seconded by PEZA Chief Plaza, she said, "Our MOU Signing today and the soon-to-be MOA is also in adherence to our Transformation Road Map (TRM) where we will create environmentfriendly, green, sustainand smart able, ecozones and townships where our investor locators can work, live, learn, and play."

Meanwhile, Senator Imee Marcos expressed, "Sustainable development will have to be part and parcel of every effort. Certainly, the 'build-buildbuild' [project] in the next administration needs to become a 2.0 iteration. It must expand to green, social, health, and school infrastructure that is wired and ready for remote learning."

Marcos also shared, "It is finally time to facilitate the use of land as a true asset in the improvement of the entire rural community. As the fifth most mineralized country in the world and with the lifting of the mining ban in our country, PEZA should also continue to look at the possibility of establishing mineral processing zones.

The Economic Affairs chairperson and senator believes that the PEZA-DENR MOU signing is also an Environment Social Governance (ESG) investment.

She stated, "This MOU is ESG indeed and I am certain that all of us will go towards this direction as we are certain that the next administration will [too]. New economic management team has tough tasks ahead

he warm reception by the business community that greeted the announcement of the members of the economic management team of President-elect Ferdinand R. Marcos, Jr. provides an auspicious sign. Public confidence in a new administration is a key element in attaining what is deemed its primary objective: to bring about economic recovery and restore the country's growth trajectory that went into tailspin due to the pandemic

With barely a month left, the outgoing economic team of President Rodrigo R. Duterte has prepared a fiscal consolidation and resource management plan aimed at raising the level of revenue generation while easing the country's debt burden. Massive borrowings have pushed the country's debt to gross domestic product (GDP) ratio to 63.5 percent, the highest since 2005 and at a level that has exceeded the 60 percent benchmark set by credit rating agencies for emerging economies like the Philippines. The Department of Finance has proposed the imposition of new and higher taxes and a three-year deferral of income tax reductions.

Bangko Sentral ng Pilipinas Governor Benjamin E. Diokno, who has also served previously as Budget Secretary in the Estrada and Duterte administrations, has been tapped to serve as Finance Secretary, generally regarded as primus inter pares, or the informal head of the economic management team. His past well-rounded experience prepares him well for the delicate task of implementing fiscal and monetary policy programs that would enhance the prospects for economic growth.

Former National Economic and Development Authority (NEDA) Director General and Socioeconomic Planning Secretary Arsenio M. Balisacan has been nominated to the position that he occupied during the administration of President Benigno S. Aquino III. He was also appointed as the first chairman of the Philippine Competition Commission, an independent quasi-judicial body created in 2015 to promote and protect market competition. As NEDA chief, he spearheaded the craft-

As DBM secretary, she would be the pivot person of the DBCC.

face-to-face learning while maintaining strict adherence to Covid-19 health and safety protocols," de Guia said.

De Guia also recognized the DepEd's "exploration of the effectiveness of blended learning setup" to address the parents' hesitancy of having their children participate in in-person classes.

She added that ensuring every Filipino child's right to education grants them an opportunity to better their lives.

It also bridges economic and social gaps, such as productivity, gender inequality, and health care accessibility, that hamper our nation-building, she added.

De Guia called on incoming government offi-

cials "to make accessible and quality education a priority investment".

"May the glaring inequalities among literacy and proficiency among our youth that the pandemic has underlined be urgently acted on, with the education sector at the very helm," she added. **(PNA)**

the safe installation of electrical equipment and wiring that also covers basic materials quality and electrical work standards for the safe use of electricity for light, heat, power, communications, signaling, and other pur-

Engr. Mendiola, defined an electrical hazard as a dangerous condition such that contact or equipment failure can result in electric shock, arc-flash burn, thermal burn, or blast. He showed some examples of electrical hazards that can be seen in a workplace. He also played video clips showing the results of electrical hazards in the blasts, explosions, electrocution, fires, loss of property, and even loss of lives.

Likewise, Engr. Bandao tackled the importance of observing all electrical safety requirements and practices. He enumerated some good practices in attaining an electrically safe working place such as taking electrical risk assessment, training safety workers, and good electrical safety manage-

He ended his presentation with the Hierarchy of Health and Safety Controls based on effective-

Lastly, Engr. Abanto presented the response

trical accident. Wherein he tackled the importance of having a safe and compliant electrical system. He also gave the different Personal Protective Equipment depending on the exposure in electrical works. He also gave the importance of having a qualified person to handle the electrical system and electrical equipment in the workplace. He taught the contact release training wherein he gave the procedures on how to respond in an emergency such as an electrical haz-

The technical speakers challenged the participants to exert further efforts in providing familiarization amongst their respective company personnel regarding the loelectricity including outlets, circuit breakers, fuse box, and general/main switch. They likewise reminded the participants to be electrically safe not only in the workplace but also at home.

Electricity is a very serious hazard in every workplace and can cause significant injuries, loss of property, and even death. Electrical hazards are not something that everyone is aware of and knowledgeable about that's why it is imperative to have a basic electrical safety training like this at the minimum so that our beneficiaries develop an awareness of the importance of electrical safety and avoid potential electrical hazards in working place. PHO commemorates the Philippine International AIDS Candlelight Memorial 2022 In partnership with HIV & AIDS Support House (HASH) and SAIL Clinical Cavita Provincial Health Office inited in the appual celebration of

ics, Cavite Provincial Health Office joined in the annual celebration of Philippine International AIDS Candlelight Memorial with the theme "Keeping the light, honoring our rights, radiating pride" on May 27, 2022 at the Cavite Collaboration Center for Public Health Building in Trece Martires City, Cavite which was attended by 52 participants.



The short program started with an opening message from Dr. Nelson Soriano saying that people should stop HIV together through HIV testing and prevention and educate others about it to make a positive change. Afterwards, Mr. Earl Patrick Penabella , SAIL Clinic Operations Manager, imparted that in keeping the light on HIV and AIDS, the need to talk about the virus should be maintained. He added that there should be human rights-based approach to create an enabling environment that will be helpful and essential in ending HIV threat. Lastly, in radiating pride, a healthy equity and social justice should be achieved to end the disease.

The risk and cases of HIV and AIDS are continuously increasing and the stigma and discrimination to the infected ones are continuously circulating. Human Immunodeficiency Virus is an infection that has no cure and can lead to the condition of AIDS or acquired immunodeficiency syndrome. Acquiring this can be a threat to one's life hence spreading awareness about the virus can save lives.

As HIV affects proportion of LGBTQIA community, stigma and discrimination are developing and growing which leads to the vulnerability of the group. This is one of the reasons why most of the infected individuals, not just from LGBTQIA community, are having a hard time seeking help and accessing services for HIV and AIDS. Mr. Penabella mentioned "undetectable equals untransmittable" which means that if a person living with HIV is on a regular treatment and therapy and has reached the undetectable levels, HIV cannot be transmitted to their partners. Therefore, every HIV patient should be encouraged and supported in getting HIV treatments, care, and services.

This year's theme is not only about remembering the people who have lost their battle against HIV and AIDS but also honoring those who committed their lives to help the people affected by the disease and giving awareness to the public about it to create an intricate response and have a non-discriminatory environment.

Dr. Ana Maureen Villamar, HIV/AIDS Core Team (HACT) Physician said, "Aside from commemorating our loved ones, friend or someone who are acquainted to us who died because of HIV

and AIDS, the ones who are survivors should also keep the light and guide other Filipinos that they would be able to survive AIDS and HIV as well. We should honor our rights because it is our right to live healthy and always radiate with pride, that we are always proud of ourselves, we keep our values and practice our responsibility as citizens and HIV advocates and enlighten everybody with the disease".

Mr. Terrenze Angam, Case Manager of SAIL Clinic, pointed out the preventions and treatments for HIV and AIDS including abstinence or no sexual intercourse, being faithful to your partner, using condoms, drug avoidance, having enough knowledge about the disease, and the preexposure prophylaxis. Subsequently, a testimony of a HIV survivor and advocate was shared.

Thereafter, Mr. Gerry Obibe and Ms. Tracy Suarez led the prayer for candle lighting ceremony with a red ribbon that symbolizes the battle against HIV and AIDS.

In closing, HIV Program Coordinator Haydelisa Maderaso expressed gratitude to the attendees and mentioned the upcoming World AIDS day to be held on December 2022. (PICAD)
