## Wheels start to turn at the Department of Migrant Workers

Mama-o as the new secretary of the newly created Department of Migrant Workers (DMW). A law practitioner, labor lawyer, and assemblyman, Mama-o was, most recently, the presidential adviser on overseas Filipino worker (OFW) concerns.

This appointment comes at a crucial time as OFWs face different challenges in different parts of the world, such as those who are infected with Covid in Hong Kong or those in the middle of conflict in Ukraine.

Various groups lauded the appointment of Mama-o, who noted his extensive experience and qualifications in the labor and diplomatic negotiations. In an online testimonial, groups cited Mama-o's role as a prime mover of Republic Act 11641, an act creating the DMW, which will now gather all government agencies dealing with OFWs under one department, with the intent of simplifying the process of aiding and issuing documents for migrant workers.

'Mamao's diplomatic skills were proven effective and successful, many times, after the President dispatched him to the Middle East and Gulf Cooperation Council (GCC) countries to appease and heal strained relations caused by diplomatic squabbles. His prowess on diplomatic negotiations paved the way for the release of OFWs abducted by armed men and the lifting of the ban for deployment of household workers to Kuwait as a result of the killing of OFW Joanna Demafiles, a Filipina domestic worker in Kuwait." The statement added that Mama-o's expertise on Sharia Laws and Islamic Diplomacy contributed to the advancement of safety of OFWs in the Middle East.

The DMW, based on its mandate, would now absorb the functions of various agencies such as the Philippine Overseas Employment Administration, the Office of the Undersecretary for Migrant Workers' Affairs under the DFA, DOLE's three offices: Philippine Overseas Labor Office, International Labor Affairs Bureau, and National Maritime Polytechnic; and

the Office of the Social Welfare Attaché under the DSWD. The OWWA, on the other hand, will continue to function but shall be attached to the DMW for policy and program coordination.

Creating a dedicated department for OFWs is one of the campaign promises of the thencandidate Duterte.

Assuming the presidency, Duterte repeatedly stressed the importance of a singular department for migrant workers so they don't have to hop from one agency to another just to have their papers signed or to submit requirements.

Aside from being the lead agency for implementing policies, plans, and programs that will ensure the protection, promotion of interests, resolution of problems, and effective reintegration of migrant workers, the DMW will also regulate private recruitment agencies.

The DMW is expected not only to serve the

more than two million OFWs but also look into the concerns of their families and relatives here in the Philippines. For so long, OFWs have been considered as modern-day heroes and "backbone" of our economy in times of crises, so it is only proper and fitting to have a dedicated department just for them.

dedicated department just for them. With an experienced and dedicated secretary at the helm of DMW, Mama-o intends to carry out the Duterte administration's promise to prioritize the safety, security, and welfare of OFWs.

Yes, there are big expectations ahead and promises to be fulfilled. Therefore, the first few steps of the new secretary are crucial as any decisions will impact our OFWs who are facing a world that is challenging with geopolitics, changing with technology, and emerging from a pandemic.

exercises with the local government and Cavite officials of the Department of Education for the limited F2F classes as part of the ongoing transition to "new normal" education.

Estalilla said two elementary schools, Juliano Brosas Elementary School in Barangay Pasong Kawayan 1 and Pasong Kawayan 2 Elementary School, already started implementing in-person classes on March 7, 2022 as pilot implementation.

Other public elementary and high schools are set to open soon pending compliance with the School Safety Assessment Tool and simulation to ensure a smooth resumption of fin-person classes from kindergarten to Grade 6 and Grades 7 to 12.

Estalilla said the students are those who will be permitted by their parents to attend the on-campus classes or those who will sign a waiver while others will continue with blended learning via online classes.

Students are only allowed to stay in their respective schools for a maximum of 4.5 hours daily.

Estalilla said there are designated areas in school premises where

parents and guardians will be allowed to wait for the dismissal of their children from classes to be able to bring them home immediately to prevent the learners from loitering in the schools.

Schools have been mandated to put up directional signs to serve as guides for students and teachers in going to and out of their classrooms and the school compound to ensure that there will only be a single entrance and a single exit for the orderly movement of people.

Every class will have only 15 students as per Inter-Agency Task Force for the Management of Emerging Infectious Diseases ruling on safety guidelines against Covid-19.

For more innovative and safe entry and return of students participating in limited in-person classes, the schools will use the quick response (QR) code system of Gov. Luis Ferrer Jr. East National High School in General Trias to get in touch with the parents and guardians.

Through the school's QR code system, the parents and guardians are updated via text message on their children's entry and exit from school.

COME NOW, plaintiffs through counsel and unto this

## Honorable Court most respectfully states and alleges that: THE PARTIES

(1) Plaintiffs are the heirs of Canuto Pangilinan herein represented by their duly authorized representative and one of the heirs Domer A. Pangilinan, Filipino citizen, of legal age and a resident of Brgy. Pangil, Amadeo, Cavite. For purposes of this complaint, pleadings, notice and other court process may be served at the address of their counsel at 3D-14 GSIS Metrohomes Bldg., Sta. Mesa, Manila

Copy of the Special Power of Attorney is hereto attached as Annex "A".

(2) Respondent Teem Multiventures Corporation is a corporation existing under the laws of the Republic of the Philippines represented by John Steven Sy and Nenita Sy with office address Suite 1025 Pioneer Highlands Condominium, East Tower, Pioneer St., Mandaluyong City where copy of the complaint, summons, notice and other court processes may be served.

(3) Respondents John Steven Sy and Nenita Sy are Filipino citizens, both of legal ages and with office address at Suite 1025 Pioneer Highlands Condominium East Tower, Pioneer St., Mandaluyong City where copy of the complaint, summons, notice and other court processes may be served.

(4) Respondent Registry of Deeds for the City of Trece Martires is a public office located at City Hall of Trece Martires City where copy of copy of complaint, notice and other court processes may be served and is impleaded as formal party for being the custodian of the transfer certificates of title of properties located in the said city, the transfer certificate of title subject matter of this case.

### FACTS AND CAUSES OF ACTION

(5) Canuto Pangilinan (herein after referred to as Canuto) was the owner of a parcel of land located at Barangay Conchu, Trece Martires City covered by Transfer Certificate of Title No. T-3387 and Tax Declaration No. 202-A with an area of sixty six thousand five hundred eighty two square meters (66,582 sq. m).

(6) On June 4, 1994, Canuto entered in a *Kasunduan* with Imarflex Battery Manufacturing Corporation (herein after referred to as Imarflex) represented by Mr. Henry Ng. The said Kasunduan is in the nature of a deed of conditional sale setting forth several conditions, fulfillment of which could have reached the consummation of an absolute deed of sale.

Copy of the Kasunduan is hereto attached as Annex "B".

(7) Despite the fulfillment of the conditions in the *Kasunduan* and the transfer of the title under the name of Imarflex and its sister company the sale did not push through. Imarflex suddenly changed its mind into acquiring the property leaving Canuto and plaintiffs in limbo. Plaintiffs are the owner and in possession of the property but registered under the name of another.

(8) As far as they know the property subject matter of their transaction with Imarflex are covered by five transfer certificates of title under the name of Imarflex and its sister company, Weilong Electrical Industrial Corporation, to wit: TCT No. T-48508; TCT No. T-48505; TCT No. T-48502 (Weilong); TCT No. T-48501; and TCT No. T-48500.

Copies of TCT No. T-48500; TCT No. T-48501; TCT No. T-48502; TCT No. T-48505; and TCT No. T-48508 are hereto attached as Annexes "C" to "G".

(9) It was very unfortunate that Canuto did not enjoy the supposed proceeds of the sale of his property because of his untimely death on May 4, 1997. Nevertheless, Imarflex through series of meetings with the plaintiffs and their counsel amicably settled their issues and agreed that they are willing to cooperate and execute the necessary documents if ever the property would be sold.

(10) Nobody wants to buy the property of the Pangilinans because of its situation. In 2012 Domer Pangilinan went to the Registry of Deeds of the City of Trece Martires City to get certified copies of the certificates of title of their property but he was informed that there is a pending transaction or transfer of registration under the name of a certain company.

(11) The deed was executed allegedly for the sale of properties covered by TCT No. 48500 with an area of Thirty Three Thousand Two Hundred Eighty Nine square meters (33,289 sq. m.) and TCT No. 48505 with an area of Two Thousand One Hundred Forty Two square meters (2,142 sq. m.). This came as a surprise to the plaintiffs because they already had an understanding with Imarflex as early as 2010 about these properties and upon inquiry with Imarflex, they firmly deny transacting with The Teem Multiventures and confirmed that they honor their agreement with the plaintiffs.

(12) Not knowing what to do plaintiffs referred the matter to their counsel who conducted an investigation on what really happened. They investigate led the plaintiffs to a Transfer Certificate of Title No. T-84883 under the name of defendant The Teem Group Multiventures Corporation and the corresponding tax declaration also under its name.

Copy of the Transfer Certificate of Title No. T-84883 is hereto attached as Annex "H" and Tax Declaration No. 004-01-0466-1 is hereto attached as Annex "I".

(13) More importantly, plaintiffs were able to secure a copy of a Notice of Denial date August 9, 2012 addressed to Mr. Antonio Tamaca of Malayan Bank Savings and Mortgage Bank from the Registry of Deeds for Trece Martires City. It was the denial to register the Certificate of Sale (Extra-Judicial Foreclosure of Mortgage-Voluntary) involving the title in the name of Teem Multiventures.

Copy of the Notice of Denial is here to attached as Annex "J".

(14) The notice shed light on the real status of the titles. Apparently, the property has two sets of titles, one set (TCT No. 48500 and TCT No. 48505) in the name of Imarflex and one in the name of Teem Multiventures (TCT No. T-84883). The registrar of deeds refused to register the Certificate of Sale which rooted from the title of Teem Multiventures and correctly pointed out that a judicial determination of which two titles must be respected was necessary before his office could act upon the request for registration.

(15) The plaintiffs are of the firm belief that the Teem Multiventures title is spurious backed by the result of the investigation of the registry of deeds, to wit:

"(2) Results from the investigation that the undersigned conducted on the matter reveals that TEEM's title appears to have been generated sans the submission of certain essential requisites for a valid registration of transfer transaction. For one, the requisite national taxes (capital gains and documentary stamp taxes) due on the transfer transaction that purportedly led to the issuance of TEEM's title do not seem to have been settled at the time of the entry of the said transaction or after the alleged registration thereof is gross violation of the pertinent provisions of the National Internal Revenue Code, as amended (NIRC). The absence of the corresponding Certificate Authorizing Registration (CAR) is statement to this allegation. For another, it also appears that the local tax (transfer tax free) due thereon may not have been duly settled at the time of the entry or even after the alleged registration of said transfer transaction, again in gross violation of the provisions of the Local Government Code. The absence of any proof of payment such as receipts and the like from local government unit concerned seems to validate siad violation. To top it all, even the real estate taxes due on the subject property may not have been paid at the time of the alleged registration of the said transfer transaction in view of the absence of the requisite Tax Clearance or equivalent thereof from local government unit concerned."

(16) Plaintiffs need not say more as the results of the investigation on the matter is very clear. Teem Multiventures' title is fake as the same was obtained in violation of laws, through fraud and through whatever illegal means defendants Teem Multiventures, John Sy and Nenita Sy perpetrated to the damage and prejudice of plaintiffs.

(17) Obviously, defendants used the title to secure a loan from Malayan Bank. Because they do not care about the property at all, they did not bother to pay the loan or redeem the property and just let the bank foreclose it.

(18) It is already painful that the plaintiffs cannot use their property or dispose the same whenever they want because it is registered under the name of Imarflex but to learn that defendants already made money out of their property, when they are left with nothing but bare promises, is more painful but it took them years to assert their rights because of lack of money and means to do the such.

(19) A transfer certificate of title secured through fraud and illegal means should therefore be cancelled.

(20) Due to the foregoing acts of the defendants, the plaintiffs suffered moral damages in the form of mental anguish, mental torture, moral shock, social humiliation and besmirched reputation, for which the plaintiff should be held liable to the defendant in the sum of P200,000.00.

(21) To serve as an example and to deter commission of similar acts, exemplary damages in the amount to be fixed by the Court.

(22) To protect their rights and interests in this case, defendants were forced to engage the services of their undersigned counsel for a fee of P100,000.00 and P4,000.00 per appearance on which the defendants should be made liable.



WHEREFORE, it is respectfully prayed of this Honorable Court that, after due proceedings, judgment be rendered for the plaintiffs -

a. Canceling TCT No. T-84883 under the name of The Teem Group Multiventures Corporation.

b. Ordering defendant Registry of Deeds for Trece Martires City to make the necessary cancellation of above stated title.

c. Ordering defendants The Teem Group Multiventures Corporation, John Steven Sy and Nenita Sy to pay the plaintiffs.

Moral damages in an amount not less than P200,000.00;
 Exemplary damages in such amount as may be fixed by

the Court; and 3. Attorney's fees of P100,000.00, in addition to

## ORDER

The present case is an unloaded case from the Regional Trial Court of Trece Martires, Branch 23 and submitted for this Court's resolution is the EX-PARTE MOTION WITH -LEAVE OF COURT TO EFFECT SERVICE OF SUMMONS THROUGH PUBLICATION dated November 24, 2015, filed by the plaintiffs, through counsel.

In the motion the plaintiffs-movants prayed that the service of summons be effected through publication since the complaint was returned unserved because the defendants no longer hold its office in the last known address, and their whereabouts are unknown despite diligent efforts to locate them.

Section 16, Rule 14 of the Rules of Civil Procedure clearly states that:

Section 16. Service upon defendant whose identity or whereabouts are unknown. - In any action where the defendant is designated as an unknown owner, or the like, or whenever his or her whereabouts are unknown and cannot be ascertained by diligent inquiry, within ninety (90) calendar days from the commencement of the action, service may by leave of court, be effected upon him or her by publication in a newspaper of general circulation and in such places and for such time as the court may order.

Any order granting such leave shall specify a reasonable time, which shall not be less than sixty (60) calendar days after notice, within which the defendant must answer. (14)




