7 dead, 1 missing in Dasmariñas, Cavite bridge collapse

Seven people have died while one is still missing after a suspended steel bridge collapsed in Dasmariñas City, Cavite on Tuesday night, July 26.

According to a report on State of the Nation, the old bridge in Sitio Talisayan, Barangay Sampaloc IV collapsed a few minutes after 9 p.m. Dasmariñas City

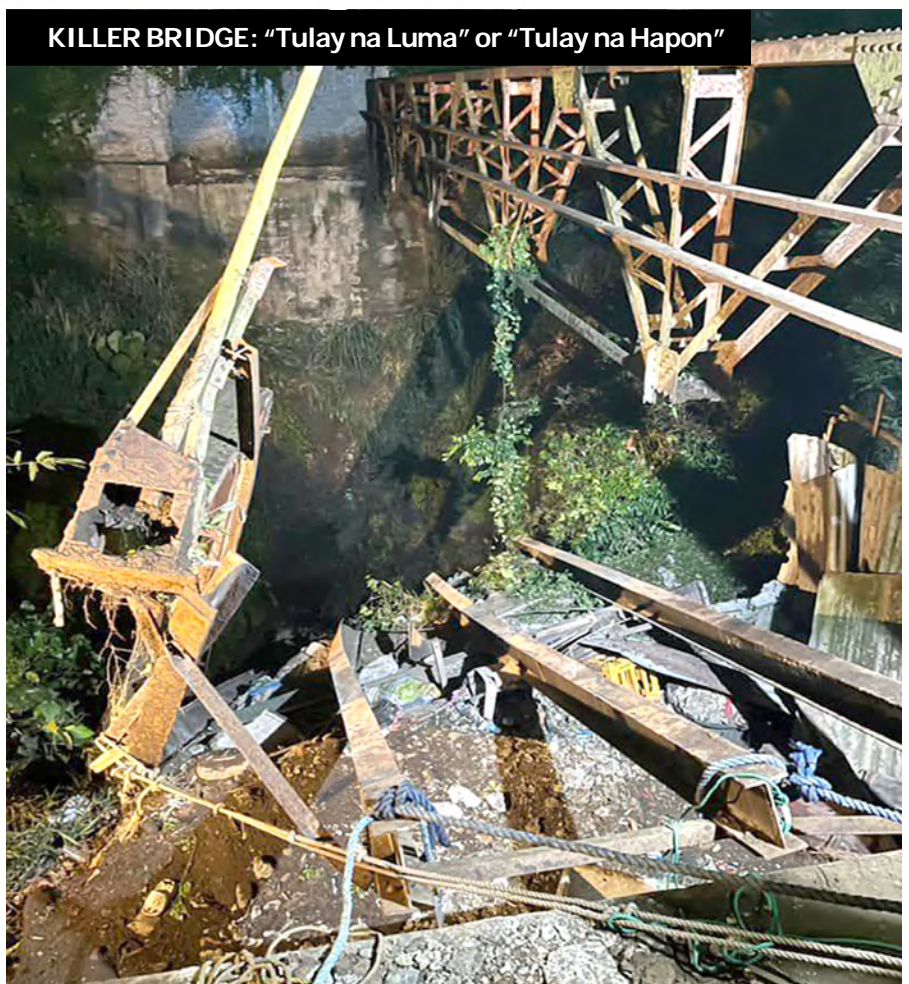
Mayor Jennifer Barzaga said 13 youngsters were on the bridge at the time of the incident. Five of them survived.

Bargaza said the bridge has long been

The House of Representatives has adopted House Resolution 100, calling on the Commission on Elections to hold Special Elections for the 7th District of Cavite.



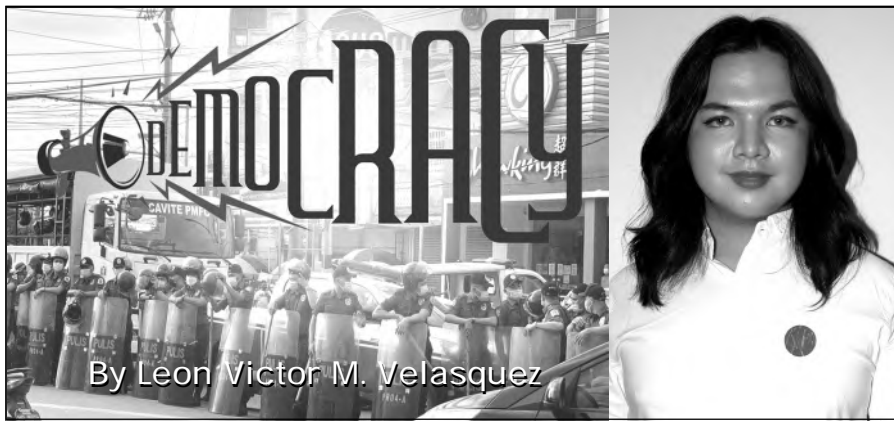
DOJ Secretary Jesus Crispin "Boying" Remulla

The position for Representative of Cavite's 7th Dist. has been left vacant after Jesus Crispin "Boying" Remulla took the Department of Justice portfolio under the Marcos Jr. administration.

Section 9, Article 6 of the 1987 Constitution states that in case of vacancy in the Senate or in the House of Representatives, a special election may be called to fill such vacancy in the manner prescribed by law, but the Senator or Member of the House of Representatives thus elected shall serve only for the unexpired term.

The House previously designated Speaker Martin Romualdez as caretaker of Remulla's district.

BRAINWASHED BY DISTORTION: THIS IS NOT NEW

This has been going on for years, and in other presidential terms, to how the state continuously attacks peaceful ceremonies and school persecutions around the country.



As President Marcos would typically say, "event" about the Ateneo shooting incident, graduation rites have shifted its rejoicing ambiance into grieving after killing three victims in broad daylight.

It has come to my senses that we are in a different era already---that even history the Philippine holds lets its nation pass as something that is a "gossip" and tolerates vulgar and direct historical distortion within the screens of their home.

The case of the Ateneo shooting, loyalists have upheld the gunman online, even praying for his recovery and well-being for getting his job done and for his "safety," as if he's a saint who needs to be patronized for what and how barbaric he did in the vicinity of a university; and was a mere victim in it all, that his acts are justified due to the sheer alleged political injustices he has suffered.

Something is terribly wrong. Filipino's moral compass completely changed in perceiving what is right and wrong--what is humane or inhumane--reflecting the values of how they always attend sanctified mass was just all a "fa-cade." The clean-up to Yumol's image shouldn't tolerated nor neglected. This is an event where we should remember as state of the nation address and shooting took place on the same date; a time where we, all, should be getting into our senses that we are blinded and brainwashed by distortion.

It has opened up a new avenue for victims to seek the justice they deserve, in spite of the fact that even their rotten justice system would not provide it in a systematic and democratically instantaneous manner. Perhaps, on the psychological spectrum, being fed up with whom we idolize shifts our world view of rights into something invisible wrongs, and we become completely blinded by it. It's sad to see how a democratic country elected a leader with no concrete platform for his country, a history of anomalies and issues, and a questionable family background and credentials.

This is not new. The Ateneo shootings are a complete witness to what is the true State of the Nation.

"And it's this world that turns a killer into a hero. Well, I blame this world for making a good man, bad," in one of Jon Bon Jovi's track line, Santa Fe, said.

We remember, impunity still reigns from the government who promotes injustices and encapsulates killings.

Editorial

President's first SONA focuses on roadmap for recovery, agenda for next six years

President Ferdinand R. Marcos, Jr. presented a roadmap for recovery from the pandemic's crippling effects and highlights of his governance agenda in his first State of the Nation Address (SONA). He also asked Congress to enact into law 19 bills that reflect his administration's priorities.

Sound fiscal management shall address the pandemic's "economic scarring" effects and "also to prepare future shocks."

Investments will be promoted through the incentives offered by the CREATE Law, the new Public Service Act and updated Foreign Investments Act. These will be directed toward ecozones – especially those outside Metro Manila – in which "strategic industries" like health and medical care, high-tech manufacturing and emerging technologies will be promoted.

Congressional concurrence is also being sought for the Medium-Term Fiscal Strategy that seeks to attain the following "headline goals:" real GDP growth of 6.5 to 7.5 percent in 2022 and 6.5 to 8 percent from 2023 to 2028; nine percent or single-digit poverty rate by 2028; three percent national government deficit to GDP ratio by 2028; less than 60 percent government debt to GDP ratio by 2025; and income per capita of at least \$4,256 by 2024, thereby raising the country to upper middle-income status.

Speaking in Filipino, President Marcos then emphasized the urgency of ensuring abundant food supply at reasonable prices. Government shall purchase farm inputs at bulk rates and provide farmers with financial and technical assistance, while fortifying value chains from farmers to consumers. Kadiwa centers offering reasonably priced food products will be revived.

His announcement on "no more lockdowns" drew loud applause as did his reiteration of government policy on the resumption of face-to-face classes from grade school to college. Vaccine rollout and booster programs shall be pursued vigorously. Health care facilities



shall be upgraded.

Specialty treatment centers for heart, kidney, lung and other diseases shall be established in other regions outside of Metro Manila, while rural health units will be deployed to enhance primary health care in the countryside. A Center for Disease Control Prevention and Vaccine Institute shall be established. Cheaper drug availability shall be ensured. Cartel-like practices of pharmaceutical companies will be probed and deterred.

Quality of education shall be a major focus; emphasis on Science, Technology, Engineering and Mathematics (STEM) strand shall improve the competitiveness of Filipino youth. English proficiency shall be enhanced further as this is the strength of Filipinos in overseas job mar-

kets. The new Department of Migrant Workers shall ensure equitable and humane treatment of Filipinos employed abroad.

Internet connectivity shall enable digital transformation across all industries. Infrastructure development shall be pursued through a Build Better More program that includes upgrading of world-class railway, maritime and air transportation facilities.

President Marcos vowed that he "will not preside over any process that will abandon even one square inch of territory of the Republic of the Philippines to any foreign power."

He ended on a note of optimism, declaring emphatically: "We will endure. Let our Filipino spirit remain forever undimmed...The state of the nation is sound."

Tips Sa Baradong Ilong at May Sipon

Nakakainis ang may baradong ilong. Hirap kang huminga at matulog. Tumutulo ang iyong sipon at nagbabago ang iyong boses. Ang kadahilanan ng baradong ilong ay ang pamamaga ng ugat sa iyong sinuses (sa loob ng ilong). Naiirita ang mga ugat dahil sa mikrobyo o allergy.

2. Maligo sa shower gamit ang mainit na tubig. Isara ang pinto sa banyo para makulob ang usok na manggagaling sa mainit na shower (parang sauna). Ang steam o usok ay may water vapor na nagpapalabnaw ng plema.

3. Subukan ang Steam Inhalation. Magpakulo ng 2 litrong tubig (8 baso) sa isang kaldero. Kapag kumulo na, palamigin ng 10 minuto at isalin ang tubig sa isang plastic na palanggana. Ilapit ang iyong mukha ng 6 inches sa mainit na tubig. Itaklob ang tuwalya sa ulo habang nakatapat sa palanggana. Ito'y para makulob ang init at malanghap mo ang usok na nanggagaling sa tubig. Puwede kang mag-steam inhalation ng 3 o 4 beses sa maghapon.

4. May tulong ang Saline Spray na nabibili sa botika (mga P100 ang halaga). Isa itong botelya na ipinapasok sa ilong at ini-spray. Sa ganitong paraan, mapapalabnaw at matutunaw ang plema sa ilong.

5. Gumamit ng warm compress. Ilubog ang tuwalya sa mainit na tubig at pigain ito. Ilagay ang mainit na tuwalya sa bandang ilong at noo. Ang warm compress ay nakababawas ng kirot at pamamaga ng sinus.

6. May mga nabibiling gamot para sa sipon (decongestants) pero hindi ito puwede inumin ng pang-

matagalan. Minsan, nakaka-apekto din itong mga gamot sa iyong blood pressure.

7. Kung may allergy, umiwas sa mga bagay na nakaka-allergy sa iyo. Linisin ang kuwarto at linisin ang mga gamit, kama, sofa at rug. Labhan maigi ang unan, kumot, tuwalya at baro. Ang mga balahibo mula sa alagang hayop at stuffed toys ay nakaka-allergy din. Kung matindi ang allergy, puwede din uminom ng gamot sa allergy ng paminsan-minsan.

ECM Farmers harvesting the nuts of their labor soon

Regional Director Emelita P. Bagsit of DOST-CALABARZON, Dr. Alexander R. Madrigal, former DOST-CALABARZON Regional Director, Ms. Vermelyn Evangelista, Technical Supervisor of Philippine Coconut Research and Development Foundation Inc. (PCRDF), and Mr. Crispin Muyrong, President of Sunlight Foods Inc., a private company in the business of fruit processing advocating on the sustainability of their partner farms, visited the Embryo Cultured Makapuno Farms in Quezon to monitor the growth of trees, inspect the farm site, and discuss the evaluation and potential business opportunities with Sunlight Foods Inc. The monitoring was organized by Mr. Aaron Joniel Carandang, DOST-CALABARZON Project Assistant III, project focal person, in cooperation with Ms. Mylene Culing, OIC-Municipal Agriculture Officer, Mr. Cleverick Pajarillo, Philippine Coconut Authority (PCA) Officer with the participation of Ms. Victoria Gonzalez, DTI-Negosyo Center Alabat Officer.



About four years ago, DOST-CALABARZON in collaboration with PCRDF, PCA, Department of Agriculture (DA), and Southern Luzon State University (SLSU) screened local farms through their respective Local Government Units (LGUs) to come up with a roster of qualified beneficiaries to participate in the Embryo Cultured Makapuno Project. A total of 5,700 seedlings were staggeringly distributed through the years in the towns of Alabat, Perez, and Quezon, Quezon. 5,400 seedlings were yet to be awarded to chosen farms on the island this 2022.

This marks the last leg of the seedling distribu-

tion to meet the targeted 11,100 makapuno seedlings covering 111 hectares of the island. The group was also able to meet with Hon. Fernando Mesa, outgoing Municipal Mayor of Alabat and Hon. Caridad Clacio, outgoing Municipal Mayor of Quezon to express the agency's gratitude for their invaluable efforts in the deliverance of the project. Likewise, both pledged continued support for the project and its advocacy of leveraging the lives of their kababayan farmers as private individuals.

Mr. Joel Arandela, farmer and farm owner was distinctively recognized as the "Best Makapuno Farmer" by the monitoring team. His

Makapuno Farm in Alabat was the first one to be awarded seedlings.

To date, his farm has a 95.1% seedling survival rate with the now Makapuno Trees having a 100% flowering rate and 70% of which are already bearing fruits. Mr. Joel's trees met the standard 10-15 nuts per cluster or "kabuwig".

Considering the lead time other farms had, the Second Best Makapuno Farmer is Mr. Nelson Omila, caretaker of Hon. Clacio's farm in Quezon. The seedlings under his care have a 96.3% survival rate with four trees showing flowering while entering their year four. Hon. Clacio's farm is among the promising ones upon visit together

with Mr. Maximo Hebrado Jr.'s farm also in Quezon cared for by Mr. Jovelito Basbas with a 96.9% seedling survival rate.

Tissue-cultured makapuno embryos are subjected to a firmly controlled environment to decrease the chance of plant contamination and mortality rate.

The government sector rallies alongside this cause to introduce farmers to this technology and encourage them to increase the hectare of their plantations. This innovative farming mechanism is projected to cause an upward shift in the makapuno industry and the economic disposition of our farmers. **(By: Cesaree M. Caperare)**
