

President Duterte declares March 22 as "Cavite Day"

President Rodrigo Duterte approved the declaration of March 22,2022 as a special non-working holiday in celebration "Cavite Day."

The date also marks the 153th birth anniversary of the first Philippine president, General Emilio Aguinaldo.

Caviteños were granted full opportunity

to celebrate the occasion and participate in the activities, subject to public health precautions placed by the national government amid the Covid-19 pandemic It was executive secretary Salvador Medialdea, by authority of President Duterte, who declared the holiday. Escudero urges gov't: Reconsider on-site work for BPO workers



The national government should reconsider its order for employees of business process outsourcing (BPO) centers to return to their offices by April 1, senatorial candidate Francis Escudero said Thursday.

Escudero said that aside from the threat brought by COVID-19, the continued increase in fuel prices should also be considered as this would also result in the higher prices of goods.

Historical markers honor Malolos Cathedral

Two government cultural agencies have installed historical markers honoring the history of the Immaculate Conception Parish-Cathedral and Minor Basilica in Malolos City.

A dedication ceremony was held in front of the historic church on Monday with some officials of the National Historical Commission of the Philippines, the Bulacan Provincial History, Arts, Culture and Tourism Office (PHACTO), and the Malolos diocese in atten-

The NHCP marker was unveiled at the belfry in the presence of Bishop Dennis Villarojo, Malolos Cathedral Rector Fr. Alberto D.J. Santiago, and Malolos Church Cultural Heritage chairman Fr. Vicente Lina, Jr.

The Bulacan PHACTO also installed its own marker, citing Malolos Cathedral as an important piece in the history of Malolos City and of the province.

The event was part of

the commemoration of the 60th anniversary of the Diocese of Malolos, which was celebrated on March 11, 2022. Friday's celebration was highlighted with a Mass presided over by Archbishop Charles Brown, Apostolic Nuncio to the Philippines.

Founded in 1580 by the Augustinian friars, the Malolos Cathedral is one of the country's oldest parishes dedicated to the Immaculate Conception.

In 1888, it was this church that became the historic venue for the dialogue between Spanish Governor General Valeriano Weyler and 20 women of Malolos, resulting in the grant given to them to learn Spanish for the first time.

During the First Philippine Republic of 1898-1899,

Malolos served as the first republican capital of the country. The cathedral's convent was also converted as the Presidential Palace for President Emilio Aguinaldo.

In 1962, the church was elevated as the cathedral of Malolos diocese.

On the occasion of the Centennial Year of Philippines Independence (1898-1998), the church was also granted the title of minor basilica. It is one of only two churches in the Philippines that is both a cathedral and a minor basilica besides the Manila Cathedral.

Called by scholars as the "freedom shrine of the Philippines", this historic church is remembered for its remarkable contribution to the history of the Church and of the country.

A resolution issued by the Fiscal Incentives Review Board (FIRB) in September 2021 allowed work-from-home setups for up to 90 percent of workers in BPO firms until March 31, 2022, in consideration of the COVID-19 pandemic.

With the deadline approaching, BPO companies have asked for an extension of the working-fromhome set-up for six more months. However, the FIRB rejected request and even warned BPOs that will not comply that their tax perks will be revoked.

Escudero said Finance Carlos Secretary Dominguez III, who chairs the FIRB, "seems to be out of touch with the realities faced by people on the ground."

He said the reform program seeks to implement permanent changes to the current system being implemented by the government, particularly establishing a comprehensive aid system to help Filipinos during crises.

Cayetano noted that the government still does not have a list of fuel subsidy grantees considering that the transportation sector has always been a recipient of pandemic aid.

Cayetano said he is eyeing reforms to the government processes in distributing aid so that affected sectors -- transportation, hospitals, and quarantine hotels, among others -- would receive it directly and more efficiently.

As for the recovery aspect, Cayetano said economic recovery will be facilitated by programs for micro, small, and medium enterprises (MSMEs) as well as agriculture.

He said the government can give interestfree or low-interest loans to MSMEs and farmers, with the payables depending on the duration and principal amount.

BSP's initiative assures credit source to revitalize MSMEs

icro, small and medium enterprises (MSMEs) account for 99.5 percent of business establishments in the Philippines, employ 63 percent of the workforce, and have been responsible for approximately 40 percent of the country's gross domestic product (GDP). This sector was among the most severely affected by nearly two years of quarantine and lockdown due to the coronavirus pandemic — and its revitalization is pivotal to the objective of increasing the pace of economic recovery.

The Bangko Sentral ng Pilipinas (BSP) has issued the proposed rules to guide banks in allocating a minimum four percent of their loanable funds for innovation development for the benefit of micro, small and medium enterprises (MSMEs) and startups. In the draft circular, the loanable funds for innovation development credit will be computed similar to the calculation of loanable funds for agriculture and agrarian reform credit.

This initiative is also geared toward realizing the goals set forth in Republic Act No. 11293, the Philippine Innovation Act, that was enacted in 2019. Qualified borrowers for innovation development credit are MSMEs, startups, innovation centers and business incubators, as well as other entities that support development of new technologies and innovative goods or services.

In the draft circular, currently being circulated among banks, the BSP acknowledges the key role of innovation in spurring inclusive development, as well as in enhancing the growth and competitiveness of MSMEs: "Innovation encourages creative thinking, which in turn, increases productivity and economic output.

The banking system plays a crucial role in providing credit necessary to support the development of new technologies and other innovation-related activities."

The BSP defines innovation as "the creation of new ideas that results in the development of new or improved products, processes, or services which are then spread or transferred across markets." Innovation development

credit includes loans and other financing activities for the development of new technologies, product innovation, process innovation, organizational innovation, and marketing innovation.

The National Innovation Council (NIC) — a multi-sectoral policy formulation body that is tasked by law to craft a National Innovation Agenda and Strategy Document — is developing strategies towards promoting MSME internationalization, digitalization, and participation in the local and global value chains. A comprehensive support program, from incorporation to internationalization, including industry firmlevel collaborations, shall be developed by the NIC and implemented by concerned government agencies.

Banks have an existing mandatory credit allocation of eight percent of their loanable funds

for micro and small enterprises and two percent for medium enterprises under RA No. 6977 for the development of the small and medium scale business sector. As of end-2021, based on BSP data, banks' compliance to RA No. 6977 is only 2.08 percent for micro and small enterprises. This translates to P178.14 billion loans for micro and small enterprises when banks should have loaned P685.60 billion. For medium enterprises, the banks released P284.99 billion last year versus the minimum requirement of P171.42 billion.

Economic recovery could be hastened considerably if the MSME sector is given a big boost, especially in terms of driving projects and activities that contribute to employment generation and uplifting the welfare of Filipinos that have been severely affected by the global pandemic.

COME NOW, plaintiffs through counsel and unto this

Honorable Court most respectfully states and alleges that:

THE PARTIES

(1) Plaintiffs are the heirs of Canuto Pangilinan herein represented by their duly authorized representative and one of the heirs Domer A. Pangilinan, Filipino citizen, of legal age and a resident of Brgy. Pangil, Amadeo, Cavite. For purposes of this complaint, pleadings, notice and other court process may be served at the address of their counsel at 3D-14 GSIS Metrohomes Bldg., Sta. Mesa, Manila

Copy of the Special Power of Attorney is hereto attached as Annex "A".

- (2) Respondent Teem Multiventures Corporation is a corporation existing under the laws of the Republic of the Philippines represented by John Steven Sy and Nenita Sy with office address Suite 1025 Pioneer Highlands Condominium, East Tower, Pioneer St., Mandaluyong City where copy of the complaint, summons, notice and other court processes may be
- (3) Respondents John Steven Sy and Nenita Sy are Filipino citizens, both of legal ages and with office address at Suite 1025 Pioneer Highlands Condominium East Tower, Pioneer St., Mandaluyong City where copy of the complaint, summons, notice and other court processes may be served.
- (4) Respondent Registry of Deeds for the City of Trece Martires is a public office located at City Hall of Trece Martires City where copy of copy of complaint, notice and other court processes may be served and is impleaded as formal party for being the custodian of the transfer certificates of title of properties located in the said city, the transfer certificate of title subject matter of this case.

FACTS AND CAUSES OF ACTION

- (5) Canuto Pangilinan (herein after referred to as Canuto) was the owner of a parcel of land located at Barangay Conchu, Trece Martires City covered by Transfer Certificate of Title No. T-3387 and Tax Declaration No. 202-A with an area of sixty six thousand five hundred eighty two square meters (66,582 sq.
- (6) On June 4, 1994, Canuto entered in a Kasunduan with Imarflex Battery Manufacturing Corporation (herein after referred to as Imarflex) represented by Mr. Henry Ng. The said Kasunduan is in the nature of a deed of conditional sale setting forth several conditions, fulfillment of which could have reached the consummation of an absolute deed of sale.

Copy of the Kasunduan is hereto attached as Annex "B".

- (7) Despite the fulfillment of the conditions in the Kasunduan and the transfer of the title under the name of Imarflex and its sister company the sale did not push through. Imarflex suddenly changed its mind into acquiring the property leaving Canuto and plaintiffs in limbo. Plaintiffs are the owner and in possession of the property but registered under the name of another.
- (8) As far as they know the property subject matter of their transaction with Imarflex are covered by five transfer certificates of title under the name of Imarflex and its sister company, Weilong Electrical Industrial Corporation, to wit: TCT No. T-48508; TCT No. T-48505; TCT No. T-48502 (Weilong); TCT No. T-48501; and TCT No. T-48500.

Copies of TCT No. T-48500; TCT No. T-48501; TCT No. T-48502; TCT No. T-48505; and TCT No. T-48508 are hereto attached as Annexes "C" to "G".

- (9) It was very unfortunate that Canuto did not enjoy the supposed proceeds of the sale of his property because of his untimely death on May 4, 1997. Nevertheless, Imarflex through series of meetings with the plaintiffs and their counsel amicably settled their issues and agreed that they are willing to cooperate and execute the necessary documents if ever the property would be sold.
- (10) Nobody wants to buy the property of the Pangilinans because of its situation. In 2012 Domer Pangilinan went to the Registry of Deeds of the City of Trece Martires City to get certified copies of the certificates of title of their property but he was informed that there is a pending transaction or transfer of registration under the name of a certain company.
- (11) The deed was executed allegedly for the sale properties covered by TCT No. 48500 with an area of Thirty Three Thousand Two Hundred Eighty Nine square meters (33,289 sq. m.) and TCT No. 48505 with an area of Two Thousand One Hundred Forty Two square meters (2,142 sq. m.). This came as a surprise to the plaintiffs because they already had an understanding with Imarflex as early as 2010 about these properties and upon inquiry with Imarflex, they firmly deny transacting with The Teem Multiventures and confirmed that they honor their agreement with the plaintiffs.
- (12) Not knowing what to do plaintiffs referred the matter to their counsel who conducted an investigation on what really

happened. They investigate led the plaintiffs to a Transfer Certificate of Title No. T-84883 under the name of defendant The Teem Group Multiventures Corporation and the corresponding tax declaration also under its name.

Copy of the Transfer Certificate of Title No. T-84883 is hereto attached as Annex "H" and Tax Declaration No. 004-01-0466-1 is hereto attached as Annex "I".

(13) More importantly, plaintiffs were able to secure a copy of a Notice of Denial date August 9, 2012 addressed to Mr. Antonio Tamaca of Malayan Bank Savings and Mortgage Bank from the Registry of Deeds for Trece Martires City. It was the denial to register the Certificate of Sale (Extra-Judicial Foreclosure of Mortgage-Voluntary) involving the title in the name of Teem Multiventures.

Copy of the Notice of Denial is hereto attached as Annex

- (14) The notice shed light on the real status of the titles. Apparently, the property has two sets of titles, one set (TCT No. 48500 and TCT No. 48505) in the name of Imarflex and one in the name of Teem Multiventures (TCT No. T-84883). The registrar of deeds refused to register the Certificate of Sale which rooted from the title of Teem Multiventures and correctly pointed out that a judicial determination of which two titles must be respected was necessary before his office could act upon the request for registration.
- (15) The plaintiffs are of the firm belief that the Teem Multiventures title is spurious backed by the result of the investigation of the registry of deeds, to wit:
- "(2) Results from the investigation that the undersigned conducted on the matter reveals that TEEM's title appears to have been generated sans the submission of certain essential requisites for a valid registration of transfer transaction. For one, the requisite national taxes (capital gains and documentary stamp taxes) due on the transfer transaction that purportedly led to the issuance of TEEM's title do not seem to have been settled at the time of the entry of the said transaction or after the alleged registration thereof is gross violation of the pertinent provisions of the National Internal Revenue Code, as amended (NIRC). The absence of the corresponding Certificate Authorizing Registration (CAR) is statement to this allegation. For another, it also appears that the local tax (transfer tax free) due thereon may not have been duly settled at the time of the entry or even after the alleged registration of said transfer transaction, again in gross violation of the provisions of the Local Government Code. The absence of any proof of payment such as receipts and the like from local government unit concerned seems to validate siad violation. To top it all, even the real estate taxes due on the subject property may not have been paid at the time of the alleged registration of the said transfer transaction in view of the absence of the requisite Tax Clearance or equivalent thereof from local government unit concerned."
- (16) Plaintiffs need not say more as the results of the investigation on the matter is very clear. Teem Multiventures' title is fake as the same was obtained in violation of laws, through fraud and through whatever illegal means defendants Teem Multiventures, John Sy and Nenita Sy perpetrated to the damage and prejudice of plaintiffs.
- (17) Obviously, defendants used the title to secure a loan from Malayan Bank. Because they do not care about the property at all, they did not bother to pay the loan or redeem the property and just let the bank foreclose it.
- (18) It is already painful that the plaintiffs cannot use their property or dispose the same whenever they want because it is registered under the name of Imarflex but to learn that defendants already made money out of their property, when they are left with nothing but bare promises, is more painful but it took them years to assert their rights because of lack of money and means to do the such.
- (19) A transfer certificate of title secured through fraud and illegal means should therefore be cancelled.
- (20) Due to the foregoing acts of the defendants, the plaintiffs suffered moral damages in the form of mental anguish, mental torture, moral shock, social humiliation and besmirched reputation, for which the plaintiff should be held liable to the defendant in the sum of P200.000.00.
- (21) To serve as an example and to deter commission of similar acts, exemplary damages in the amount to be fixed by
- (22) To protect their rights and interests in this case, defendants were forced to engage the services of their undersigned counsel for a fee of P100,000.00 and P4,000.00 per appearance on which the defendants should be made

PRAYER



WHEREFORE, it is respectfully prayed of this Honorable Court that, after due proceedings, judgment be rendered for

- a. Canceling TCT No. T-84883 under the name of The Teem Group Multiventures Corporation.

direct translations or introduction to grammatical structures, but is effectively learned from simple hearing up to interactive applications.

"(CLIL) allows us to provide rich optimal input, following the idea that when the studentspeaker is right, they are showing what they already know, they are practicing in fact. Whereas when they listen or read, they are learning new things," she added.

Meanwhile, Ellaine Gallagher, one of the invited American English language specialists, emphasized the use of the English language in teaching during this formative season, alongside the consideration of promoting the use of the mother tongue.

"If kindergarten is being taught in the mother tongue, then there's no room for English. How is English being taught? But if the school system decides that they want the mother tongue to be promoted, they can have part of the day in the mother tongue and then some subjects being taught in English. For example, they could do Music and Art in English," she said.

According to the DepEd, more than 300,000 teachers from various district offices nationwide are expected to join the month-long training. (PNA)

PH teachers to optimize learning approaches for K-3

To optimize Filipino teachers' competence in securing quality education among learners from kindergarten to Grade 3 (K-3), the Department of Education (DepEd) and the Regional English Language Office Manila have started their six-week webinar series on Monday.

The online series is expected to set its focus on literacy and numeracy, subdivided into three clusters in Luzon, Visayas, and Mindanao until April 27.

In a webinar livestreamed on Facebook, three American English Language Specialists shared effective approaches to ensure the learners' ability to speak, read, and comprehend during their formative stage.

During the event's kickoff, Rosalie Bongon, a Supervising Education Program Specialist in the Teaching and Learning Division, attested how effective language integration in subjects can help students learn English, particularly with the use of the Content and Language Integrated Learning (CLIL) concept.

"English is not a subject, it is a tool for com-

municating as is any language, and that CLIL is teaching a language via a subject and teaching the subject using a target language.

This tells us that both the language and the content mutually support each other," she said.

Bongon said children's knowledgeacquisition on the English language is not solely achieved through

VATICAN— Pope Francis will consecrate Russia and Ukraine to the Immaculate Heart of Mary, the Vatican announced on Tuesday.

The Holy See press office said on March 15: "On Friday, March 25, during the Celebration of Penance at which he will preside at 5 p.m. in St. Peter's Basilica, Pope Francis will consecrate Russia and Ukraine to the Immaculate Heart of Mary."

"The same act, on the same day, will be carried out in Fatima by His Eminence Cardinal Krajewski, Apostolic Almoner, as envoy of the Holy Father." Cardinal Konrad Krajewski was one of two papal envoys sent to Ukraine last week in an expression of the pope's concern for the war-torn country's population.

March 25 was the day in 1984 that Pope John Paul II consecrated Russia and the world to the Immaculate Heart of Mary. It is also the Solemnity of the Annunciation of the Lord.

Ukraine's Latin Rite Catholic bishops asked Pope Francis earlier this month to consecrate Ukraine and Russia to the Immaculate Heart of Mary.

In a letter to the pope, the Ukrainian bishops said that they were writing "in these hours of immeasurable pain and terrible ordeal for our people" in response to many requests for the consecration.

"Responding to this prayer, we humbly ask Your Holiness to publicly perform the act of con-

'Relief, Reform, Recovery' bill pushed amid oil crisis
