Go green on 'Undas', public told

The Catholic Church's advocacy arm once again called on Filipinos to go green this "Undas", saying that cemetery waste is an issue that should not be buried.

Fr. Antonio Labiao of Caritas Philippines urged the public to keep cemeteries "trash-free" and preserve their sacredness.

"We appeal to our fellow Filipinos to make this year's observance of Undas different from the pre-pandemic celebrations, which were marred by tons of garbage left by cemetery visitors and vendors," Labiao said over Radio Veritas.

According to him, keeping cemeteries clean is part of the people's responsibility to care for Mother Nature. "It's our shared responsibility to ensure that our environment, which includes

us all, is protected against practices that pollute and degrade it," he said. Filipinos are expected to flock to cemeteries and columbaria to visit their

departed loved ones on All Saints Day and All Souls Day. This will mark the first time that cemeteries will be allowed to open during

Undas since the start of the Covid-19 pandemic in 2020.

Religious superiors stand with embattled RMP

A collegial body of major religious superiors assured its support for the Rural Missionaries of the Philippines (RMP), accused of links with terrorist activities.



The Conference of Major Superiors in the Philippines (CMSP) reaffirmed its commitment to RMP as its mission partner in helping the rural poor.

Sixteen people, including nuns, of the RMP are currently facing charges of financing terrorism and violating the country's anti-terrorism

The accused are facing non-bailable offenses of allegedly donating and soliciting funds for the Communist Party of the Philippines and its armed wing, the New People's Army.

The CMSP said it is also "gravely concerned" about the safety and well-being of those accused, and integrity of RMP's ministry to the poor.

"In like manner, we trust and assure the four consecrated women who are implicated and indicted of our unwavering support and solidarity," it added.

With the impact of climate change more felt in recent years, Mr. Dizon

shared the importance of communities to thin out air pollutants in keeping the air fresh and people healthier. The trees which his father planted also helped prevent soil erosion and landslides caused by earthquakes.

He nurtures a dream that some of his children will take after him to help protect the environment.

Getting closer to that dream, one of his sons is eyeing a career in forestry, a nod to his

father's chosen field. To further this advo cacy, Mr. Dizon supports the reforestation initiative of SM Foundation, Inc., the social good arm of SM and the Fast Retailing Foundation (FR Foundation), a general incorporated foundation in Japan through the Grow Trees Community campaign.

The project aims to plant and grow forest trees such as the Benguet pine, Alnus or Calliandra and Coffee trees to also help create livelihood opportunities for the community by working closely with People's Organizations such as NAMALISA in Tuba, Benguet.

National IP Month celebrates our cultural heritage

n Oct. 23-24, representatives of Indigenous Peoples (IP) communities will gather in a celebration called "Dayaw" to present with pride their rich cultural heritage through music, dance, and oral tradition performances, and to share stories on best practices in safeguarding intangible cultural heritage (ICH).


Leading the celebration is the National Commission for Culture and the Arts (NCCA) through the Subcommission on Cultural Communities and Traditional Arts (SCCTA). The theme that will unite the celebration of National Indigenous Peoples Month is "Pagtataguyod ng pamayanang kultural para sa isang matatag na Pilipinas (Upholding cultural communities for a robust Philippines)."

Presidential Proclamation 1906, signed in 2009, declared October as the "National Indigenous Peoples Month" that mandates the "recognition and protection of the rights of Indigenous Cultural Communities (ICC).

The gathering of cultural communities kicked off last Oct. 2 at the Rizal Park, with performances representing IP communities around the country. Today, Oct. 23, the Dayaw performance will be at the Rizal Park open air auditorium. On Oct. 24, the Dayaw forum will be held at the Metropolitan Theater in Manila.

The heart of the celebration will be the sharing of best practices on safeguarding ICH which are "measures aimed at ensuring the viability of the intangible cultural heritage" so that efforts in its preservation, promotion and transmission to the next generation will be initiated.

ICH includes "traditions or living expressions inherited from our ancestors and passed on to our descendants, such as oral traditions, performing arts, social practices, rituals, festive events, knowledge and practices con-





cerning nature and the universe or the knowledge and skills to produce traditional crafts."

Its importance, according to UNESCO, "is not the cultural manifestation itself but rather the wealth of knowledge and skills that is transmitted through it from one generation to the next."

The Philippines has a wealth of intangible cultural heritage, some familiar to many of us now but others still remains to be documented and disseminated so that it will continue to give us "a sense of identity and continuity, providing a link to our past, through the present, and

These are the Hudhud chants of the Ifugao province, the Darangen epic of the Maranao people of Lake Lanao Maranao, and the tugging rituals and games of the Tuwali tribe in Ifugao, the NCCA announced.



MPT SOUTH REACTIVATES SMSK FOR UNDAS 2022

Metro Pacific Tollways South (MPT South), a subsidiary of Metro Pacific Tollways Corporation (MPTC), the toll road development arm of Metro Pacific Investments Corporation (MPIC), readies for the expected motorists' surge during the observation of the All Saints and All Souls' Days as cemeteries reopen for Undas week.

With this, the toll road operator again reinforces road safety for Undas travelers and reactivates the "Safe Trip Mo, Sagot Ko" (SMSK) program across its high-speed road networks Cavite-Laguna Expressway (CĂLAX), with its joint venture partner, the Philippine Reclamation Authority (PRA) and its operating subsidiary PEA Tollway Corporation (PEATC) for Manila-Cavite Expressway (CAVITEX) and CAVITEX Ć5 Link.

'This year's celebration of Undas season will be different from the past two years as cemeteries, especially in Metro Manila, now reopens and more motorists are expected to ply the roads. We are anticipating as much as 10% increase in the volume of vehicles that will pass through our toll roads from October 28 to November 2, 2022," said MPT South's President and General Manager Mr. Raul L. Ignacio.

From 6 AM on October 28 up to 6 AM on November 2, 2022, MPT South toll roads will provide free towing to the nearest exit for Class 1 vehicles needing assistance. There will be intensified 24/7 motorist assistance and will augment the deployment of traffic operations personnel at toll plazas and on the ground to ensure smooth traffic. CAVITEX Customer Service Centers (Cavite and Manila bound) will be available 24/7 for RFID health check, installation, and reloading. Additional cash lanes for cash-paying motorists will be open to cater to seasonal travelers with no RFID.
