National Children's Month to focus on children's mental health issues

The Council for the Welfare of Children will seek to address the mental health and well-being of children as the council marks the 30th National Children's Month observance on November 3.

Cavite invites challengers on SMC's P27-b expressway

The provincial government of Cavite is inviting local and foreign groups to challenge the unsolicited proposal submitted by San Miguel Corp. to build the P27-billion Cavite-Batangas Expressway.

"The provincial government of Cavite invites local and international companies to submit comparative proposals under a competitive challenge bidding process to finance, design, construct, operate and maintain the project under a 35-year concessional period," Cavite's public-private-partnership selection committee chairman Renato Abutan said.

Cavite earlier received and approved the unsolicited proposal from San Miguel Holdings Corp., the infrastructure unit of SMC, for the financing, design, construction, operation and maintenance of the 27.06-kilometer Cavite-Batangas

The project will traverse the municipalities of Silang, Amadeo, Tagaytay, Indang, Mendez, Alfonso in Cavite and Nasugbu in Batangas.

2 DSWD officials relieved following complaints of Cavite mayor

Two officials of the Department of Social Welfare and Development (DSWD) were temporarily relieved and transferred to another office after the department received complaints from Noveleta, Cavite Mayor Dino Reyes Chua.

Mayor Chua, as disclosed by DSWD Secretary Erwin Tulfo in a press briefing on Thursday, Nov. 3, complained about the alleged "numerous requirements that were being asked by DSWD officials before releasing aid to his constituents."

"Si Mayor Chua ng Noveleta, Cavite ay nagrereklamo po siya na madami raw pong hinihingi na dokumento [at] papeles ang DSWD gayong ang kanyang mga constituents ay humihingi lamang ng ayuda (Mayor Chua of Noveleta, Cavite is complaining that the DSWD is asking for a lot of documents and papers when his constituents are only asking for help)," said

This is in contrast with President Ferdinand "Bongbong" Marcos Jr.'s mandate to make the distribution of aid, especially to cyclone or calamity-hit Filipinos, easier.

DSWD admitted that they, indeed, ask benefi-

ciaries for an identification card, adding that if no IDs may be presented, their name must be on the list from their local government unit (LGU)

"We have conducted an initial investigation and the Regional Director of Region 4A [Barry Chua] and Assistant Regional Director [Myla Gatchalian] told me that those who were not given aid are not on the list. Mayor Chua, however, insisted that they are on the list," Tulfo

Governor Jonvic Remulla briefed the president that around 18,000 families have

DOST-CALABARZON and PSTO-Rizal launch 120-day Feeding Program to address malnourishment among children in Tanay, Rizal

Feeding programs go beyond providing nutritious meals to children, empower and give them proper nutrition to go on with their everyday lives. To answer this, the Department of Science and Technology initiated the Community Empowerment through Science and Technology (CEST) Program to ensure that communities with malnourished children will be given proper nourishment through DOST's complementary food technology.



Last September 19, 2022, the DOST-CALABARZON, through its Provincial S&T Office in Rizal (PSTO-Rizal), started the 120-Day Feeding Program to 163 malnourished children in Tanay, Rizal under DOST's (CEST) Program. The event took place in Tanay Gymnasium, E. Rodriguez St. Brgy.

During the visit, President Bong Bong Marcos (PBBM) led the distribution of goods to the remaining evacuees in the evacuation center together with Department of Social Welfare and Development (DSWD) Secretary Erwin Tulfo.

During a press briefing that ensued after the distribution activity, President Marcos Jr. states, "We are at the stage of rebuilding, we have to help the victims of the typhoon by giving them building materials to rebuild their houses."

Filipino Values Month worthy of celebration

t is hard to sell to Filipinos abstract concepts of nationalism, unity, empathy for others, etc. which are native values inher-

ent to our race. Still and all, former President Fidel V. Ramos issued Presidential Proclamation No. 479 on Oct. 25, 1994, declaring the month of November of every year as Filipino Values Month.

In signing this presidential issuance, President Ramos not only enjoined all government agencies and offices to instill in their personnel the correct and upright values that define our national character, but also expressed the hope that future generations of Filipinos will continue planning and living their lives around these values.

Proclamation 479 builds on the gains of the government's moral recovery program as enunciated by an earlier Presidential Proclamation, No. 62, issued on Sept. 30, 1992.

Both executive issuances were made in response to the need to strengthen the moral resources of the Filipino rooted in the Filipino culture, values and ideals that are pro-God, pro-people, pro-country and pro-nature.

Through these measures, the government at that time endeavored to mobilize all Filipinos for nation-building through the practical exercise of human values in their daily lives as citizens. The lofty objective was "to awaken us all to the power of these values in achieving our individual and national goals."

From the time of President Ramos until today under the administration of President Ferdinand "Bongbong" Marcos Jr., the government has pushed for the celebration of Filipino Values Month on a regular basis because they recognize that this observance is a desirable and effective measure to create moral awakening and national consciousness on human values that are unique, genuine and positively Filipino.

In its early years of observance, the Filipino Values Month celebration was spearheaded by the Kabisig People's Movement of former President Corazon Aquino, which later sponsored the government's Expo and Trade Fairs which showcase the profiles, service facilities, programs and projects of various government agencies.



"I am relieving two of my officials so that this does not happen again. Earlier, I issued a relief order for my two officers. [I hope] this situation does not happen again, especially now that we are in the typhoon season," he said.

The committee said to obtain a copy of the request for comparative proposal and participate in the competitive challenge, any interested party should register and submit a written expression of intent, sign the prescribed non-disclosure agreement and pay the non-refundable participation fee of P1 million on or before the last day of registration and purchase of RFP.

It said the challengers should also submit qualification documents, technical and financial proposals as one bid package not later than Jan. 24, 2023 at 2 p.m.

National Children's Month to focus on children's mental health issues

The Council for the Welfare of Children will seek to address the mental health and well-being of children as the council marks the 30th National Children's Month observance on November 3.

"Kalusugan, Kaisipan at Kapakanan ng Bawat Bata Ating Tutukan," the kick-off ceremonies will gather participants from national government agencies, non-government organizations, civil society organizations, and local government units.

Undersecretary Angelo Tapales, CWČ Executive Director, said this year's theme is anchored on the World Health Organization's statement that health is "a state of complete physical, mental and social wellbeing and not merely the absence of disease or infirmity."

"Many were affected during the Covid-19 pandemic. But the silent victims of the pandemic are the youth and children as

Highlighting the theme there were no discus- the country. sions on how the pandemic has affected them," Tapales said in a press briefing last Tuesday, October 25.

He added the CWC will also push for the review of the Mental Health Law to include children's welfare.

In 2018, the Philippines had published findings from the 2015 National Baseline Study on Violence against Children (NBS-VAC) showing that children and youth aged 13-24 years, experience high levels of physical (64.2 per cent), psychological (61.5 per cent), sexual (22.4 per cent) and peer (65 per cent) violence.

It was the first study to measure prevalence of all forms of violence against children across

Some activities linedup during the kick-off are: ceremonial launching of the CWC MĂKABATA Helpline, partnership launching with the Miriam College Child Rights Advocacy Center (CRAC), National Play Advocacy Week (NPAW) Partners' Play Toolkit launch, and the relaunching of the Mental Health Literary Pieces for Children: Šarilaysay Activity Book and Eroplanong Papel Comic Book.

Video documentaries on the success stories of **Local Government Units** on Child Participation and the Local Council for the Protection of Children (LCPC Functionality) will also be shown.

ernance will also be held with Mayor Dahlia A. Loyola from the municipality of Carmona, Cavite as speaker.

Republic Act 10661 or the National Children's Month Act is celebrated every November and commemorates the adoption of the United Nations Convention on the Rights of the Child on 20 November 1989. Under section 3 of the law, the CWC. National Youth Commission, and the Department of Social Welfare Development were designated as the lead agencies for the conduct of the celebration.

The month-long celebration aims to instill in the Filipino consciousness as well as sustain the promotion and protection of children's rights. (CS/PIA-PMD)
