

DepEd to launch Bullying Prevention campaign

The Department of Education (DepEd), spearheaded by the Child Protection Unit (CPU), will launch the Bullying Prevention Advocacy Campaign during the observance of the 30th National Children's Month (NCM) this November.

With the theme #KasamaKa: BaLiK-Aral (Boses, Lakas ng Kabataan at Komunidad sa Balik-Aral), the said campaign will focus on three core aspects: KasamaAko (Adbokasiya Para sa Sarili), KasamaKayo (Adbokasiya para sa Kapwa), and KasamaTayo (Adbokasiya Tungo sa Pagbabago).

"This program aims to recognize schools that deliver positive results for the learners' well-being. Schools will be assessed based on criteria aligned with the Child Protection Policy Implementation Checklist, principles and objectives of a child-friendly school, focusing on child's rights, health, protection, and learners' participation," the issuance stated.

US must quit its overbearing role in Africa

It was Kwame Nkrumah, Ghana's first Prime Minister, who famously declared during the founding of the Organisation of Africa Union (OAU) in Addis Ababa on 24th May 1963 that Africa, which was gradually emerging from the furnace of colonialism, must unite if she must confront and wade off the yoke of neo-colonialism. In his words, the great pan-Africanism proponent thundered to his audience that the continent "must unite now or perish". He reminded the countries that gathered from different blocs of the continent that "independence is only the prelude to a new and more involved struggle for the right to conduct our own economic and social affairs". Other speakers like Julius Nyerere at that August event passionately shared the sentiments and the need for a united continent.

These founding fathers might not be prophets, but they had a foresight of the struggles that this newborn independent child as it were, would face growing interference from the West who has seen her enormous and blessed natural resources. More than 60 years since they made those onerous calls, the reality of what they feared is evident in the continent. More than 60 years later, the continent is struggling to free itself from the high-handedness of the overarching influence of so-called super powers and developed democracies like the United States of America (USA).

Africa has so many leeches deliberately working to hamper its growth and to manifest its true essence, and the overt and covert activities and overbearing influence of the USA through its criminal and murderous world police known as the Central Intelligence Agency (CIA) has held the continent bound. The US through the CIA has instigated unnecessary and avoidable conflicts and political instabilities that have resulted in various violations of human rights, unwanted loss of lives and hampered the continent's development. Pag-IBIG Calamity Loan ready for members affected by Typhoon Paeng

Top executives of Pag-IBIG Fund announced on Friday, 4 November, that the agency has allocated P5 billion in calamity loan funds to help members affected by Typhoon Paeng.

"We are ready to help our members affected by Typhoon Paeng with our Calamity Loan program. We have initially identified a total of 344,000 affected members in Regions IV-A (CALABARZON), V (Bicol Region), VI (Western Visayas), the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) and other areas where a state of a calamity has been declared by the local government unit, who are eligible to borrow under the program. That is why we have set aside P5 billion in calamity loan funds to help them recover from the damages caused by the typhoon.

This is in line with the directive of President Ferdinand Marcos, Jr. to provide Filipinos in affected areas with immediate relief and all the necessary assistance," said Secretary Jose Rizalino L. Acuzar of the Department of Human Settlements and Urban Development and Chairperson of the 11member Pag-IBIG Fund Board of Trustees

Under the Pag-IBIG Calamity Loan, eligible members may borrow up to 80% of their total Pag-IBIG Savings, which consist of their monthly contributions, the counterpart employer's contributions, and accumulated dividends earned. And in consideration of the plight of the members, the loan is offered at a rate of 5.95% per annum which is the lowest rate in the market. The loan is payable over a period of up to three years, with a grace period of three months so that initial payment is due only on the fourth month after the loan is released. Qualified borrowers may apply for the calamity loan within 90 days from the date when an area has been declared under a state of calamity.

Pag-IBIG Fund Chief Executive Officer Marilene C. Acosta, meanwhile, stated that the agency has already released P2.03 billion in calamity loans to help 149,773 members in calamity-hit areas as of September this year. She also added that PagIBIG branches are now in coordination with local government units who have declared a state of calamity in their respective areas for the deployment of the agency's mobile branch, the Lingkod Pag-IBIG On-Wheels, to receive applications for calamity loans from members as well as insurance claims from current PagIBIG Housing Loan borrowers whose properties have been damaged due to the typhoon.

Even while our offices and personnel in calamity-hit areas have also been affected by the typhoon, our branches remain open and are ready to receive loan applications and housing loan insurance claims. We have also deployed our Lingkod Pag-IBIG on Wheels to initially go around typhoonstricken areas in Cavite, Aklan, Capiz, Cotabato and Maguindanao to further bring our services closer to our members who are most in need. And, for members who have internet access, the Virtual Pag-IBIG is ready to accept their calamity loan applications online. Natural farming in the PH still has ways to go, but it's getting there

ovember is Organic Agriculture Month. Republic Act (RA) No. 10068, also known as the Organic Agriculture Act of 2010, was signed by the President Benigno Aquino, Jr. on May 21, 2015.

According to the Official Gazette of the Philippine government, Organic Agriculture month was created "to promote, propagate, develop, and further implement the practice of organic agriculture in the Philippines.'

Seven years on, not only has organic agriculture remained a niche industry, the use of the term "organic" itself has been clouded. Nowadays, in this country at least, the official term for farms that practice organic farming but do not have third-party certification is "natural" farm, with "organic" reserved for farms or products that have the proper paperwork.

And since third-party organic certification can be very costly, this is hardly a good strategy for small farmers who can barely make ends meet, if at all. It's a huge roadblock to its use as a "tool for development." That said, organic certification is still important if one wants to compete globally, as it is an important requirement in many countries.

Thankfully, this hasn't stopped many farmers from practicing natural farming, nor has it hindered those interested from seeking a less expensive, more democratic way of obtaining organic certification.

The Participatory Guarantee System (PGS) is an internationally recognized quality assurance system that relies on farmers and stakeholders to make sure that the farm seeking organic certification adheres to a previously decided set of qualifying criteria. It is recognized by the International Federation of Organic Agriculture Movements (IFOAM), who also helps in PGS training and also complies PGS initiatives worldwide.

Seven years on, there are still many misconceptions about organic agriculture - that it is expensive, that it is easy, even that it is the solution to all problems. Much work has to be done to show (not tell) people that naturally grown crops can be for everyone, not



just the wealthy, but this also requires a food system that will make it accessible to everyone regardless of income.

There is a huge push to encourage people to farm, and much of it hinges on promoting it as a social media-friendly lifestyle.

In reality, farming is usually difficult, and while we must encourage more people to find careers in agriculture, we must also build the infrastructure that will encourage them to stay beyond the social media posts. Natural farming is even harder than conventional farming, but as its practitioners will tell you, the results are worth it.

Natural farming is a solution to our food cri-

sis, but it is not THE solution, which will probably be a mix of different practices hinging on an effective and transparent food and agriculture system, much of it requiring proper laws and regulations and implementations thereof. If the government wants to encourage farming, they should make it easy and profitable for farmers to stay farmers.

We have a long way to go in terms of giving natural farming the recognition it deserves, but as more consumers begin to ask questions about where their food comes from, more farmers will be encouraged to follow this mode of agriculture.

It houses equipment, tools, and various technologies for mold and mold-related requirements of the industry. The establishment of the MTSC aims to help advance local mold companies, increase their productivity, and help them become globally competitive.

At the MTSC launch, MIRDC executive director Robert Dizon said the facility will also help strengthen the industrial cooperation between the Philippines and the Republic of Korea.

"Korean partners who supplied all the equipment are here to

demonstrate and encourage more local companies to avail of MTSC's services. Not only did they provide the equipment, but our Korean partners made sure to boost the skills and technical know-how of our MTSC engineers and staff," Dizon said.
