# HUGE SUCCESS OF DOST-RSTW CELEBRATION IN CAGAYAN VALLEY

THIS year's celebration of the Department of Science and Technology's (DOST) Regional Science and Technology Week (RSTW) in Region 2, Cagayan Valley, was a big success.



DOST Secretary Dr. Renato U. Solidum Jr., underscored the importance of using science, technology and innovations (STI) "to make life easier and to have a better future." Other guests in the three-day event held at Robinsons Place in Tuquegarao were DOST undersecretaries led by Engr. Sancho Mabborang for Regional Operations; Dr. Leah Buendia for Research and Development; Regional Directors led by Region 2 Director Virginia Bilgera, national and local dignitaries led by Tuquegarao City Mayor Maila Ting Que.

The national media was represented by president Nelson Santos of the Publishers Association of the Philippines, Inc. (PAPI) and other local media.

With the theme, Agham at Teknolohiya: Kabalikat sa Maunlad at Matatag na Kinabukasan," Solidum said that "it is really through science and innovation that can really propel the economic development" of the Philippines.

What is really impressive, he said is the large participation today of Region 2 and he was amazed of the presence of various leaders and representatives of the private sector, civil society, development partners, government and other sectoral groups.

"The desire for innovation has led us increase our effort and find effective ways to help the Filipinos," Solidum declared during the event's closing ceremony

on Friday, Nov. 18. On the other hand, Mabborang commended everyone in DOST Region 2 "for their hard work in advancing science, technology and innovations in the region."

He said this year's RSTW will be pushing forward its programs, projects and services to attain its goal of becoming the science, technology and innovation hub in the entire Cagayan Valley region.

The holding of the event in the region was actually a return or "comeback" to the region after a two-year hiatus



due to the global pandemic. The celebration for the last two years was virtual.

"We know that the crisis forced us to adapt new ways of working, educating and relating to one another but it did not stop us from reaching out to our stakeholders including Micro, Small and Medium Enterprises (MSMEs), LGUs, the academe, public and private institutions," Mabborang stressed during the second day of the affair.

Bilgera, meanwhile said that the celebration "is another opportunity and a chance to recognize the immense contribution of our STI partners, their achievements through the sheer of their hard work, passion, perseverance and excellence

amidst the pandemic and their battle towards the new normal."

Awards were also given to winners of various categories such as in Science and Mathematics and Investigatory Project and S & T jingle competition.

To learn more about the coming end to singleplastic use, the Industrial Technology and Development Institute (ITDI) of the DOST will conduct a technology forum on "Analyzing the Life Cycle of Non-Environmentally Acceptable Products on 23 November 2022 from 1:00PM – 2:00PM at the Luna Room of the World Trade Center, Pasay City.

With the enactment of Republic Act No. (RA) 9003, otherwise known as the Ecological Solid Waste Management Act of 2000, the DOST-ITDI had initiated projects to address the problems of solid waste management in the country following the waste management hierarchy were avoidance and reduction are the most preferred options.

## PH's call for postpandemic recovery, economic cooperation heard on the world stage

President Ferdinand R. Marcos Jr. returned to the country early this week after the 40th and 41st Association of Southeast Asian Nations (ASEAN) Summits and Re-

Asian Nations (ASEAN) Summits and Related Summits in Phnom Penh, Cambodia. He dubbed the participation of the Philippines and his first as Chief Executive — as a success, owing to the numerous dialogues, meetings, and side talks made with our neighbors and allied countries.

Foremost, the President reported to the nation his call for unity among the ASEAN member states and the need for collective strength in order to address post-pandemic recovery issues. "We have similar challenges on food supply, fertilizer prices, oil prices, etc. Member states understand that we can't do this alone. We need to be united and help each other," he said.

The President also mentioned that other pressing issues were discussed, some of which required a "balancing act" as there were opposing sides to consider, such as the situation in Myanmar, the developments in the South China Sea, the war in Ukraine, the application of Timor-Leste for ASEAN membership, etc. During these talks, the President ensured that the Philippines extended its openness to listen and demonstrated receptiveness to cooperation and mutual interests.

"We reviewed the progress of our relations so far, in the initiatives and projects under ASEAN-led mechanisms. There was an exploration of possible new areas of cooperation with our dialogue partners.

We exchanged views on regional and international issues," he said, describing his participation in dialogues with the United States, Canada, Australia, and New Zealand.

As for bilateral meetings, the President had a fruitful discussion with leaders from Cambodia, Brunei, Canada, South Korea, and Vietnam. "In these meetings, we discussed how we can deepen cooperation in key areas and we exchanged views on important regional and global issues."

More importantly, the economy was on top of the President's agenda. "I invited (Cambodian) business leaders to visit and have a look at the opportunities that they might find in the Philippines, arising from the process of transforming the economy, given that it seems our direction for post-pandemic recovery is bearing fruit.

Our discussions touched on collaboration on specific sectors such as food processing, energy, housing, medical care, the manufacture of garments and bags, education, training," the President said.

This positive outcome from the ASEAN meet, buoyed by the optimism of the President who debuted on the world stage, bodes well for the country's participation in the Asia-Pacific Economic Cooperation (APEC) Leaders' Meeting, which will be held in Bangkok, Thailand starting today, Nov. 16, 2022. Like in the ASEAN meet, the President intends to raise on the world stage the priorities of the country in terms of trade, investment, and post-pandemic recovery.

Add to that, the President will push during the APEC meet for "an economic agenda which includes empowerment of the MSMEs and their inclusion in global value chains, recognition of the essential role of maritime crews and seafarers in ensuring stable and resilient supply chains, and ensuring food and energy security, as well as climate change mitigation and adaptation."

As the President departs for Bangkok, we wish him well. If a President does well on the world stage, it would send an uplifting message to the millions of Filipinos around the world and at home that the Philippines is, once again, back in business.



Learning resources are devices and materials produced that help to make teaching and learning more interesting and effective.

The 23 Schools Division Offices (SDOs) in Calabarzon presented their Contextualized Learning Resources that highlighted their best practices in adapting blended modalities in delivering quality education to students at the height of the Covid-19 pandemic.

Curriculum and Learning Materials Division (CLMD) chief, Job Zape said that as highlight of the Learning Resources Expo, the Workshop on the Quality Assurance of SDO Contextualized Learning Resources Used for Learning Recovery Plan will help the regional education office and its Schools Division Offices in upgrading their learning resources, particularly in numeracy and literacy.

"We hope to upgrade learning resources to strengthen numeracy and literacy, upskill teachers and parents, and advance skill building of teachers and parents across learning areas," Zape said.

While Schools Division Offices can make their own Contextualized Learning Resources, Atty. Rolando Bernalez reminded that learning materials are also encompassed in the Intellectual Property Rights Law.

"The worst that can happen to us is to lose our credibility as teachers, as writers, and as professionals." Bernalez warns. (PB/PIA4A)

PPDAO Head Ms. Marie Shiela Antenor-Haloc expressed her gratitude for all stakeholders' participation in the meeting and urged the partner agencies to continually support initiative programs and projects for the welfare of persons with special needs/disabilities. ### PEZA

In a five-day investment promotion meetings and activities, PEZA together with private sector partner Aboitiz InfraCapital (AIC) pitched the Philippines for investments especially for export productions in ecozones. The said investment mission was joined by the Department of Trade and Industry (DTI), Board of Investments (BOI), Department of Foreign Affairs (DFA), Department of Energy (DOE) and Philippine Trade and Investment Center (PTIC-Tokyo).

In his presentation, PEZA OIC Director General Tereso O. Panga discussed during the "Philippine Business Forum" held on 14 November, "As of September, PEZA has a total of 898 Japanese enterprises located in our economic zones with cumulative investments of PhP 739.599 billion. Meanwhile, from January to September 2022, PhP 11.262 billion of investments were made from Japanese investors, with USD 13.258 Billion of export income generated, and created 351,335 direct jobs."

In terms of priority sectors in the current PBBM administration, OIC Chief Panga said "We draw our guidance from the priority strategy of President Bongbong Marcos which are into economy, agriculture, and renewable energy. We are also guided by DTI's Science Technology Innovation-driven industrialization strategy."

"Ito po ang hinahanap natin na investments galing sa Japan. Bagama't sila ngayon ay number one na investor sa ecozones under PEZA, patuloy pa natin silang hinihikayat na mag-invest pa sa Pilipinas," added Panga. (Although they are already the number one ranking investor in economic zones under PEZA, we are still encouraging them to invest more in the Philippines.)

According to DTI Undersecretary and BOI Managing Head Dr. Ceferino S. Rodolfo, "They are pioneers and leaders in key areas in renewable energy and digitalization. Japan also administered visionary industrial souls that will provide us with full solutions should they decide from page 1

to locate in the Philippines." Back-to-back invest-

ment signings In a roundtable discussion of PEZA and AIC Iast 17 November, PEZA inked two (2) strategic partnerships: A Memorandum of Understanding (MOU) with Junca Global Partner, Inc. and a Registration Agreement (RA) with Kurabe Industrial Philippines, Inc.

Under the MOU Signing with Junca Global Partner, Inc., PEZA and Junca shall aggressively promote the Philippines as an investment destination not only for the established manufacturing companies in Japan but as well as startups that want to collaborate with local startups or MSMEs that are engaged in activities under the Fourth Industrial Revolution (FIRe). Junca Global Partner, Inc. is into stem cells biotech, fintech, and blockchain technology.

OIC Chief Panga mentioned, "With the signed MOU, PEZA and Junca will collaborate in bringing renewable energy technologies to ecozones and thereby enable locator companies to remain globally competitive while at the same time contributing to mitigating the effects of climate change pursuant to the Kyoto Protocol and the Paris Agreement."

In an interview with PTV, Panga also said, "These are high-tech industries that will diversify the country's investment profile. The biotech industry will support our bid to attract (investments in) R&D and pave way for their commercialization and level up the value chain so we can compete with big countries on high-tech industries,"

Junca Chairman and CEO Dr. Hisayuki Nagatome stated, "I would like to thank Director General Panga, DTI Secretary Alfredo Pascual, and President Marcos Jr. for this partnership. I guarantee you that Junca Holdings will invest and bring in the latest technology in the Philippines through PEZA, especially in the field of artificial intelligence (AI), blockchain system, biotech and stem cell, and wellness products."

Meanwhile, with the signed Registration Agreement, Kurabe, an electronics company, will operate in a five-hectare lot in Lima Technology Center - Special Economic Zone (LTC-SEZ) in Lipa City, Batangas. Kurabe will engage in the manufacturing and assembly of car seat heater (CSH), steering wheel heater (STH), and CSH and STH heating wires.

Japanese stakeholders committed to bringing more investments in PH

OIC Chief Panga shared that business meetings with potential investors were "serious and have heightened interest to invest in areas under the renewable energy, electronic vehicle, and agro-industrial sector."

PEZA delegates met with Japanese EV stakeholders, Marubeni, Umehara, Epson, Canon, FEC, and SMBC Nikko Securities Inc. There were also consultation meetings with the Philippine Embassy in Tokyo with leading Japanese banks.

With PEZA's robust investment promotions in Japan and in other recently visited countries, PEZA OIC Director General highlighted, "We echo the call of the government and our investors that the Philippines is the smart investment choice in the region. This is the best time to invest in the Philippines as it is one of the top-performing countries in Asia."

This is seconded by Aboitiz InfraCapital Head of Economic Estates Rafael Fernandez de Mesa. He said, "We are committed to helping establish the Philippines as a preferred investment destination in the region and we would be honored to welcome more Japanese [investment] leaders." (PEZA)

Cavite community groups trained in urban gardening technologies

TRECE MARTIRES, Cavite (PIA) – Three community groups from the cities of Imus, Dasmariñas, and the municipality of General Emilio Aguinaldo were provided with training on Urban Gardening Technologies by the Department of Agriculture (DA) - Agriculture Training Institute (ATI) – Calabarzon on November 14-16.



The three-day training was held at the DA-ATI 4A Compound here with lead facilitator OIC TCS Director II/Center Rolando Maningas, Ph.D. formally commencing the event.

In his opening message, Director Maningas emphasized the importance of building community-based urban gardens to help address food security in the region and the entire country.

The training was in response to President Ferdinand R. Marcos, Jr.'s directive to intensify food security programs to increase the participants' capacity and knowledge in various urban gardening technologies that are suitable for their community.

This will also support the community groups that will be beneficiaries of the projects under Urban Agriculture.

Serving as resource speaker in the three-day training, Mrs. Cynthia Perez from the Office of the Cavite Provincial Agriculturist and other employee trainers from the agency.

The participants were

taught various urban gardening techniques such as container, vertical, raised bed, square foot gardening, edible landscaping, hydroponics, and aquaponics, and were given an opportunity for the actual preparation of seeds, and natural fertilizers.
