

# THE COMMUNITY PRESS AND THE CHALLENGES IT FACES IN THE POST-PANDEMIC ERA

THE press has the power to uplift individuals, to instigate community change and to direct the nation's aspirations, according to Supreme Court administrator, Raul B.Villanueva.

The court official made the declaration in his speech during the Publishers Association of Philippines, Inc.'s (PAPI) National Press Convention on April 22, 2022 held at the Penlai Finest Chinese Cuisine (Formerly Shangri-La), with the theme "The Community Press: Its Challenges in the Post-Pandemic

Era."

"Information is a capital and those who wield it possess an insurmountable amount of power at their disposal," Villanueva said. This privilege however, entails adherence to truth and dignity and allegiance to nothing else. "This adherence is made even more challenging

due to Covid-19 pandemic that we are all subjected to, changing the usual way we go about with our daily lives."

# Imus New Government Center formally opens

Trece Martires, Cavite (PIA) - The city government of Imus held the blessing and inauguration of its New Government Center last Monday, April 25.

City Mayor Emmanuel Maliksi who led other officials and guests said while the fight against the Covid-19 crisis is very much the city government's priority, this should not hinder the administration's desire to accomplish other programs and projects aimed at providing for the welfare of the citizens.

The building which is part of the legacy projects of Mayor Maliksi's administration is designed to be an 'Eco-Friendly Green Building' because of the green architectural principles such as the solar panels installed to power its lighting and other electrical fixtures. A rain water harvesting system which is stored in tanks can supply the building occupants for at least four days.

Also, a sewage treatment plant ensures water wastes are safe and treated before it is released to the sewerage while a material recovery facility contributes to the solid waste management and recycling as well.

editor-in-chief of Philippine News Today for the Recognition Award; Other Presidential awardees were: Jessica Bacud, Angelina Lim, Danilo Silvestrece, Rolando Andy Manatad, Dr. Henry Lim Bon long, president of the Federation of the Filipino-Chinese Chambers of Commerce and Industry.

Meanwhile, the Executive Judges for the awardees were Flordeliz Cabanlit Fargas of Cavite; Virgilio Macaraig of Manila and Cecilyn E. Burgos Villaver of Quezon City.

Further, Villanueva said that "the way forward is a united front against any form of injustice and that institutions like the PAPI has the stake to see to it that this is judiciously pursued and earnestly promoted." He added that in the efforts, the concepts of shared responsibility and adhering to a common pursuit done in unison to safeguard the information systems and meet the challenges of the post-pandemic era.

"Without firm commitments and purpose, when a clear vision and mission is lacking, we can never go far and will not achieve what we set out to accomplish," the Supreme Court official explained.

Villanueva added that PAPI, with its influence "should serve as the formidable channel in the information systems "to pave the way for a community press that is faithful and true to its calling as the sentinel for a free press and an indispensable ally of the judiciary."

On the other hand, Supreme Court Associate Justice, Jose Midas Marquez received a Special Recognition/Citation award from PAPI. He belatedly greeted PAPI president Nelson Santos on his 60th birthday last April 15.

Marquez said he has been closely working and collaborating with PAPI for around 10 years, even when he was still a court administrator. The close relationship between PAPI and Marquez continues up to now. Led by president Santos, PAPI thanked all

the guests from regular to associate members of the association, to community newspaper publishers, media executives, editors, print and broadcast journalists, public information officers, campus journalists and their faculty advisers.

All these features aim to lessen its carbon footprint from its daily operations.

The government building is also considered a "Smart Building" because of its computer-based building management and maintenance system.

The system could control all lighting, the alarm system, its elevator system, 500 CCTV surveillance cameras and other facilities to give access to Persons with Disabilities (PWD).

The 53,761 sqm lot is

located at Pedro Reyes in Barangay Malagasang I-G while the Executive Building sits on the 32,871 sqm area near the Ospital ng Imus and Imus Grandstand.

Now that all 72 offices of the city government is housed under one roof, the public is assured to expect a much better service from the city government. *(RF)*

# PH carves its role in global tourism he just concluded three-day World

Travel & Tourism Council (WTTC) meeting held in Manila has highlighted the Philippines, not just as a tourism destination, but as a prime mover in this industry globally.

The 21st WTTC Global Summit, the first global event staged in the country since the pandemic, was an initial salvo to a world reopening after more than two years of the Covid-19

Come to think of it, the WTTC is considered as one of the most influential tourism events worldwide. This year's WTTC hosted 1,200 inperson attendees, including 200 media and 1,000 delegates from various countries, and 30 government officials. For the virtual platform, the summit boasts of 10,000 attendees.

The Virtual Platform will continue to be promoted for a month after the Summit finishes so more people can view it.

It is an annual gathering of the entire spectrum of the industry, including airlines and airports, hotels and hospitality groups, tour operators and retail travel agents, online distributors, cruise lines, investment companies, insurance groups, and the technology industry.

Such mileage will overshadow the country's competitors in a travel-hungry world.

WTTC President and Chief Executive Officer Julia Simpson lauded the leadership of Secretary Berna Romulo-Puyat for her continuous efforts to revitalize the tourism industry of the Philippines, which has been steadily recovering in spite of the ongoing global health concern.

Simpson spiced it up with WTTC forecasts of an average annual growth rate of 6.7 percent over the next 10 years, exceeding the expected country's overall economy average growth rate of just 5.6 percent.

WTTC also forecasts that tourism employment will grow annually by an average of 3.0 percent over the next 10 years, generating 2.9 million new jobs, accounting for 21.5 percent of all jobs in the Philippines.

Credit goes to Romulo-Puyat, the country's tourism poster girl, who played her role to the hilt. The proactive secretary is one of the best choices, if not the best, the country has had

## 4 Prutas Para Sa Hindi Makarumi

araming tao ang hindi makarumi ng regular. Ang tawag dito ay constipation o pagtitibi. Ang pagtitibi ay puwedeng magpalala ng sakit sa puso, luslos at hemorrhoids.

Ang mga buntis, kababaihan at may edad ay madalas hirap makarumi. Hindi namin pinapayo ang pag-inom ng gamot o herbal tea para makarumi. Sa katagalan ay makasasama ito.

May mga prutas na mabisang lunas para sa hindi makarumi. Subukan niyo ang 4 na prutas na naguumpisa sa letrang "P"

1. Pakwan – Ang pakwan ay may taglay na 92% alkaline water. Mataas ito sa vitamin A, Vitamin B, Vitamin C, lycopene at potassium. Ang pagkain ng 2 hiwa ng pakwan sa maghapon ay puwede nang magpalambot ng dumi. May benepisyo din ang pakwan para sa bibig, sikmura at bituka. Makatutulong ito sa may singaw at bad breath (mabaho ang hininga).

2. Papaya – Ang papaya ay napakabisang prutas para sa hindi makarumi. Kapag kumain ka ng 1 o 2 hiwa ng papaya ay siguradong lalambot ang iyong dumi. Kapag matamis ang papaya ay mas mabisa ito. May sangkap na papain ang papaya, isang enzyme na nakatutulong sa paglambot ng dumi. Mataas din sa vitamin C ang papaya kaya masustansya ito. Huwag lang sosobrahan ang pagkain at baka magtae ka naman.

3. Peras (Pears) - Ang peras ay mayaman sa fiber at sorbitol na makatutulong sa pagdumi. Ang fiber ay nagbibigay ng hugis (o bulk) sa dumi. Ang sorbitol naman ay nagbibigay ng tamis sa peras at naghahatak ng tubig sa loob ng bituka para lumambot ang dumi. Ayon kay Dr. Jay Hoecker ng Mayo Clinic, puwedeng bigyan ng peras ang mga sanggol at bata na hindi makarumi. Ang 2 hanggang 4 na onsa (ounce) ng katas ng peras ay maaaring makatulong sa pagdumi ng bata.

4. Prunes – Sa Pilipinas, makabibili tayo ng prune



juice at dried prunes sa mga supermarkets. Ang prunes ay matagal nang lunas para sa pagtitibi. Tulad ng peras, may taglay na fiber, sorbitol at antioxidants ang prunes. Sa bawat kalahating baso ng prune juice (100 ml) may sangkap itong 6.1 grams ng sorbitol. Dahil dito, napapalambot ng prunes ang dumi. Ayon sa mga eksperto, may tulong din ang prunes sa buto at sa pag-iwas sa osteoporosis.
