# Phase 2 Construction of CAVITEX C5 Link Segment 2 Set to Begin

Cavitex Infrastructure Corporation (CIC), a subsidiary of Metro Pacific Tollways Corporation (MPTC) and the concession holder for the Manila-Cavite Expressway (CAVITEX) and its C5 Link segment, inks deal with the China Road and Bridge Corporation (CRBC) to construct Phase 2 works at the CAVITEX C5 Link Segment 2.

CAVITEX C5 Link Segment 2 is a 1.9-kilometer, 2x3 lane expressway that will connect CAVITEX R-1 (Coastal Rd.) from Paranaque Toll Plaza to Sucat thru R-1 Interchange. It is expected to reduce travel time to Sucat Road from CAVITEX R-1 and vice versa by 10 minutes. PHASE 2 • 2


## Carmona, now a component city

President Ferdinand Marcos, Jr. signed into law Republic Act No. 11938 converting the Municipality of Carmona into a component city of the Province of Cavite on Friday, February 24, 2023.

According to Cavite 5th District Representative Attorney Roy Loyola, it has been twelve (12) long years since they started the journey to cityhood. He originally authored Carmona's proposed city charter.

On January 30, 2023, the Senate approved House Bill No. 3968 or the Charter of the City of Carmona



with 19 affirmative votes. Senator Joseph Victor "JV" Ejercito was the bill's principal sponsor in the Senate and chair of the Upper Chamber's local government panel.

"Carmona has all the characteristics of a city but does not enjoy such privilege despite being one of the most prosperous municipalities in the entire country. This bill embodies the hard work, dreams, and aspirations of the people of Carmona," Ejercito said in support of the bill.

The cityhood will provide more opportunities for its people and more investments for its local government, Sen. JV Ejercito added.

The town of Carmona is the first municipality to be converted into a city under Republic Act No. 11683, which amended the Local Government Code of 1991 and made it easier for towns to apply for cityhood. Solidum expressed gratitude to Senator Francis Tolentino for inviting him to the launching of the "Townhall Meeting on Public Policy" organized by KLABARZON, a non-profit humanitarian organization, held at Kawit, Cavite today, February 23, 2023, as this provides a mechanism for national and local leaders to convene and collaborate.

He said that this is vital for promoting regional development and the socio-economic development of the country.

"Itong pagpupulong ay very timely dito sa DOST at sa topic na inassign sa akin kasi po ay mag-lolaunch kami ng 'Smart and Sustainable Communities Program,' hopefully, sa susunod na buwan at kayo po ang unang makakarinig nito sa isang probinsiya," the Secretary gladly introduced.

Aside from refocusing the programs, projects

and activities of DOST to support the socio-economic agenda of the President, he said that the agency is strengthening the collaborations, complementation and synergy within the DOST system, as well as in partnership with other national government agencies. This will help them concentrate their human and financial resources and efforts, and realize the full potential and benefits of science, technology and innovation (STI). The Secretary also

emphasized the advocacy of DOST which is, " Science for the People" and "One DOST for you!"

The "Smart and Sustainable Communities" program that the Secretary introduced will be the consolidation of all the STI initiatives of the department with all the national agencies down to the local government. This means DOST is com-

Through this program, he said the DOST will be offering smarter solutions, approaches and strategies to the key development areas of the country, including agriculture and food security, energy, transportation, health, education and human capital building, among several others.

Sec. Solidum asserted that science, technology and innovation must be utilized for wealth creation, wealth protection, sustainability and promotion of human well-being.

Firstly, wealth creation for an improved quality of life and economic condition of the Filipino people. Secondly, there is a need to protect the wealth we create through developing STI for disaster resilience as an archaeological country that is prone to natural hazards and global warming. Thirdly, sustainability to ensure the continuity of STI initiatives for a better future. And lastly, to maximize the use of STI for enabling a holistic human well-being - physically and mentally healthy, has access to quality education and modern transport systems, lower energy cost, and many alike.

The DOST Secretary highlighted that there is a paradigm shift happening in DOST in terms of doing research and development. From being a peer-centric and publication-driven endeavor to becoming a more society-centric, marketdriven, and impactbased undertaking.

He ensured that DOST will work closer, engage, and encourage more partnerships among government departments, academe, local government and private institutions to collaborate in developing sustainable and more responsive solutions to bridge the science, technology and innovation gaps in the country.

The event was attended by Mayors, Vice Mayors, and officials of PNP and national Government Agency of Calabarzon region.

We are glad that our new partner China Road and Bridge Corporation (CRBC) took on the challenge," said Mr. Raul L. Ignacio, President and General Manager of Cavitex Infrastructure Corporation.

CRBC is a pioneer in the international engineering contracting market in China with a history of nearly 60 years. The company focuses on global civil engineering and construction projects such as roads, bridges, ports, tunnels, railways, municipal works, dredging, and airports. CRBC has been in the Philippines for

nearly 30 years and has done numerous projects in different regions and these projects have stimulated the growth of the region with its quality and on-time construction. The Central Luzon Link Expressway (CLLEX) Phase 1 Package 2, the Estrella- Pantaleon and Binondo-Intramuros Bridge are among them. CIC and CRBC target

to start phase 2 of the

construction for the CAVITEX C5 Link Segment 2 this Q1 of 2023 and aims to open it to the public before the end of the year.

Meanwhile, the construction of Segment 3-B from Sucat to E. Rodriguez (RSG Subdivision), according to the latest project timeline of CIC, is set to begin in the third quarter of the year. CAVITEX C5 Link project is a 7.7-kilometer 2x3 lane expressway that will connect CAVITEX R1 to C5 Road in Taguig.

It is expected to serve 40,000 vehicles per day: reducing travel time to Makati and Taguig from Parañaque City, Las Pinas City, and Cavite Province by forty-five (45) minutes; and decongesting traffic in Metro Manila. Aside from the CAVITEX and its C5 Link Segment, the MPTC's tollways portfolio includes the concessions for the Cavite-Laguna Expressway (CALAX), North Luzon Expressway (NLEX), the Subic-Clark Tarlac Expressway (SCTEX), the NLEX Connector Road, and the Cebu-Cordova Link Expressway (CCLEX) in Cebu.

## Onward to a million homes annually?

he President seemed serious as he reiterated his administration's goal to build at least one million housing units annually during his term of office. He made this statement during a groundbreaking event of the Department of Human Settlements and Urban Development (DHSUD) in Cebu last Feb. 27, 2023.


It was not lost on the President that the housing crisis — a burden of every administration — starts with a 6.5 million backlog in housing units. The DHSUD, led by Secretary Jerry Acuzar, is aware of the task at hand and feels the pressure; but the President is confident in the skills of Acuzar, who was the chair of a major housing developer and builder before being appointed to the post.

The one-million housing goal is a good start in facing this gargantuan crisis. Housing entails the use of so many resources — land, raw materials, utility connections, etc. The DHSUD now has to "balance" its budget, maximizing it to provide the most number of houses, but not to the point of compromising the standards and safety of each unit. After all, what's the use of a house that would be dilapidated or in a state of disrepair in a few years' time?

Even though a great deal of resources would be needed and utilized, the benefits of housing are exponential not only to the individual or a family, but more so for the community, and eventually, the country. According to Habitat for Humanity, housing is important because "it affects everything in a person's life." "Without a house, things that many people take for granted, like raising a family, securing a job, or making a meal, become almost impossible."

"Homelessness and poverty lead to increased rates of family and domestic violence, depression, health issues, food insecurity, child abuse and neglect. All the issues associated with poverty are inextricably linked to housing," the group explained.

Permanent housing, it said, can "relieve economic stress and reduce rates of domestic violence and alcohol dependence. For children, a house means avoiding lifelong poverty. Access to housing means a better chance





to obtain necessities like food, clothing, medicine, and sanitation. The stability of a house gives those in poverty the opportunity to build a decent life for themselves."

In short, "housing is not just a roof over the head, but a solid foundation for the future."

To give credit to the President, he has called on multiple times the need to urgently address the housing crisis. For him, to solve poverty and a lot of social ills, one of its root causes must be tackled first, which is the lack of housing. With the lack of decent housing, this pushes the number of informal settlements — not the most ideal of places to thrive in, especially for the youth, growing families, or the elderly. In that Cebu event, the President noted that the houses that will be built for the poor will also be disaster-resilient, affordable, and near livelihood spots, schools, health centers, and other establishments. He said the government will also build other infrastructure in the area in order to sustain the community.

The one-million goal is commendable and deserves our support as taxpayers. Naysayers, however, may say that this is a lofty ambition, or maybe an illusion considering the difficulty of just building a few thousand housing units. Now, we have to wait and see if the DHSUD delivers on its promise, and makes this goal a reality and not a fantasy.
