

REP. ALVAREZ VISITS BAUERTEK CORP., A LAB TO DEVELOP MARIJUANA TO MEDS

DAVAO del Norte's 1st District Rep. Pantaleon D. Alvarez personally visited the now famous Bauertek Corp. that will soon process the medical cannabis or marijuana once bills on this controversial plant are enacted into law.

Dr. Richard Nixon Gomez, the company's general manager, scientist and inventor led the congressman, his wife and team in touring the medical facility, to show the latter the equipment to be used in the possibility of processing or formulating into medicines and medicinal oil from marijuana.

After being shown and tour of Bauertek Corporation, a research, manufacturing and development facility, the Media Health Forum anchored by veteran radio broadcasters Rolando 'Lakay' Gonzalo and Edwin Eusebio, was likewise conducted in the laboratory cum studio.

Rep. Alvarez strongly believes that the Philippines can be at par with other progressive countries in producing medicines from marijuana extract.

Lipa City Food Manufacturers receive packaging technology, labeling requirements, marketing innovations seminar

Food Manufacturers in Lipa City received a seminar on packaging technology, labeling requirements, and marketing innovations from the Department of Science and Technology (DOST)-Batangas in partnership with the Local Government Unit of Lipa City (LGU-Lipa City) through the City Cooperatives Office held at Lipa City Training Center, May 05.



The seminar aimed to equip the participants with knowledge on packaging technology and innovations, mandatory labeling information for prepackaged food products imposed in the Philippines and abroad, and the science behind innovations in marketing. It was divided into three parts: 1) packaging technology, 2) labeling requirements, and 3) marketing innovations.

The discussion on packaging technology covered the definition and functions of food packaging, factors in selecting product packaging, food packaging materials, packaging material tests, and food packaging techniques. Product packaging innovations were also explained to the participants.

For labeling requirements, concepts discussed were the definitions and objectives of labels, mandatory label information standards in all countries and according to Codex

Alimentarius, parts of the label, and the "Rules and **Regulations Governing** the Labeling of Prepackaged Food Products Distributed in the Philippines." The mandatory label information consists of the following: 1) product name; 2) brand name/trade name (as per consumer act); 3) list of ingredients; 4) net content declaration; 5) name and address of manufacturer, repacker, importer, trader, and distributor and country of origin; 6) lot identification number; 7) storage condition; 8) expiration date; 9) food allergen information; 10) direction/instruction for use; and 11) nutrition facts/ nutrition information/nutritive value, were also explained. Other required information, including alcoholic beverages, irradiated foods, additional information, and language, was expounded during the discussion.

The session on marketing innovations was anchored on analyzing the opportunities digital technology offers in promoting the business and examining the science in digital promotion and communications for improving engagement with the target customers. Topics covered were the basic principles of productivity promotion, principles of digital promotion and strategic communication, how to build a digital marketing and promotion plan, and an introduction to marketing and digital promotion tools.

The discussion also touched on some of the best digital marketing strategies in the Philippines. MSMEs that integrate competitive approaches to increase their visibility, engagement, and reach in social media were used as examples. Tips in driving traffic and penetrating wider social media reach, applied mechanisms to boost online presence organically, relevant digital marketing

ments and the use of medical cannabis is still illegal in their country. The use of the same is also illegal in the Philippines and users are penalized.

However, more and more advocates, including congressmen and senators are pushing for the legalization of the medical cannabis. Alvarez is the author of House Bill 6783 or the Decriminalization of Marijuana, which aims to amend Republic Act No. 9165 or the Comprehensive Dangerous Drugs Act

The congressman is fully supportive of Gomez's move to potentially process the medical cannabis to become pills or medicinal oil.

Among the ailments said to be cured by marijuana medicines include depression, epilepsy, Alzheimer's disease, sleep disorder, anxiety and others.

Resist tying minimum wage with inflation rate

AWMAKERS should resist increasing the minimum wage to counter the high inflation rate. A legislated minimum wage can be harmful because political factors are likely to sway more votes rather than sound economic principles.

votes rather than sound economic principles. Recently, the Senate Committee on Labor, Employment and Human Resources approved in principle a bill for a P150 hike in the minimum wage. At the House of Representatives, members of the socalled progressive bloc filed a bill for a P750 increase nationwide in minimum wage. That proposal would more than double the current minimum wage in Metro Manila, which has the highest rate in the country at P570 per day.

Apparently, some legislators fail to grasp some basic economic concepts, such as the fact that inflation rate speeds up and slows down over time. Wages, meanwhile, tend to stick once they are raised, and they remain high even when inflation falls. Since it is virtually impossible to reduce wages when inflation is low, policymakers should be careful about pegging the minimum wage to match rising inflation.

Fact is inflation has been going down for three consecutive months. The latest figure was for April 2023, when it was 6.6 percent.

That is high compared to the same period last year, when it was 4.9 percent. But economic managers predict that the downward trend will continue.

In a statement, Finance Secretary Benjamin Diokno said, "The recent inflation numbers indicate that we are on track to managing inflation to within target sometime in the fourth quarter, if not sooner, and the near midpoint of the target range of 2 to 4 percent by next year."


Even then, legislators pushing to increase the minimum wage are not backing down. They should be mindful of possibly harming the economy.

Last week, authorities reported that growth is slowing down. The gross domestic product (GDP) grew by 6.4 percent in the first quarter, the slowest pace since the Philippines started recovering from the lingering pandemic in the second quarter of 2021. The first-quarter GDP was the slowest in the last seven quarters.

Increasing the minimum wage now will weigh down firms ahead of an economy that is slowing down. Also, many companies that survived the pandemic are yet to recover from the losses attributed to the impact of Covid-19. Then there are other businesses that have remained shuttered.

Alternatives

The minimum wage should be left to the Regional Tripartite Wages and Productivity Board, where labor and employers are represented. There are other

ways to help those most affected by high inflation.

For instance, lawmakers can look at targeted doleouts, at least in the short run. Clearly, the challenge here is sourcing the funds. But Congress should not pass on that responsibility to the private sector, which still needs help keeping people employed. In the long run, lawmakers can craft bills creating a

In the long run, lawmakers can craft bills creating a more conducive business environment that allows firms to expand. That can increase the demand for labor and can lead to higher wages.

Look at the outsourcing sector, for example. Call centers and similar firms offer relatively higher wages than those in other sectors, as well as signing bonuses and other perks. Competition for labor drives up wages.

There are other factors to consider, like the need to improve the quality of education that creates more

economic opportunities. But the point here is that legislating the minimum wage is not a sound policy and is risky for the economy.

Besides, raising the minimum wage will not help as many people as lawmakers think. Only those in the formal sector stand to benefit, or 16 percent of the 50 million labor force, according to the Employers Confederation of the Philippines. The rest work in the informal sector, which is not covered by the minimum wage law.

Perhaps, Congress should look at incentivizing firms in the gray market to enter the formal sector, where they are required to comply with laws protecting workers. But a higher minimum wage discourages that.

Sure, lawmakers just want to help. In doing so, however, they should avoid doing more harm.

5. If you have diabetes, numb feet or stroke, our advice is to just not get a pedicure. Diabetics have vein (nerves) problems and wounds in their feet may not heal. The foot might be cut off.

6. Be careful when pulling "hangnails" or your skin near the nails. Pulling and bruising is the root cause of finger infection.

First-aid in the Finger Wound:

For severe toe or hand infections, this is what to do.

Buy Povidone iodine, cotton and band-aid. Take a small piece of cotton and put Povidone iodine on it. Lay it on top of the wound for a long time.

If possible use a band-aid to seal cotton with Povidone iodine. Just let your wound soak in Povidone iodine all day. Drop extra Povidone iodine when it dries.



Do this for 7 days, until the skin inflammation is completely gone. When Povidone iodine penetrates the skin, it can kill the wound germs and heal. Just keep taking Povidone iodine until your finger heals.

Remember: Health is more important than beauty. If the finger just gets an infection, it's best no manicure or pedicure. Good luck!

THROUGH a Memorandum of Agreement (MOA), the Department of Science and Technology (DOST) via Community Empowerment through Science and Technology or CEST, empowers lives and builds communities in Region 1.

The MOA signing was held in Don Mariano Marcos Memorial State University (DMMMSU) on May 16 in Sipalang, Bacnotan, La Union. The theme of the event was "CEST: Empowering Lives, Building Communities."
