Maynilad: Daily water interruption in Parañaque, Pasay, Cavite until May 16

MANILA, Philippines - Maynilad Water Services announced that cities of Parañaque, Pasay, and Cavite, will continue to face daily water service interruption until May 16 due to low water production.

Maynilad in an advisory on Tuesday night, attributed the low production level to the turbidity level of raw water in Laguna and a leak in its ultrafiltration valve. "Our customers in portions of Parañaque City, Pasay City, Cavite City, Noveleta Cavite, Rosario Cavite will have water service interruptions daily from April 25, 2023 until May 16, 2023," said Maynilad. As we all know, the Philippines is in the Pacific Ring of Fire, where volcanic eruptions and earthquakes are common.



The DOST- Legislative Liaison Office together with the DOST-Philippine Institute of Volcanology and Seismology held a stakeholders' consultative meeting on April 18, 2023, at the DOST-PHIVOLCS Auditorium in Diliman, Quezon City regarding the modernization bill which is currently filed in the House of Repre-sentatives. 






Bauertek Corp. ready to process marijuana as medicine

Dr. Richard Nixon Gomez, a scientist, inventor and general manager of Bauertek Corporation, recently led members of the media and other visitors in touring the firm's medical manufacturing facility in Guiguinto, Bulacan that will process medical cannabis or marijuana into medicine.

The research, manufacturing and development company will process marijuana to treat various medical ailments, including depression, epilepsy, Alzheimer's disease, sleep disorder, and anxiety, among others

Dr. Gomez said once the bill on medical cannabis is enacted into law, his facility is more than ready to process cannabis into medical tablets and oils.

This, in turn, can be planted with other plants or herbs for food supplement, which are being manufactured by Bauertek Corp. since December 16, 2019, the facility's date of establishment.

Gomez said medical cannabis can be planted in different places in the Philippines.

With the tour of the facility, the same was used as a studio for a live Media Health Forum and for Gomez's live radio program "Kaibigan sa Kalusugan" aired over various radio stations.

His programs also offer free consultation with health lecture on symptoms, causes, complications and intervention of ailments or diseases.

Climate change response must be a development priority

development priority NE of the key takeaways from the annual spring meetings of the World Bank earlier this month was the extent to which the world's largest multilateral development bank (MDB) intends to reconfigure its policies and operations to place an even greater emphasis on climate change response. The rationale is simple and obvious: Climate change affects everything, so any development aspirations must respond to it, even if they concern areas such as poverty reduction, public health, education or fiscal management that may not appear to be relevant to climate change adaptation and mitigation goals.

Masatsugu Asakawa, the president of our region's flagship MDB, the Manila-based Asian Development Bank (ADB), reinforced that message in a recent commentary for Project Syndicate. That commentary takes on added significance as it comes ahead of the ADB's own annual meetings in May, where a planned large-scale revamp of the organization — and by extension, its development and resource allocation priorities — are certain to dominate the agenda.

In his commentary, Asakawa expresses concern that the region and the world is headed for a "doom loop," in which ever-increasing amounts of effort and resources are needed to address the effects of climate change, diverting attention from addressing its causes, and therefore making the problem worse. "Billions of dollars are being invested to avoid this fate, but trillions are needed. Where will it come from?" he writes. "I believe that MDBs must do more, and faster, with the substantial resources that we manage. Simply placing climate action at the top of the development agenda is not enough. The climate crisis demands a dramatic shift in our mindset as development professionals."

The "shift in mindset" is more important for this region than for any other part of the world, Asakawa asserts. "The stakes are highest in Asia and the Pacific. In addition to accounting for more than half of the world's greenhouse-gas emissions, the region is warming faster than anywhere else and is acutely vulnerable to rising sea levels, extreme weather events and biodiversity loss," he explains. "These trends will only escalate if MDBs continue to pursue business as usual."

For countries like the Philippines, where many of the large-scale development goals such as expanding utility and transportation infrastructure, access to health care, transitioning to sustainable energy, and poverty reduction are necessarily dependent on a substantial level of external support, the ADB chief's

message makes a clear point: That support is going to be prioritized for projects and programs that are aligned with the new mindset of the MDBs and other development partners. Every goal the country has must also have the goal of responding to climate change, in whatever manner is applicable to the circumstances, if the government is to receive any help.

And to be clear, the government will need help. As just one example, the "Patubig sa Buong Bayan at Mamamayan" initiative recently introduced by the Local Water Utilities Administration (LWUA) and which aims to expand water and sanitation service to up to 2.4 million more households by 2028 will require an investment of almost P25 billion. The LWUA does not have P25 billion, and as a matter of fact, as a government-owned and -controlled corporation, does not actually receive a budget in the annual General Appropriations Act. Funding from MDBs or other official development assistance (ODA) is going to be necessary, and in order to obtain that funding, the climate change response features of the program will need to be emphasized — and if it doesn't already have them, or have strong enough ones, the program will need to be redesigned accordingly.

The government under President Ferdinand Marcos Jr. has indeed raised the profile of climate response in key policy areas, so the warning, if it can be regarded as such, from the shift in the thinking of the MDBs should not be read as a criticism. But as ADB's Asakawa said, much more can be done. And it has to be, if we are to have any hope of leaving a livable planet for future generations.







ports could be affected by volcanic ash

Meanwhile, the Philippines also lags in earthquake monitoring, with only 117 seismic stations, while Taiwan, which is one-tenth the size of the Philippines, has 194.

In a consultative meeting held on 18 April 2023, at the Philippine Institute of Volcanology and Seismology of the Department of Science and Technology (DOST-PHIVOLCS) headquarters in Quezon City, Director Teresito C. Bacolcol shared all the data and information that would further justify the urgency of the passage of the DOST-PHIVOLCS modernization bill.

The DOST-PHIVOLCS modernization bill aims to modernize the operations of the agency and enhance their ability to provide timely and accurate information, warnings, and recommendations to the public, government agencies, and other concerned stakeholders in the event of natural disasters.

The bill includes allocating funds, which will be around seven billion. for the acquisition and maintenance of state-ofthe-art equipment, infrastructure improvement, research and development, and capacity building of DOST-PHIVOLCS personnel.

In his presentation, Dir. Bacolcol explained the need to strengthen the monitoring systems and capability of DOST-PHIVOLCS.

He said that the **DOST-PHIVOLCS** needs to add more seismic stations in the country to effectively increase the detectability and locate small earthquakes particularly for faults that exhibit low activity prior to large events. In addition, a denser network would help reveal active faults that have no clear surface expressions.

On the other hand, for tsunami monitoring, through this modernization bill, DOST-PHIVOLCS plans to establish at least 50 more stations for tsunami detection for coastal communities at risk to tsunamis, develop effective warning systems, and install sensors offshore close to tsunami sources.

Dir. Bacolcol also said that 21 out of 24 active volcanoes have incomplete hazard maps, putting at risk 28 provinces. Meanwhile, 27 potentially active volcanoes have incomplete hazard maps, putting 17 provinces at risk. He also emphasized that only 38 out of 82 provinces have complete earthquake hazard maps.

"Filipinos would greatly benefit from the passage of this modernization bill. Many of us are aware of the impacts of destructive earthquakes and volcanic eruptions. Casualties, property losses, all of these will be prevented or minimized if we have adequate monitoring equipment across the country. This will greatly help us formulate policy recommendations and guidance to our LGUs and communities," said Dir. Bacolcol.

On the other hand, when it comes to the status of the bill, House of Representatives' S&T Committee Secretary Donald Amado Montes Caballero shared that the

DOST-PHIVOLCS Modernization Bill has already been approved at the committee level. A substitute bill is being consolidated from the 12 measures presented in the House of Representatives. He explained that after this, it will be referred to the Committee on Ways and Means and to the Committee on Appropriations, after which a committee report will be crafted. The bill will then be presented to the plenary deliberations for the approval of the House of Representatives

Loan negotiations for Bataan-Cavite bridge to start in the third quarter, according to the Department of Public Works and Highways (DPWH).

Maria Catalina Cabral, DPWH Undersecretary for Planning and Public-Private Partnership (PPP) Services, said the project would be funded by the Asian Development Bank, with co-financing from the Asian Infrastructure Investment Bank. The four-lane bridge has a project cost of P175.66 billion.

The detailed engineering design of the infrastructure is 78-percent complete. The DPWH expects to commence construction as early as this year.

"We are now finishing the engineering design. Hopefully we'll start the construction late part of this year or early part of next year," Cabral said. The Bataan-Cavite bridge starts from Barangay Alas-asin in Mariveles, Bataan,

crosses Manila Bay and ends in Barangay Timalan, Naic, Cavite. Included in the project is the construction of two navigation bridges: the 400-

meter North Channel Bridge and 900-meter South Channel Bridge. The project is designed to reduce travel time between the provinces to 45

minutes from 5.5 hours It is just one of major infrastructure projects being built in Cavite, which also

includes the \$11-billion Sangley Point International Airport (SPIA). In February, the SPIA consortium inked a joint venture and development agree-

ment with the Cavite government for the airport project aimed to decongest Ninoy Aquino International Airport. Cavite Gov. Jonvic Remulla earlier told the Inquirer they were hoping to hold the groundbreaking ceremony within the year. This would be followed by four years of construction for the first runway and another four years for the second runway.

The Cavite government likewise inked a tollway concession agreement with San Miguel Corp. for the construction of the 27.06-km Cavite-Batangas Expressway. *INO*

LRT-1 Cavite Extension Phase 1 on track for completion by Q4 2024

MANILA – The first phase of the 11.7-kilometer (km) Light Rail Tran-sit Line 1 (LRT-1) Cavite Extension Project is nearing completion, according to the Light Rail Manila Corporation (LRMC), the private operator of LRT-1.



In a statement on Friday, the LRMC said the progress rate for the project has reached 82.7 percent as of March 2023, for both civil and rail system works since it started the construction in September 2019

"The viaduct was completed in February 2022, while the ongoing station construction includes architectural, mechanical, electrical, plumbing, fire protection, and safety works. In terms of the rail system, trackwork, and overhead catenary system installation are almost complete," it said.

The first phase covers 7 km of the 11-km extension, including five stations: new **Redemptorist Station**

(56 percent complete), MIA Station (61 percent complete), Àsia World (51 percent complete), Ninoy Aquino Station (55 percent complete), and Dr. Santos Station (60 percent complete)

LRMC president and CEO Juan Alfonso said all civil and equipment installation works for the project are slated to be completed this year, with a focus on commissioning the entire project's line by nex

"We are optimistic that we can start commercial operations of Phase 1 by the fourth quarter of 2024 as we continue to achieve milestones with our team," Alfonso said.

To date, the LRMC has invested over PHP30 billion in capital improvement projects to upgrade

the existing systems of the LRT-1 and for the construction of the Cavite extension since the operator took over the rail line in 2015.

The LRT-1 Cavite Extension project, a public-private partnership venture that aims to add 11.7-kilometer an Baclaran-Bacoor, Cavite segment to the current 18.1-kilometer train line, will have eight stations.

The new stretch is nected to service up to 800,000 passengers per day and cut down travel time from Pasay City to Cavite from an hour and a half to just 25 to 30 minutes.

The remaining stations between Las Piñas and Niog are scheduled to become fully operational by 2027. (PNA)
