

Maple Grove-GenTri bypass road opens in Cavite

CAVITE Gov. Juanito Victor "Jonvic" Remulla Jr., General Trias City Mayor Luis "Jon Jon" Ferrer 4th, Tanza Mayor Yuri Pacumio, Vice Gov. Athena Tolentino, and Alliance Global Group Inc. Chief Executive Officer Kevin Tan led the inauguration of the Maple Grove-General Trias bypass road on Tuesday, July 25.

The 12-kilometer diversion road, which passes through the Megaworld's 140-hectare Maple Grove township in Barangay Tejero, was built to alleviate the traffic congestion at Tejero junction and give vehicles going to General Trias, Rosario and Tanza an alternative route.

"This diversion road will reduce around 30 percent of the volume of traffic along Tejero junction, especially during rush hour," said Mayor Ferrer, who lauded the Alliance Global Group Inc. and its subsidiary Megaworld Corp. for taking part in the project.

DOST-CALABARZON, OCD-CALABARZON conduct PSCP Tabletop Exercise to ensure continuous service delivery amid The Big One and other looming disasters

Through the collaboration of DOST-CALABARZON's Disaster Risk Reduction Management (DRRM) Unit and the Office of Civil Defense (OCD) CALABARZON, the implementation of DOST-CALABARZON's Public Service Continuity Plan (PSCP) was re-examined in a Tabletop Exercise where unit heads and staff provided inputs about the restoration of their services vis-a-vis the mission essential functions.



The discussion was led by Mr. Randy N. de la Paz, the Chief of Operations of the OCD CALABARZON together with Engr. Jenny Lawas and Mr. Raphael San Antonio of the DOST-CALABARZON'S DRRM Unit, and was held last July 13, 2023 from 10:00AM to 3:00PM at the DOST IV-A Regional Office.

The exercise aims to examine and evaluate unit heads' and process owners' awareness on the existing PSCP of the organization; identify and enumerate vulnerabilities and gaps on inter-operability of existing policies, plans, and procedures/ protocols and address deficiencies on preparedness and response measures; and enable streamlining of decisionmaking processes within and among DOST-CALABARZON key officials based on the existing plans, policies, and protocols.

These objectives are

integrated in the three modules specifically on the pre-activation, activation, and post-activation/ de-escalation of the

When asked what prompted the unit to collaborate and conduct the activity, Mr. Antonio of the DRRM Unit said that it was to cope with the previous action plans for the PSCP which included its testing and maintenance, since the PSCP is recommended to be updated and tested annu-

"The PSCP is very important for our organization to have a clear protocol on what to do during times of disruptive events," Mr. San Antonio added, "It identifies the mission essential functions, processes, and procedures to ensure they can be recovered when normal operations are discontinued in the least possible time while also safeguarding human

DOST-CALABARZON is

also known to provide various laboratory testing and calibration services to its regional and provincial clients. The exercise provided a platform to discuss challenges in this aspect, especially amid disasters.

Ms. Agnes Morales, Senior Science Research Specialist II and the Head of the Regoional Standards and Testing Laboratory (RSTL) of DOST-CALABARZON expressed that awareness of an organization's PSCP is a significant step towards its effective implementation. She also said that such awareness is critical for the continuous operations and service delivery of DOST-CALABARZON's laborato-

OneLab is a network of laboratories aimed at ensuring availability and broadening public access to testing and calibration services at a single touchpoint through an ITbased platform. It uniquely facilitates the seamless laboratory transaction from sample receipt to release of test result as facilitated by the OneLab Referral System.


Meanwhile, Ms. Janice Irene Berris, Supervising Science Research Specialist of DOST-CALABARZON, also emphasized the importance of strengthening linkages and strategies in optimizing the use of the organization's limited resources

PSCP dates back to 2017 when the National Resilience Core Group on MSME Disaster Resilience (RCG) collaborated with DOST and other government agencies such as the Office of Civil Defense in assessing organizational risks and hazards.

The PSCP template was eventually distributed through the NDRRMC Memorandum Circular No. 33 s. 2018.

Jeffrey S. Perez, supervising science research specialist of DOST and Philippine Institute of Volcanology Seismology (PHILVOCS), presented images and history of past earthquake occurrences in Pangasinan. Although the epicenters were not in the province, the province suffered significant damages.

He explained that earthquake epicenter is the point on the surface of the earth directly above the focus. When an earthquake is felt by everyone, it is intensity

Meanwhile, DOST-PHILVOCS science respecialist. search Robelyn Mangahas, explained about tsunami hazards and facts, differentiating tsunami from storm surge.

To generate a tsunami, the earthquake generator where the earthquake occurs must be underneath or near the ocean; cause vertical movement of the seafloor; over a large area and shallow focus earthquakes.

Height of tsunamis can be as high as 12 meters. It is actually a series of waves. The first wave may not be the biggest. Some of the impacts of tsunami include flashfloods. One effect of post-tsunami is destruction of agricultural lands and causing mud thus bringing dirty water.

Ma. Mylene Ms. Martinez Villegas, chief of science research specialist for DOST-PHILVOCS, presented an overview of Disaster Risk Reduction and Management (DRRM).

Another science research specialist II, John Harold Tabuzo, talked about georisk.

<u>Editorial</u>

A healthy citizenry forms the foundation of a wealthy nation he health of a nation's people is its

greatest wealth. Progress and prosperity can only be sustained when the citizenry is healthy and free from diseases. The recent pandemic clearly illustrated that no amount of economic development can compensate for an unhealthy population.

In this context, the 2nd State of the Nation Address (SONA) by President Ferdinand R. Marcos Jr. emphasized the significance of health in building a prosperous and resilient Philippines. His administration's achievements and vision toward a robust healthcare system were among the highlights.

To ensure universal healthcare access for every Filipino, the President announced that the country's healthcare system was "undergoing structural changes." The focus was on increasing the number and capabilities of public health facilities. Notably, over 3,400 projects were completed last year, and 60 specialty centers have been opened, providing specialized medical treatment.

The President noted that he had recently inspected the site of what will soon be a fivehectare multi-specialty center in Pampanga, which will specialize in pediatrics, cardiology, kidney, and cancer treatment. This bodes well for those living in the northern provinces as they do not need to travel to Metro Manila just to avail of excellent medical care.

What was heard by Filipinos is the commitment of the administration for a "better and more efficient PhilHealth." "We are working for a more direct, efficient delivery of services, through integrated primary care providers and networks, in partnership with the LGUs and our partners in the private sector. These shall of course be supported by what is now a better and more efficient PhilHealth."

The President was satisfied to report that over 93 percent of Filipinos are now PhilHealth members, enabling more individuals to access free healthcare services. In fact, PhilHealth's Konsulta package, which includes 20 different medicines and 13 laboratory services, is available for free across over 2,000 Konsulta centers nation-wide, aimed at



helping more indigent families.

Additionally, the government's focus on primary medicines' affordability has had a tremendous impact on ordinary Filipinos. Prices of critical medications have decreased by 40 percent, and 59 essential medications for cancer, diabetes, hypertension, kidney disease, and mental illness have benefited from strategic VAT exemption.

Furthermore, the administration did not forget the sacrifices of the heroes of the pandemic, as it is actively pursuing measures to improve the welfare of medical frontliners, such as doctors and nurses. "To repay the sacrifices of our healthcare workers in public and private hospitals during the pandemic, the Covid health emergency allowance will be distributed to them together with all their pending benefits,"

House of the Representatives and the Senate on the amendment of the Magna Carta of Public Health Workers. The DOH bill version for the said legislation includes ongoing staff work along with salary standardization.

From providing assistance to indigents and optimizing the welfare of healthcare workers, to ensuring affordable and accessible medications for all, the reforms demonstrate a commitment to the well-being of every Filipino.

If these healthcare reforms mentioned in the SONA are effectively implemented, we can wake up to a tomorrow filled with hope and optimism, knowing that a reliable healthcare system exists to support us and our family members in times of need.

DOST hosts forum on geological hazards in Region 1

THE Department of Science and Technology (DOST) hosted a seminar, dubbed "Alerto! Rehiyon Uno: Forum on Geological Hazards in Region 1."



The event was held at the Provincial Training and Development Center in Lingayen, Pangasinan last Thursday, July 20, with the goal of preparing for any hazards and disasters the country would face.

DOST Secretary Dr. Renato U. Solidum, the event's keynote speaker and introduced by Dr. Teresita U. Tabaog, OIC director of the DOST Region 1, Office, said that disaster resilience is the key from science, technology and innovation, in facing major disasters or calamities.

'Through science, we can prevent further losses in lives and damages to properties," the DOST chief stressed, adding that technology and innovations must be used to safeguard economic gains and "most importantly to save lives."

In anticipation of "The Big One" that will possibly hit Manila, Solidum said they don't expect significant damage in Region 1 but it still depends on the place's distance to Manila.

Based on the study of the Japan International Cooperation Agency (JICA), released in 2004, at least 34,000 persons will die while 114,000 will be injured, and 40 percent of residential buildings in Metro Manila will be affected—170,000 houses will collapse while another 340,000 will be partly damaged—and about 500 fire incidents will occur within the first hour of the earthquake.

According to Solidum. "resilience is the ability of a community exposed to hazards to resist, absorb, adapt to, transform and recover from the effects if a hazard in a timely and efficient manner."
