### 'LEGALIZING USE OF MARIJUANA IS SAVING, EXTENDING LIFE'

PUSHING for the legalization on the use of medical cannabis or marijuana intensifies with an expert saying this will save or extend life of the patients.



Dr. John Ortiz Teope, a researcher, critic, political analyst, media practitioner and the secretary general of TIMPUYOG Philippines, said that legalizing the use of medical cannabis has various positive implications. He spelled out TIMPUYOG as an Ilocano word for organization, unity or movement.

TIMPUYOG in refer-

ence to the use of cannabis, was defined as T for timely, I for internationally accepted, M for medical use and not for recreation, P for pedagogy or concept of education, U for uplifting the economy, Y for yielding to decriminalization of the use of cannabis, O for organization to monitor or supervise the use of cannabis and G for giving way to healing of every Filipino who needs treatment for various ailments.

Teope said that their group was established to serve as "think tank and give suggestions" on the aspect of legalizing the use of medical cannabis which has a rough sailing in Congress even when 60 countries have already approved the use of the medical plant, LEGALIZING • 7

### DOST, PEZA

The establishment of KIST parks is integral to the creation of and growth of startups, spinoffs and science and technology-based firms.

On January 24 this year, a Memorandum of Understanding (MOU) was signed by the two agencies. "The parties commit to have participatory, collaborative and inclusive planning and crafting of enabling mechanisms, strategies and policies to support the establishment of KIST Parks in the regions," is among its scopes of collaborations.

For this cooperation, other agencies, institutions, local government units (LGUs), private sector groups and organizations "may be invited to participate when deemed appropriate as mutually agreed upon by the parties."

The objectives of the parks are the following: transform idle lands owned by the Higher Education Institutions (HEIs) into more productive uses catering to STI pur-

poses; serve as a center of excellence where optimal growth conditions for business and innovation, startups and spinoffs are created through the collaboration of the government, academe, business and community.

It also aims to promote and facilitate the commercialization of Research and Development outputs and innovative products of startups and spinoffs, among others. It will open opportunities to business and startups and spinoff companies and will support strategies for skills development, the generation, acquisition, adoption and assimilation of knowledge through sharing and'or transfer of the academe and industry and the promotion of technopreneurship such as startups and spinoffs.

DOST Secretary Renato Solidum, in his message, said that KIST can generate more jobs and create technologydriven innovations. Further, it will encourage those who want to put up new business through the aid of DOST and PEZA.

Among KIST Park services are the following: startup incubation; technical support and product development; financial support from partner banks/ MSMEs/ Angel investors/Venture capitalists; patent services; market linkages, capacity building programs; inhouse spaces for locators; enhanced ICT infrastructure; secure, safe and sustainable commu-

nity. PEZA director general, Tereso O. Panga, for his part said that "together with the DOST, we can do a lot to boost our knowledge, technology inputs and outputs towards enhancing our global innovation and economy."

To support the program, PEZA issued a board resolution entitled "Guidelines for the registration of knowledge, innovation, science and technology (KIST) ecozone and administration of incentives to KIST developers/operators and locators under Republic Act No. 7916, as amended."

### Philippine Space Week: Putting our national 'footprint' in space

Why are we talking about space when we have so many issues to confront on land?" This is perhaps the question on the minds of individuals when they become aware of Presidential Proclamation No. 302. This proclamation, signed last month by the President, declares the "period of Aug. 8 to 14 every year as Philippine Space Week."


The President acted upon the recommendation of the Philippine Space Council, as the date coincides with the enactment of the Philippine Space Act on Aug. 8, 2019. Philippine Space Week, essentially, is aimed at "highlighting the substantial influence of space science and technology applications on the socio-economic development of the country."

"There is a need to promote space awareness, celebrate the significant contributions of Filipinos worldwide in the field of space science, and espouse the value, benefits and impacts of space science and technology applications on the lives of Filipinos," according to the proclamation.

As far as human knowledge is concerned, space is the final frontier because it is truly massive, and no expert here on earth could claim to know all its features. In fact, scientists have observed that the universe spans 100 billion light years across and is still expanding. So, the mystery of space continues to baffle — and excite — humanity.

Space Week is not only exclusive to the Philippines as there is an annual "World Space Week," a worldwide celebration spearheaded by the United Nations from Oct. 4 to 10. According to the UN, Space Week is commemorated to "celebrate the contributions of space science and technology to the betterment of the human condition, educate the public about space activities, and foster international cooperation in space outreach and education."

UN Secretary-General António Guterres has said that it is in our common interest to "preserve the domain of outer space — a province of humankind that benefits us all." The UN noted that the past decade has seen an





"exponential increase in the number of satellites launched into outer space — from 210 in 2013 to 2,470 last year — and mainly by private companies."

"The period was also marked by a rapid expansion in the number of private missions to space, including the first commercial mission to the International Space Station, which took place in 2021," the UN said. "The number of planned private missions for communications, resource activities, space tourism, and science is also rising. While the US has led the sector, many new commercial space companies have emerged in China, India, and Japan."

With more explorations of space, there will be more discoveries and new technologies to unravel. Our country, though a very minor player in space discovery, must not be left behind in all the developments. That's why there is the Philippine Space Agency (PhilSA), a central government agency attached to the Office of the President tasked with addressing all national issues and activities related to space science, technology, and applications. For Philippine Space Week, PhilSA is directed to promote the observance and identify the programs, projects, and activities for the annual celebration.

In the coming years, there will be more progress in the field of space science, space technology, and even space tourism. We have to be sure that we now have plans on how to face this inevitable future when the line between land and space blurs. It is hoped that any discovery will not only benefit Filipinos today or this week, but for infinity and beyond.



#### Handa Pilipinas Expo 2023

At the Handa Pilipinas Expo 2023, the public had the privilege of witnessing 86 groundbreaking technologies conceived and developed by Filipino researchers, engineers, and scientists.

One of these is Project SAFER, developed by the Polytechnic University of the Philippines - Parañaque Campus, it aims to support emergency broadcast and two-way communication in disaster-prone areas. Another one is the GeoRisk Initiative Platform, a digital platform developed by DOST-PHIVOLCS and several government agencies, presented an official platform for sharing and analyzing hazards and climate information, collecting exposure data, and conducting risk assessments.

The exhibit also featured HazardHunterPH, an advanced system providing comprehensive site-specific reports on seismic, volcanic, and hydro-meteorological hazards. Additionally, the Automatic Trash Rake, developed by the DOST-Metals Industry Research and Development

Center (MIRDC), offered an innovative solution to combat flooding caused by excessive garbage in waterways. This fully automated system enhanced flood control operations by efficiently collecting largesized trash along creeks and unclogging drainage

systems. On the other hand, water security concerns were addressed by the DOST-Food Nutrition Research Institute (DOST-FNRI), which introduced lodine Rich Drinking Water (Tubig Talino) to combat lodine Deficiency Disorders (IDD) among Filipinos. This purified or ordinary potable water, mixed with Water Plus 2, aims to improve iodine intake and promote better health.

Handa Pilipinas Expo 2023 also showcased emergency rescue technologies such as UNSINK-ABLE PORTA BOAT (UPB) and the Water Ambulance (UWA), designed to facilitate quick responses in urban rescue operations. Innovations for fire incidents in informal settlements were presented, including the fire blanket and the Fire designed by Trike,

Valenzuela Inventors Producers Society that can prevent fires from spreading in narrow roads.

For families affected by disasters and emergencies, the DOST-Forest Products Research and Development Institute exhibited a DIY bamboo shelter. This 24 sq. m. semipermanent shelter, equipped with electricity and water supply, utilized 90% renewable materials, making it environment friendly.

Notably, Filipino-made technologies were also employed to communicate scientific knowledge effectively. The DRRM Mobile Learning Hub of Muntinlupa City, DOST-ASTI's Kooha application, DOST-PAGASA's Augmented-Reality Terrain-Flood Simulator with Kinetic Sand, and DOST-PHIVOLCS' Earthquake Simulator play the pivotal role in increasing public safety awareness and disaster preparedness.

Sec. Solidum reiterated the importance of reimagining city organization, design, planning, and construction to create smart, sustainable, and livable cities. He emphasized the Philippines' vulnerability to hydrometeorological and geological hazards, which resulted in tragic

Teope was last Monday's special guest in Bauertek Corporation's weekly Media Health Forum held in Quezon City, hosted by veteran radio broadcasters Rolando 'Lakay' Gonzalo and Edwin Eusebio.

Dr. Richard Nixon Gomez, scientist, inventor and general manager of Bauertek Corporation disclosed that only one patient was given a compassionate special permit by the Food and Drug Administration (FDA) to buy medical cannabis from overseas but to this day, hasn't bought yet due to the whopping price of P1.7 million for one patient alone.

Gomez said he had been to Sacramento, California some two weeks ago to tour the facility that produces medicine out of marijuana extract. California was the first state to legalize the use of medical cannabis.

He said that the processes were simple but

there were those levels they are not capable of doing but Bauertek can do, like cloning and tissue culture, which the US facility has to outsource. Other processes include isolation, extraction-all of which Bauertek can likewise do.

Gomez said that many illnesses are covered for treatment by medical cannabis like anxiety, sleep disorder, Parkinson's diseases, cancer, and others.

Teope further explained that enactment of a law legalizing the use of medical marijuana would mean revenues and taxes for the government while generating job or employment for the people.

He also disclosed that there is a proposal of Cong. Luis Raymund Villafuerte of Camarines Sur, for the establishment of Philippine Cannabis Development Authority (PHILCADA) as the sole authority in the management of medical cannabis. The doctor admitted that
