# DA: FILIPINO FARMERS REAPING BENEFITS FROM HIGH PALAY PRICES

Filipino farmers are benefitting from global fears of a rice shortage resulting from the adverse possible impact of El Niño phenomenon, which forced world suppliers to tighten supply in the world market, an agriculture official said on Monday.

"For the longest time, Filipino farmers have always been at the losing end of the rice sector. But now, Filipino rice farmers are enjoying better prices from their fresh harvest, perhaps sparked by global fears of a shortage resulting from the adverse impact of El Niño forcing world suppliers to tighten supply in the world market," Agriculture Undersecretary Leo Sebastian of the Rice Industry Development.

Data from the Department of Agriculture (DA) National Rice Program showed palay prices in March 2023 rose to P17.69 a kilo for fresh and P19.73 for dry. Compared to the same month last year, palay prices were P15.99 for fresh and P18.41 for dry palay.

President Ferdinand R. Marcos Jr. concurrently holds the DA port-

In April 2023, the price of fresh palay was at P17.66 per kilo and for dry palay, it was P20.38,

while in April 2022, the prices were P15.57 for fresh and P17.95 for dry.

The highest posted palay price was in Central Luzon at P22 for fresh palay and P25 for dry, the DA-NRP data showed.

The DA Regional Field Office 3 covering Nueva Ecija, the rice granary of the country, reported that palay prices in April 2023 was at P20.46 for dry palay and P17.64 for fresh. These prices are higher compared to the April 2022 rates, which were at P18.20 for dry palay and P15.67 for newly harvested grains.

In addition, DA Regional Field Office 2 that covers Isabela, another major rice producing province in Luzon, showed the prices of palay in March 2022 were at P18.48 for dry and P15.1 for fresh. For March 2023, palay prices in Cagayan Valley region were at P20.47 for dry and P16.52 for fresh palay.

A separate data from the Philippine Rice In-

dustry Stakeholders Movement (PRISM), comprising rice millers and palay traders, showed both fresh and dry palay prices for the 2023 dry season: Isabela, P18.50 (fresh) and P22.50 (dry); Nueva Ecija, P19.50 and P23.50; Bulacan, P20 and P24; Tarlac and Pangasinan, P18.50 and P22.50; Mindoro, P19 and P23; Leyte, P17.50 and P21.50; Caraga, P19 and P23; Iloilo, P18 and P22; and Davao, P19.40 and P23.40.

According to Joseph Fajardo of the Occidental Mindoro-based Tao Foods Co., his company has been buying palay at very high prices since 2022 from its clustered farmers. Mindoro is one of the provinces where palay prices are at the lowest.

Starting as a seed supplier in Sablayan, Mindoro, in 2022, Tao Foods is now into value chain operations, seeds, credit, technical support and has been carrying out buy-back scheme.

### AFP: CHINA COAST GUARD TO COOPERATE AS PH PLANS **ANOTHER RESUPPLY** MISSION IN AYUNGIN SHOAL

The Chinese Coast Guard was asked to cooperate and not interfere with another resupply mission for Filipino troops stationed in the BRP Sierra Madre in the Ayungin Shoal, a military official said on Saturday.

In a news forum in Quezon City, Col. Medel Aguilar, spokesman of the Armed Forces of the Philippines (AFP), said that the military is committed to ensuring the safety and well-being of Filipino soldiers deployed in BRP Sierra Madre as he mentioned the conduct of another resupply mission.

The supply mission for the AFP personnel is intended to maintain the country's presence in the Ayungin Shoal and to exercise its sovereign rights and jurisdiction based on international law to ensure regional peace and stability.

"Let me add also that we have special message to the China Coastguard for them to behave. They should not do any action that will endanger people's lives. For all the consequences that the singular acts will cause, the blame will be on them and on the authorities above them, so they should behave," Aguilar said in the forum. "They should not interfere with our re-mission."

Aguilar pointed out

that the Avungin Shoal holds a strategic importance for the Philippines and is a vital fishing ground for Filipino fishermen.


Beyond its practical purpose, the roll-on/roll-off (Ro-Ro) mission to the shoal is a clear demonstration of country's resolve to standup against threats and coercion and its commitment in upholding the rule of law.

"As we continue to pursue this humanitarian undertaking and defend our rights [in] our maritime shoals, we also affirmed our support for the peaceful settlement of disputes," Medel told the forum.

"We call on all relevant parties to abide by (their) obligations under international law and respect the Philippines' sovereign rights and jurisdiction over its maritime source," he said.

A resupply mission last Aug. 5 was subjected to dangerous maneuvers by the China Coast Guard firing water cannons to the resupply vessel going to Ayungin Shoal, putting the lives of the crew of the Philippine vessel at

## **Editorial**

### Gov't extends a helping hand to alleviate burden of cancer patients

he scourge of cancer runs deep — it can shatter family ties, derail a promising career, and obliterate the dreams of individuals who now find themselves immersed in the relentless struggle for recovery. There's always the feeling of an impending doom that cancer brings and this is something that even advanced science continues to grapple with.

Irrespective of the variant of cancer, the afflicted individual needs all kinds of support — physical, mental, spiritual, emotional, and especially, financial. No matter the course of treatment prescribed by doctors, the financial toll can be overwhelming, forcing the sick to exhaust their life savings just to procure lifesaving medicines.

Hearing the pleas of cancer patients nationwide, the government is sending a strong response. In a statement, the government is allotting a substantial fund in the proposed 2024 national budget to aid cancer patients. This financial commitment is proof of the government extending its helping hand not merely to offer well wishes or empathy.

"The prevention, treatment, and control of non-communicable diseases, such as cancer, is one of the key priorities of President Marcos, as evidenced by the allocation of ?2 billion in the proposed 2024 National Expenditure Program (NEP)," said Department of Budget and Management (DBM) Secretary Amenah F. Pangandaman.

Pangandaman stated that "18,695 cancer patients will benefit from ?1.024 billion in funds under the prevention and control of noncommunicable diseases, which will cover the procurement of 61 different cancer commodities."

In addition to the cancer control program, ?1 billion will be appropriated to the Cancer Assistance Fund (CAF) to subsidize the continuous medical aid for 6,666 cancer patients registered across 31 cancer access sites nationwide.

The CAF will "partially finance outpatient and inpatient cancer control services. This includes, but is not limited to, therapeutic pro-



cedures and other cancer medicines needed for the treatment and management of cancer and its care-related components." It is a big help as it aims to bridge the financial gap in cancer diagnostics and laboratories, which PhilHealth does not cover.

"When I see these (cancer) patients, especially the kids... I can't help but cry. But I know in my heart that I need to be strong. And I remain strong in finding better ways to give them all the help and support they need," the budget

This is not the first instance where Pangandaman has directed attention to this critical issue. Earlier in the year, during the 4th Philippine National Cancer Summit, she noted that for many years, cancer has been one of the leading causes of death in the country.

'As you may know, many Filipino families, even those in the upper income brackets, are vulnerable to catastrophic health spending due to high treatment costs and limited coverage of cancer care under public programs. Based on 2019 estimates, around 60 percent of the total public cancer expenditures come from out-of-pocket payments and private insurance,' she said. "As such, we should discuss public oncology financing through the advancement of the implementation of the National Inte-grated Cancer Control Act or NICCA with sustainability in mind. Through this, we can provide our fellow Filipinos quality and affordable cancer-related healthcare that would last for many generations."

Considering this valuable — and timely assistance to thousands of cancer patients, the government proves that it is one with the Filipino people in their darkest of times. Through this financial provision, which encompasses treatment and rehabilitation, may each afflicted patient feel the compassionate hand guiding them on their journey to recovery.

With some 10 pending bills in Congress and Senate seeking to legalize the use of the medical herb or marijuana, he said that more and more evidence are gathered indicating its benefits.

Gomez said that the use of the controversial marijuana, should be looked at from a bigger and global perspective as more doctors, experts, scientists, politicians around the world advocate for its use, based on studies. The benefits are for physical, mental and emotional. "Ito ay tinatanggap na ng mga sports, athletic bodies, NBA. Tinatanggap na rin ng Olympics at iba pang athletic bodies at maraming hospital."

To this date, he said around 60 countries and counting, are prescribing the use of medical cannabis to their patients for various ailments.

Dr. Marq Gem Mutia meanwhile said that the use of medical cannabis has been going on for many years and the only "traditional" medicine that was available even during the time of national hero, Dr. Jose Rizal. It was, he said a "mainstream medicine" before its prohibition.

Around 100 ailments and diseases could be treated with marijuana and it was clinically proven for chronic pain, chemotherapy associated with nausea and vomiting, multiple sclerosis and intractable epilepsy.

Dr. Camille Garcia, a clinical psychologist and CEO of the Clinic of the Holy Spirit, said that medical cannabis is also used for Parkinson's disease and Alzheimer's disease. She said that cannabis contains cannabidiol or CBD, which is one of the best medications for various ailments like psychosis, schizophrenia.

Meanwhile, Gomez brought good news to the forum on the status of the pending bills in Congress that led to the formation of a technical working group (TWG) in the Senate. He said, they discussed the contents of the bills and amended some and once done, this would be signed by the bills' authors and will be brought to the plenary for another discussion. It is in this stage that Gomez's group needs the help of various advocates and supporters.

Bauertek is a research, manufacturing and development company in Guiguinto, Bulacan, that has the capability to manufacture medicines from marijuana based on the specific formulation or needs of the patients.

Drs. Garcia and Mutia were guests at the forum hosted by veteran broadcasters Riolando "Lakay" Gonzalo and Edwin Jose Eusebio.



ing on us for a more just, inclusive, and equitable society," said the PCW director.

Supermalls SM through Grace Fornier Magno, SM Vice President for Corporate Marketing, delivered a message of appreciation.

"SM is the largest homegrown company to sign and promote the United Nations' 2030 agenda on gender equality dimensions and sustainable development. In our internal and external activities, we provide women the right platforms, so that they can grow, thrive, and flourish at SM," stated Ms. Magno.

One notable genderresponsive initiative of SM is establishing the Women's International Network on Disaster Risk Reduction which recognizes women leading disaster risk reduction efforts in the Asia-Pacific region.

Moreover, Supermalls is advancing its commitment to advocate the implementation of the Magna Carta of Women and other gender-related laws by signing the memorandum of Understanding between the Philippine Commission on Women.

Based on the PCW's assessment of the implementation of the Magna Carta of Women from 2019 2021, to mainstreaming gender in different sectors is heading north. According to the 2023 gender global gap report, there was a growth in the Filipino female population enrolled and completed their education as well in basic and functional literacy rates.

In the same report, the Philippines ranked 32 in terms of educational attainment with a gender parity score of 0.999

(with 1 denotes to high gender parity rate) covering all the key indicators. Gender parity pertains to the equal contribution of men and women in every aspect of private and public life. Furthermore, an escalation is noticeable in women occupying higher positions and women assuming leadership roles in office administration, peace and order, and politics.

On the other hand, the percentage of teenage pregnancy for women aged 15 to 19 has de-clined from 9% in 2017 down to 5% in 2022 based on the national demographic and health survey.

Gaining legislative support is another landmark to protect girls from sexual abuse and exploitation. Some of the newly passed laws under GAD include R.A. 1156 which prohibits child marriage, R.A. 11648 which raises the sex consent from 12 years old to 16 years old, and R.A.

11930 which is the antionline and sexual abuse of exploitation of children and anti-sexual abuse and exploitation materials Act.

As an 'AlaGAD' silver awardee, the DOST has attained level four (4) commitment enhancement and institutionalization in all entry points of Gender

Mainstreaming Evaluation Framework (GMEF) Organizational Assessment Tool.

"As we institutionalized gender mainstreaming in DOST, we continually build the organizational capacity to attain gendersensitive policies, programs, projects, structures, and procedures," says DOST Secretary Renato U. Solidum Jr. in his message.

The department demonstrates its commitment to gender and development principles through partnership with other agencies in developing and using renewable sources of energy in food production including the development of womenfriendly technologies and providing useful information and gender-sensitive technologies for production, processing, and marketing food products.

Through its attach agencies, DOST continuously provides scholarships and career opportunities for women in science and supports startups through assistance in product development, packaging, marketing, intellectual property, and business guides. Women Micro-Entrepreneurs are also assisted through a resolution that engages **Local Government Units** to support their products.

Furthermore, DOST also established and actively operates its Gender Help Desk and produced and launched the use of DOST GAD KIT and modules in gender mainstreaming. As unified GADvocates, the capacity-building activities on GAD, as well as the GAD Focal point assemblies, were continuously conducted.

"Our department intends to develop science, technology, and innovation policies that empower and support women and men in sustainable development. As ONE DOST, we will fight gender inequality to achieve the change we desire to our gender equality." This was af-firmed by Sec. Solidum Jr., rallying the department to continuously improve their GAD endeav-

There were 18 government agencies awarded the Outstanding Gender-Responsive Agency and Exemplary GADtimpala AlaGAD 2023 having the Commission on Audit (COA) as the sole gold awardee for both categories. ### DOH RECOGNIZES 'MARIJUANA' BENEFITS



NO less than Department of Health (DOH) secretary, Dr. Ted Herbosa, has recognized the benefits of medical cannabis or marijuana. A fast-tracked bill is in Congress for the legalization of its use.

tracked bill is in Congress for the legalization of its use.

Only few are now opposed to the passage of pending bills in Congress seeking to legalize the use of this medical cannabis as medicines. The recently concluded Joint Congressional Committee on Dangerous Drugs and Health unanimously approved that the proposed bills be forwarded to a technical working group, preparatory to submission to the Congress for deliberation during plenary session.

Dr. Marq Gem Mutia, adult medicine specialist and founder of Philippine Society of Cannabinoid Medicine, said it's the first time ever that a DOH chief has recognized the medical cannabis and its benefits "unlike his predecessors."

Dr. Richard Nixon Gomez, an inventor, a scientist and general manager of Bauertek Corporation, the sponsor of the weekly Media Health Forum held every Monday, said the number of those opposed to legalize the use of marijuana, has lessened.
