

LRT-1 completes first test run of Cavite extension

The Light Rail Transit Line 1 on Tuesday completed the first test run of its Cavite Extension Phase 1 project.

The Light Rail Manila Corporation (LRMC) said the initial test featured second generation train sets that ran up to 4.5 kilometers per second.

"The train test run is part of the detailed and rigorous preparations to ensure that Phase 1 of the extension is completed by the last quarter of 2024," LRMC said in a statement on Wednesday. The first test run was conducted to check the compatibility of vital infrastructure components such as the train pantograph, overhead catenary system, train wheels, and rail tracks, the LRMC added.

The firm also said that further test runs are planned in the coming weeks.

The LRMC said that the five new stations under the first phase of the Cavite extension line are in various stages of development. These are: Redemptorist Station, MIA Station, Asia World Station, Ninoy Aquino Station, and Dr. Santos Station. (By CNN Philippines Staff)

DOST-CALABARZON capacitates staff on Technical Writing and Project Proposal Development

To enhance the capabilities of its workforce, the Department of Science and Technology (DOST) CALABARZON conducted a specialized training session focused on Technical Writing and Project Proposal Development last December 11, 2023 at RFSQAC Multipurpose Hall, DOST Regional Office Building. The training aimed to equip staff members with essential skills crucial for effective communication and project formulation.

Under the guidance of Ms. Emelita P. Bagsit, Regional Director of DOST-CALABARZON, the training commenced with a warm welcome extended to participants from various DOST Regional Offices. Ms. Janice Trene F. Berris, Supervising Science Research Specialist of DOST-CALABARZON, presented

the training objectives. Ms. Berris stressed the importance of crafting a strong project proposal and offered perspectives on why and how it could be improved.

She remarked, "Among us, we should be aware that sa proposal dapat pa lang, nagkakaintindihan na tayo before we implement the project. Kasi later on, when we access collecting information on the impacts of what we did, may effect 'yun sa decision-making natin and how we plan sa regional level." Ms. Berris added, "Kasi maaaring maganda 'yung concept

ng proposal natin pero hindi natin na-document ang impact niya properly because we didn't set the right indicators from the start."

The objective of this initiative was to enable DOST CALABARZON staff to better express ideas, fostering improved comprehension, collaboration, and successful implementation of research and development initiatives. Participants gained insights into the art of technical writing, enabling them to simplify complex concepts for better organizational cooperation.

A series of discussions were led by Dr. Ruel Mojica, Professor VI from Cavite State University's College of Engineering and Information Technology. The session focused on providing insights into technical writing, emphasizing the logical structuring and evaluation of project proposals. Dr. Mojica aimed to inspire participants to infuse their proposals with genuine passion and enthusiasm, recognizing that it enhances their quality.

According to Dr. Mojica, "Madali lang mag-sulat, andyan na si AI, pwede tayong humingi ng tulong sa

kanya, pero ang gusto kong i-develop sā bawat isa sa atin is 'yung passion n'yo. Kasi hindi kayo makakasulat magandang proposal kung wala 'dun 'yung puso ninyo." He further added, "Sino ba talaga 'yung gumagawa ng proposal na 'yun? As evaluator, kita ko kung may puso

ang inyong proposal." When asked how he copes with rejected project proposals, he admitted that he hasn't experienced having his proposal rejected yet. However, he advised others to keep pursuing what they want to do despite setbacks. "May mga lesson tayong matututunan sa mga ganyang pagkakataon, kaya diretso lang. Sabi ko nga, kung naniniwala ka project na pinopropose mo, ipaglaban mo, kasi may pupuntahan

pupuntahan 'yan," Dr. Mojica said.

Moreover, the training focused on honing skills in project proposal development, equipping attendees with the expertise to structure proposals effectively, highlight project significance, outline methodologies, and forecast outcomes. The aim was to ensure comprehensive and compelling proposals that increase their potential for securing support

and funding. DOST CĂLABARZON's initiative to invest in the skill development of its workforce stands as a testament to its dedication towards fostering innovation and driving progress. From the third to the last week of December 2023, the toll road company anticipates a 15% to 20% surge in traffic for CAVITEX, primarily from motorists in Cavite heading to Manila. The average daily traffic count is projected to increase to 208,000 vehicles, up from the current 181,000. Meanwhile, for CALAX, MPT South expects a significant 35% increase in traffic, rising to 47,000 from last year's 35,000 figures. This surge is attributed to travelers from Manila going to Tagaytay and nearby cities and municipalities via the recently opened Silang (Aguinaldo) Interchange, providing motorists with quicker access to tourist

The training was graced by the Provincial Director Marivic B. Martinez of the Department of Labor and Employment (DOLE)-Cavite



Jeep modernization: Adapt or perish

he decision of President Marcos last week to stick to the Dec. 31 deadline for consolidating public utility vehicle (PUV) operators is truly commendable. This will finally get the PUV Modernization Program (PUVMP) moving to align the country's public transport with global standards "by providing Filipinos with a system that is safe, reliable, convenient, and environmentally sustainable." This was specifically the goal set when the program was launched in 2017 under the Duterte administration, a plan that has since been delayed by the pandemic and several postponements done whenever transport groups threatened to, or actually launched, disruptive strikes that inconvenienced commuters.

More than a year into the term of Mr. Marcos, Transportation Secretary Jaime Bautista reiterated the need to modernize PUVs, pointing out that this project will strengthen the CASA (convenient, accessible, safe and secure, and affordable) program in the transport sector and generate more jobs, among them mechanics, dispatchers, and administrative staff. Bautista explained that the modernization will also lead to more organized groups with efficient operations, end the inequitable boundary system, and allow drivers to earn more. The modernized jeepneys are also envisioned to have a GPS (a satellite-based radio navigation system used to locate a vehicle), an automated fare collection system, and a CCTV camera.

Benefits of consolidation

According to the Land Transportation Authority, PUVs that have not consolidated by the Dec. 31 deadline shall have their provisional authorities deemed revoked by Jan. 1, 2024. This leaves the PUVs no option but to yield to the modernization program.

Converting the thousands of jeepney drivers and operators into bigger and more efficient organizations is just the crucial first step in revving up the PUVMP. A 2018 study conducted by Joemier Pontawe of the University of Auckland, a licensed environmental (urban) planner here specializing in public transportation planning, and Ma. Sheilah Napalang, professor at the University of the Philippines National Center for Transportation Studies, clearly showed the benefits of consolidation as shown in the case of 1-Transport Equipment Aggregator and Management Inc. (1-TEAM). The fleet management company has been operating with modernized jeepneys since 2014, managing



30 brand new Euro 2 jeepneys of 20 operators that ply five Metro Manila routes. The study said the financial viability of modernizing the current jeepneys will greatly depend on efficient management and operations of the brand-new PUJs, something that is possible only by consolidation.

Biggest air polluters

A highlight is its findings on the impact on operators and drivers: Operators get a higher income while drivers and conductors receive fixed salaries and other employment benefits. It said jeepney drivers benefited the most after the modernization of 1-TEAM's fleet by increasing their monthly net income to P23,000 a month, an increase of P7,000 to P13,000 from their pre-modernization take-home pay of P10,000 to P16,000. But as the study noted, transport groups need support in the form of fleet management and financial literacy training.

The PUVMP is very much delayed, prolonging the sufferings of commuters and the toll on the environment with the jeepneys being among the biggest air polluters with their inefficient diesel engines. It is therefore laudable that the government stood firm to get the program on track. As the President pointed out, "We cannot let the minority cause further delays, affecting majority of our operators, banks, financial institutions, and the public at large." Pursuing the current timeline, he added, "ensures that everyone can reap the benefits of the full operationalization of

our modernized public transport system." In deciding to stick to the Dec. 31 deadline, the President noted that 70 percent of operators "have already committed to [or have] consolidated."

Convert noisy minority

Still, the government has the opportunity to convert the noisy minority by hearing out their side. These transport groups have clarified that they were not opposed to the PUVMP but they want the government to simplify the program and not make it too much of a burden to operators. Surely there must be a way to address these concerns so that the modernization program will be embraced by all.

The so-called Magnificent 7, made up of seven big transport groups that expressed their support for the PUVMP in a meeting with the Department of Transportation last month, has this advice to unconvinced drivers: "We know that this modernization has sowed fear and doubt among our ranks ... We are calling on our colleagues to be openminded to the imminent modernization. This is necessary so that our country can adopt new technologies so that commuters and our public transportation can be safer and more comfortable." The case study of 1-TEAM is a good starting point on how to go about the modernization plan. Groups opposing the modernization must remember that the times, to quote the great musician Bob Dylan, "they are achangin'." Adapt or perish.

Secretary said.

ties. With Congress' theme "Media's crucial role in encouraging agricultural scientific and technological innovations in LGUs," she outlined the various activities DOST 1 is currently doing in the agricultural industry and other sectors

DOST 1 deals with scholars, local government units (LGUs), Micro and Small Medium Enterprises (MSMEs) and other stakeholders. It sees to it that the result of the project is used "for maximum economic and social benefits for the people."

The agency, according to Tabaog, due to its vastness, has sectoral planning councils. Like agriculture which is linked to Philippine Council for Agriculture, Aquatic and Natural Resources Research and Development (DOST-PCAARRD), which identifies what are to be prioritized when it comes to agriculture, aquatic and natural resources.

She recalled that DOST had high performance rating during the time of Covid-19 because of different projects to counter the virus. DOST was linked likewise to the Dept. of Health (DoH) and other institutions.

DOST had projects like testing kits and masks out of bamboo. Tabaog said that other important agencies linked to the department are the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA) and Philippine Institute of Volcanology and Seismology (PHILVOCS)

Meanwhile, the Research and Development Institute (RDI) is where the local technologies come from and the regions transfer these. The Food, Nutrition and Research Institute (FNRI) takes care of technology relating to foods.

DOST has 16 regional offices and 80 science and technology offices.

Another very important project is Šmall Enterprise Technology Upgrading Program (DOST-SETUP) for small businessmen. This offers projects like food processing, furniture, decors and handicrafts, aqua, metals, halal products and services and salt processing, among others.

Applicants' business should have been in existence for at least three years and they should submit documentary requirements. "Now you can see that the govt. investment has impact. Hindi lugi ang gobyerno," Tabaog explained.

To date, Tabaog said DOST has assisted 225

businessmen in 2019 alone and with a total of P162,180,000 and gross sales of over P3-billion.

Another project is the Community Empowerment through Science and Technology or CEST

that empowers lives and builds communities in Region 1.

Another project is NICER or Niche Centers in the Regions for R&D. DOST has lot of other projects in every region.

nities for the country's development.

The DOST has been leading the way in pioneering the advancement that could reform agriculture landscape, she told the audience of PAPI members and DOST officials from all over the country.

On the other hand, PAPI national president, Nelson Santos underscored the huge role of DOST through Secretary Renato U. Solidum, as Press Congress' keynote speaker. The agency, along with Ilocos Norte provincial government and Laoag City were among PAPI partners in organizing the summit.

Solidum in delivering his video message, said that DOST can't stand alone in bridging the gaps between the scientists and the grassroots. "These gaps accelerate communication process and transfer technologies ...," he said. The success of DOST endeavors is into the dealings with the academe in the ability to communicate the significance of science and technology to the Filipino people.

Media people, he said are great allies in DOST advocacies.

Communication as Lifeblood of Progress

Meanwhile, Engr. Sancho A. Mabborang, DOST undersecretary for regional operations, who delivered his speech via Zoom, said "communication and the press play a highly pivotal role in the promotion of science, technology in an era defined by rapid advancegroundbreaking discoveries, the need for communication cannot be overstated," adding that the power of the press can propel the society toward a future enriched by science, technology and innovations (STI)

Communication is considered the lifeblood of progress. The press considered as the fourth estate has an immense power to share public opinion, influence policy decisions and foster an information culture, that values and supports scientific development, according to Mabborang.

As communicators, the press can make complex scientific terms more accessible and understandable by the general public, the DOST official added.

PAPI chairman emeritus Johnny Dayang, recalled how the organization was established in 1974 when there was no media organization yet and there were few newspapers. PAPI to this day, after 27 years, continues to struggle to serve the nation "and
