

Flagship gov't housing program builds new hope for Bacoor families

More than providing safer and more resilient homes, the Pambansang Pabahay Para sa Pilipino (4PH) Program of President Ferdinand R. Marcos Jr.'s administration has provided Filipino families living in danger-prone areas a new hope for a more stable future.

At least 360 families from Bacoor City, Cavite benefitted from the government's resettlement program catering to informal settler families primarily affected by the Supreme Court Mandamus Program in cleaning and preserving Manila Bay.

The Ciudad Kaunlaran in Barangay Molino II is part of the 4PH housing project constructed in two phases: the 880-unit Ciudad Kaunlaran Phase 1 that was divided between nine (9) low-rise buildings and six (6) buildings; and the Ciudad Kaunlaran Phase 2 which is a two (2)-unit low rise housing project comprising of 120 units that is currently in its pre-construction stage.

DTI-Laguna Reminds Service and Repair Shops to Renew Accreditation

Victoria, Laguna - The Department of Trade and Industry (DTI) in the province of Laguna reminds all Laguna-based service and repair shop enterprises to renew their accreditation on or before 31 January 2024 without penalty.



Under Presidential Decree No. 1572 as amended by Article 128 of the Republic Act (RA) 7394, otherwise known as the Consumer Act of the Philippines, no person shall operate a repair and service firm or act as technical personnel therein without first being accredited by the DTI.



The accreditation of repair and service shops and their technical personnel aims to protect the interest of the consumers availing their services. The accreditation, likewise, ensures that the enterprises have the necessary tools, equipment, and facilities and that its technical personnel have the required expertise to provide the services.

In line with this, the DTI Laguna Provincial Office accredits business enterprises engaged directly or indirectly, in the repair, service, or maintenance of motor vehicles; heavy equipment and engines and engineering works; electronics, electrical, air-conditioning, and refrigeration; office machine and data processing equipment; medical and dental equipment; and other consumer mechanical and industrial equipment, appliances, or devices.

DTI will continue to ensure strict compliance of the service and repair shops with the accreditation requirements by conducting regular moni-



toring and enforcement cessed through this link: activities in the province. Cars and motorcycle dealerships are likewise encouraged to have their facilities and services accredited by the Department whether their repair services are offered for free or paid for by their exclusive clientele.

Editorial

Toxic display at mass piety

his year's celebration of the Feast of the Black Nazarene in Manila showed, once more, the strong attachment of Filipinos to some religious rites of the Catholic Church.

Last Jan. 9, approximately 6.5 million people were reported to have participated in the Traslacion (or the transfer of the religious icon from Intramuros to Quiapo Church) that took almost 15 hours.

To that number should be added the devotees in their homes, hospitals, work premises, or other parts of the world who watched the procession on livestream in their gizmos.

President Marcos even declared that day as a special nonworking day in Manila to allow more of the faithful to attend the biggest public religious gathering in the country every first week of January.

The huge number of attendees, who, following tradition, walked barefoot on hot streets from start to finish, may be described as a case of "revenge attendance" because the procession was disallowed by the government from 2021 to 2023 to prevent the spread of COVID-19.

Peaceful and orderlyThe event was marked by numerous attempts by devotees to hold a piece of the ropes that pulled the statue's carriage or to climb it to touch its glass cover in the belief that their action would result in the grant of their wishes.

Never mind that in the process they could get hurt. Their faith trumps any physical suffering.

It helped that the personnel of the Philippine Red Cross were on the scene to provide the needed medical assistance or treatment.

By and large, the procession was peaceful and orderly.

The security measures implemented by the Police National Police, e.g., deployment of a large contingent of uniformed personnel and clearing of street obstructions ahead of time, enabled the sea of humanity to complete the return of the icon to the church with minimal disruptions.

But the otherwise favorable impression on the devotees' display of faith was marred by



the deplorable state of the streets after they had completed their religious mission and left.

Garbage collectionAccording to the spokesperson of Manila Mayor Honey Lacuna-Pangan, a total of 128 metric tons of trash were collected which filled 46 garbage trucks.

They consisted of, among others, single-use plastic bags, bottles, cups, packaging leftovers, soiled diapers, improvised sleeping materials, cigarette butts, and disposable vapes.

It's unfortunate that many of the devotees dumped their garbage on the streets, leaving the job of cleaning after them to the city's sanitary staff.

To the credit of those personnel, as soon as the streets were cleared of people, they collected the trash before they could clog the city's water drains and contribute to the perennial flooding problem in those streets and plastic pollution in Manila Bay.

The lack of discipline of many devotees in handling their garbage is disheartening. It happens every year despite repeated pleas by church and government authorities to dispose of them properly, i.e., put them in designated trash cans or bring them home.

Cleanliness traitNo doubt that if they were in their own house, they would make sure leftover foods are placed in a covered garbage can and recyclable plastic and paper materials are segregated for possible sale to junk shops.

And woe to anybody who dumps garbage near their house. They would raise hell because

they feel their private space had been violated. It's a puzzler that the trait of cleanliness in

garbage that many Filipinos usually observe is forgotten once they're out of their house and have to get rid of personal trash.

When a garbage bin is within arm's reach, there is no hesitation in using it. But if none is in sight or would require taking a short walk, chances are the trash would either be dropped on the ground or discreetly placed at any available space.

It's a reprise of the Dr. Jekyll and Mr. Hyde story. Herculean task Changing the attitude of future participants in the Black Nazarene procession on the handling or disposition of their trash would be a herculean task.

Considering the huge number of devotees involved, there is absolutely no way authorities, no matter how many police and sanitation personnel may be assigned, can effectively enforce the rules on proper disposition of garbage.

All told, the responsibility of maintaining the cleanliness of the premises where the faithful display their religiosity lies solely on their shoulders. The religious character does not excuse that moral obligation.

Remember the saying "cleanliness is next to godliness"? If only its message is taken to heart by future participants in the procession, the Ecowaste Coalition would not have any reason to shake their head in disbelief and disappointment after every such religious event.

tion for a lifelong love of education and success in school and life.

The pandemic caused the suspension of operations of the DDCC for almost three years, which gave way to the facility's rehabilitation. It was relaunched last June 13, 2023 as one of the highlights of the 65th Anniversary of the department. With the partnership with NBS Foundation and other stakeholders, it is now ready to welcome the children again for a fun-packed learning experience.

National Book Store, the country's largest bookstore and supplies store, through its social arm NBS Foundation, will partner with DOST to transform its facility into a learning center by providing books, school supplies, learning materials,

and redesigning the center through activities such as painting murals and donating furniture.

Ms. Torres stated that the DDCC will be the first in the NBS Foundation's initiative to launch a daycare center in government agencies in the country. She added that during the pandemic, their operations in public schools were halted; thus, the idea to establish learning centers in government agencies was conceived to continue providing assistance to children through education.

Ronalyn Aropay was among the 360 new homeowners who personally received their Certificate of Eligibility Housing Allocation from President Marcos Jr. on January 12.

"Of course, I am very happy we got to leave the danger zone. I am now sure that my children are safe," Ronalyn toldshared with the Philippine Infor-Agency mation CALABARZON.

A single mother, Ronalyn raised her three young children as a nail technician in a shopping mall in the city. But as her children grew, so did their needs, prompting her to look for higherpaying jobs overseas.

With the key to their new home tucked in her hands, Ronalyn and her kids will walk to a future as stable and safe as the house handed to them through the 4PH program.

"I am planning to work abroad [to earn more]. So I am thankful that before I leave, I know that my kids are safe, and they have better living [condition]."

Like many fathers who were present during the inauguration of the Ciudad Kaunlaran Housing Project, Ruben Consolacion could not contain his joy and relief as he could soon move his family into a better home.

Ruben, who makes a living for his family of five as a fisherman, used to live with his family near the coast of Cavite province, gathering shellfish like tahong which the city of Bacoor is known for.

"I am very happy. This is a really big help to my family because the house we are now living in is better than the one we used to have."

He is relieved to finally have a home of his own through the 4PH Program, which not only opened doors for better living conditions for his

family but also opened new doors to new livelihood opportunities.

"There are more job opportunities for us because there are more places where we can apply. I am very thankful to President Marcos because this housing program is a big help for us. This new home is also a new life for my family," Ruben added.

"With unwavering loyalty to President BBM and the amended party CBL, we remain committed to ensuring the integrity, effectiveness and transparency of the Partido Federal ng Pilipinas," Verceles stated in his letter to Lagdameo.

Marcos is the party national chairman while Verceles is the national president.

In a separate January 9 letter of Verceles, former Mayor Antono C. Rodriguez, now PFP national secretary-general and national treasurer, Engr. Antonio C. Marfori, they said the Constitutional crisis stemmed with the alleged refusal to leave their positions as former national president, ex-secretary general and former general counsel of Reynaldo S. Tamayo Jr., Thompson C. Lantion and Atty. George S. Briones, respectively.

"Had Tamayo, Lantion

and Briones followed the party Constitution and By-Laws, by conducting an election for party national officers before Sept. 18, 2023, and potentially reelected themselves, the constitutional crisis could have been averted," the trio told Pres. Marcos.

Further the three were accused of concealing the CBL guidelines on the two-year term. Due to the crisis, the former regional chairmen and officers. provincial, city, municipal and barangay officers also lost their standing authority a year before Nov. 11, 2022.

To address the constitutional crisis resulting from the alleged gross negligence of the three party national officers, the party Regional party members, utilizing the residual authority of continuous party membership granted by the party CBL, organized themselves by electing new regional chairmen and officers.

The restored standing authority enabled them to convene a National Directorate meeting promptly followed by the National Assembly on December 14, 2023, both meetings were with a quorum.

Other PFP national officers are Cong. Ferdinand Alexander A. Marcos III, national executive committee chairman; Mayor Antonio C. Rodriguez, National Secretary-General; Engr. Antonio G. Marfori, National Treasurer; Atty. Rudyard A. Avilla III. Counsel; Assam M. Ullangkaya, National Auditor; Gabriel A. Sotto, Vice -President for Luzon; Lorenzo G.
