## Rizal Food Safety Team (FST) conducts Good Manufacturing Practices Training-Workshop for the Rizal Mango Stakeholders Association (RIMASA)

TANAY, Rizal – The Department of Science and Technology (DOST) through its Provincial Science and Technology Office (PSTO) Rizal conducted the Good Manufacturing Practices (GMP) training-workshop for the Rizal Mango Stakeholders Association (RIMASA) last 7-8 March 2024 at the Brgy. Plaza Aldea, Tanay, Rizal.



The Rizal Food Safety Team (FST), composed of various national government agencies (NGAs) at the provincial level from the Department of Trade and Industry (DTI) and Department of Labor and Employment (DOLE), was tapped as the resource speakers for the said training-workshop.

Ms. Jennefer Jeazon Medina, Science Research Specialist II of DOST Rizal and master of ceremonies led the commencement of the program with an opening prayer. She reminded the participants of the proposed flow of lectures and activities to be accomplished within the two-day training. A pretest was conducted to assess the prior knowledge of the participants about the topics to be covered.

The first speaker, Mr.

R-jay M. Salabao, Project Technical Assistant I of DOST Rizal, discussed basic food hygiene and a briefer on the GMP. He ended his presentation introducing one type of food safety hazards—biological hazards. Next, Ms. Duane Mariel S. Juarez, Project Technical Aide I of DOST Rizal, continued the discussion on food safety hazards, specifically on the chemical and physical hazards. To

The participants immersed themselves in their first day group activity, wherein they were able to determine the contaminants and hazards to address the risks and identify preventive measures to avoid such risks from happening. They also participated in another activity which demonstrated the proper handwashing techniques.

The Rizal FST started the second day of the training-workshop by facilitating an interactive game to provide a quick recap of the Day 1 activities. Then, the participants shared their inputs and insights on cross contamination through the second group activity presentation of outputs.

To resume with the lectures, Ms. Niña Sherylle Giron, Supervis-



ing Science Research Specialist of DOST Rizal, conducted a plant layout audit to assess the association's GMP compliance. Mr. Salabao also shared his knowledge on pest control, while Ms. Pascual continued her discussion on the food contact surfaces and raw materials handling. To conclude, Ms. Janine Rivera, Labor and Employment Office II of DOLE Rizal talked about food preparation and personnel hygiene.

Finally, the participants addressed their inquiries through an engaging Q&A and expressed their gratitude to the prompt response on their requested training. A photo opportunity was taken capping the training-workshop.

RIMASA is one of the beneficiaries of the Community Empowerment thru Science and Technology (CEST) Program of DOST. Through DOST's intervention, they were able to process their produces, particularly mangoes. Their processing facility is able to produce mango products ranging from dried mangoes, mango juice, and mango wine. ### To BBM: RE Investments will fail if Energy Industry Gaps are not addressed

President Bongbong Marcos shared that German company WPD GmbH will invest P392.4 billion in the Philippines' expansion of renewable energy (RE). Investments will be funneled to offshore wind farms in Cavite, Negros Occidental, and Guimaras.

While we are pleased to hear about these investments in the development of our RE capacity, these will remain only commitments and not tangible projects if reforms in the national grid and renewable energy development are not undertaken.

At the recently con-cluded 2nd Philippines Onshore Offshore Wind & Energy Storage Summit (POOWESS), held at the Sheraton Manila Bay on March 14-15, investors and developers in the renewable energy industry t voiced their concerns over the development of renewables in the Philippines. Among these are outdated grids that can't utilize the added RE, insufficient training programs for RE projects, and the lack of concrete RE development plans at the national level.

The most glaring is the Philippines' continued use of fossil fuels. The local energy sector is still dominated by fossil fuel generators, despite a coal moratorium passed in 2022. A gas bill is also being pushed to promote fossil gas (liquefied natural gas or LNG) as a transition fuel— that will only cement the dominance of fossil fuel in the energy market and discourage investment in RE.

Pursuing 100% RE is essential to prevent catastrophic global warming. But with coal and gas being allowed to keep the contracts, renewable energy will not grow based on the climate calls of tripling RE by 2030. We cannot make full use of these RE investments until the national government addresses these gaps in the energy industry. Development of renewables must be met with the phaseout of fossil fuels, reforms in renewable energy development, and the modernization of the national grid.

Establishing concrete plans for 100% renewables will also place the Philippines as a staunch global partner in combating climate change.

We call on the national government to raise its ambitions for RE in its energy plan.

Lay out a framework for a just energy transition to 100% renewables by 2030.

Push for a just and managed phaseout of fossil fuels!

### Free trade talks: Foster economic growth, safeguard Filipinos' welfare

he Philippines and the European Union have just announced the resumption of their free trade agreement (FTA) nego-

tiations, marking a significant step in enhancing economic ties between these two economies.

"An FTA with the EU is anticipated to expand market access in goods, services, and investments significantly. It aims to enhance commercial interactions between our business sectors, create valuable opportunities for our service providers, especially our professionals, and establish reciprocal rules and standards," Trade Secretary Alfredo Pascual said during a press briefing in Brussels, Belgium on March 18 (Philippine time), where the resumption of the FTA negotiations was announced.


"We are one step closer to a prosperous new partnership thanks to the EU and the Philippines resuming trade negotiations. A modern, comprehensive and values-based free trade agreement with this fast-growing economy would open new opportunities for both sides, strengthen our supply chains, and promote sustainable trade. It would also deepen ties with a key partner in the burgeoning Indo-Pacific region," said European Com-mission Executive Vice President and Commissioner for Trade Valdis Dombrovskis in the same briefing,


The resumption of free trade negotiations is a welcome development for the Philippines, which has grown to become among the fastest growing economies in Asia.

An FTA would open up new markets for Philippine exporters, allowing them to tap into the vast EU consumer base.

This free trade agreement, once sealed, would also enhance the country's economic resilience as it would diversify trade partners and reduce dependence on specific countries.

It also aims to reduce or eliminate tariffs on goods traded between the EU and the Philippines. This would make Philippine products more competitive in the EU market, po-





tentially boosting exports and the country's economy in general.

According to the European Commission, the Philippines enjoys enhanced trade preferences with the EU under the Generalized Scheme of Preferences plus (GSP+) since December 2014. The special incentive arrangement for Sustainable Development and Good Governance GSP+ grants full removal of tariffs on two thirds of all product categories, aiming to support sustainable development and good governance

Another potential advantage of an FTA is the facilitation of foreign direct investment (FDI) from EU member states into the Philippines.

It would also give the Philippines access to advanced technologies and managerial expertise which are certain to enhance local industries.

But what could be the adverse consequences of an FTA?

An FTA could increase competition from EU products which may challenge some local in-

a monitoring system. "Moreover, this act includes provisions against misuse and abuse, such as the prohibition of recreational use," the former police chief added.

Under Padilla's proposal, a Philippine Medical Cannabis Authority would be established under the Department of Health. This authority would be responsible for crafting a Comprehensive Cannabis Medicalization Plan, establishing regulations for the medical use of cannabis, implementing a monitoring and regulating system for medical cannabis and issuing licenses for registered entities within the medical cannabis indus-


