

Batangueños/Groups call out DENR, DOE, and DOH for ignoring health impacts of LNG amid partnerships with fossil gas giants

Quezon City, Philippines–Concerned residents of Batangas, together with climate groups, and civil society organizations, held a press conference today, May 23, to call on the Department of Environment and Natural Resources (DENR), Department of Energy (DOE), and Department of Health (DOH) to address the glaring health impacts of fossil gas (liquefied natural gas/LNG) in Batangas.

The event was held at Kenny Rogers Roasters, Matalino St., Brgy. Central, Quezon City. Organizations present included the Philippine Movement for Climate Justice (PMCJ), Sanlakas, Oriang, Break Free From Fossil Fuels, Batangas for Health and Clean Air for All, and residents from barangays in Batangas (Simlong, Sta. Clara, Delapaz, Isla Verde).

This demand for a definitive solution to the health crisis comes after DOE and DENR recently partnered with known fossil gas companies First Gen Corporation, Aboitiz Equity Ventures, San Miguel Corporation, and Metro Pacific Investments Corporation, for the purpose of protecting the Verde Island Passage. While this partnership is questionable on how LNG, a fossil gas considered dirty and deadly, can be cleaned so as not to affect the Verde Island Passage and supposedly to alleviate the environmental damages it caused in the province, it completely ignores the impacts of LNG on the surrounding communities' health.

"Maraming nagkakasakit na bata sa mga barangay na pinupuntahan ko," said Wilma Abanil, a health worker from Brgy. Sta Rita. "Kasama na rin doon yung apo ko, na nabuhay pa sana nang mas matagal. Kadalasan ay inuubo o hirap huminga, kaya alam mong may mali rin talaga sa hangin. Sana tulungan kami ng gobyerno para maging ligtas ang mga komunidad namin, lalo na para sa kabataan."

Abanil also participated in the petition earlier in 2023, where residents from five barangays hosting LNG power plants in Batangas called for an impartial health investigation on the impacts of fossil gas, after reports of increased cases of respiratory and cardiovascular diseases. This culminated in the global sign-on campaign, relaunched today, which began in August 2023 to call on the declaration of a public health emergency in Batangas. Despite several followups, the local health office has not shared the results with its constituents.

Dr. Benito Molino of the Philippine Network of Forensics also criticized the lack of health impact assessments (HIA) on the fossil gas plants. "Health Impact Assessment is a MUST in ALL environmentally critical projects. To ensure that the rights of the people enshrined in our 1987 Constitution on a healthy and balance ecology are upheld, a Health Impact Assessment is done before deciding on applications of projects that are critical to the environment."

"For more than three decades, environmentally critical projects like mining and coal plants have been endorsed by the national and local governments and consequently approved by government agencies, primarily DENR without taking into account the health impacts of these projects to the people. Sadly, the Department of Health has no hands in these projects," he added.

These health-sensitive projects also fall under the DENR Environmental Management Bureau's environmentally critical projects. PMCJ called out the DENR's decision to partner with fossil gas companies, the same ones polluting the air with particulate matter and toxic compounds, as a contradiction that betrays the agency's own mandate to protect the environment.

Fisherfolk toiling the waters near the power plants reported fish kills and disruptions to their livelihood, contrary to the environmental protection offered by the government-corporation alliances. "Dumadalas yung inaabutan naming maraming patay na isda sa dalampasigan. Umoonti yung mga huli namin at lumiit din yung mga pwede naming pangisdaan, kaya kailangan naming dumoble kayod o kukulangin yung pang-araw-araw namin," said Irvin Doremon, a fisherman from Brgy. Isla Verde.

In line with this, PMCJ called for the resignation of DENR Secretary Toni Yulo-Loyzaga due to losing credibility as head of the environment department with the mandate to protect the natural resources, after partnering twice with known polluters.

Groups also criticized the DOE's and fossil gas companies' insistence on promoting fossil gas. Larry Pascua, Senior Energy Campaign Officer of PMCJ, said, "Their partnership tries to gloss over the fact that LNG is a fossil fuel that worsens the climate crisis. Its primary emission is methane, which is 80 times stronger than carbon dioxide at warming the planet.

"It also forces us to rely on imports for energy, making it just as unreliable and financially bad as coal. Its damage outweighs its supposed benefits," Pascua added.

Ian Rivera, national coordinator of PMCJ, emphasized, "They keep pushing LNG as a transition fuel, but what they don't say is that it will lock us in with this fossil fuel for decades, preventing us from peaking fossil fuel use by 2025, as emphasized by the Intergovernmental Panel for Climate Change (IPCC) Assessment Report 6 released last year. It also ignores the global agreement in COP28 to triple renewables by 2030."

"We'll be locked in with the consequences of catastrophic climate change, too."

Batangueños, together with concerned organizations, call on the DENR, DOE, and DOH to work together in ensuring holistic protection for the people and environment of Batangas.

Conduct proper health impact assessments and independent investigation on fossil gas operations. Cancel endorsements on upcoming LNG projects and focus on developing renewables.

The people of Batangas and everyone of us deserve clean air, water, and energy.

# Proper garbage disposal will contribute to flood prevention

A t the first-ever National Higher Education Summit held last week, President Marcos declared that "the most important service that government must provide to its people is a good education." Noting that in the recent Times Higher Education's 2024 Asia University Rankings, no Philippine university was among the top 100, he signaled the need to "pursue a comprehensive and all-encompassing strategy that will turn this trend around." He proposed a fourpronged strategy:

First, joint government-private sector collaboration must be enhanced. Government must ensure the strategic viability of private higher education institutions (HEI) "by nurturing policies and support."


Second, government must sustain investments that enable Filipinos from the most needy families to fully attain the benefits of tertiary education. Noting that "of all state expenditures, education delivers the best dividends," he reported that aside from the ?135 billion allocated this year, the government will continue to provide sufficient budgetary support.

Third, "mandates must be attached to merits," which means that the government must continually benchmark performance against global standards and exert efforts to ensure that Filipino students are capable of attaining excellence.

Fourth, he urged stakeholders to explore and develop non-financial areas of action, as well as consider fresh challenges and approaches brought on by the global postpandemic economy.

A noted economist-educator, Dr. Bernardo Villegas of the University of Asia and the Pacific, has expressed the view that the government may need to scale back on establishing state universities and colleges (SUCs) that now number 629, compared to 1,729 private HEIs. "There are 2,095,160 students in





State Universities and Colleges (SUCs) and 2,069,649 in private HEIs, a 50-50 sharing," according to Dr. Villegas.

He notes and proposes: "Part of the funds that can be shifted away from SUCs should be invested in establishing more quality Technical Education and Skills Development Authority (TESDA)-type schools that are more likely to train skilled workers in great demand in the booming sectors of construction, tourism, healthcare, and agribusiness." He also cited the need to enact vital legislation that has been identified by the Second Educational Commission (EDCOM 2) as priorities, namely: Early Childhood Care and Development and Basic Education; Higher Education and Teacher Education and Development; Technical-Vocational Education and Training (TVET) and Lifelong Learning; Governance and Finance. The bills that have already been filed are HB 8559 on Teacher Quality (Amendment of the Teacher Professionalization Act) and SB 2354 (Apprentice Training System Act).

It may be noted that Congress is mindful that the quality of higher education is affected by the quality of basic education, and that a more holistic approach would include consideration of technical-vocational education and training

Finally, President Marcos' call to action deserves the full support of all stakeholders: "Let us mold a new generation of critical thinkers, problem solvers, and visionaries who will realize our aspiration for a new Philippines, a Bagong Pilipinas [and] bring us to a future of growth, opportunity, and prosperity."

Ano na lang ba ang puwede kainin? Puwede naman ang lahat ng gulay puwera sa mga nabanggit ko na. Ang gatas, keso at paminsan-minsan na karne ay pinapayagan din. Ang coffee, tea, gelatin at lahat ng




prutas ay hindi bawal sa gout. Ano ang mga gamot sa gout?

These platforms, accessible via a mobile application, ensure that critical information is always within reach, enhancing the readiness and responsiveness of DRRM officers. Experts from DOST-PHIVOLCS provided hands-on and interactive training, ensuring partici-pants are proficient in utilizing these platforms to their fullest potential.

This capacity-building effort also serves as a pre-cursor to the HANDA Pilipinas Luzon Leg, which DOST Region 1 will host on July 3-5, 2024, at Laoag City, Ilocos Norte, aiming to convene leaders from across the country. The event will showcase the power of collaboration, partnerships, and technology, while also fea-turing various DRRM technologies that can enhance disaster risk management efforts across the provinces.

This initiative from DOST Region 1 demonstrates the impact of visionary leadership and effective partnerships in tackling the challenges of disaster risk reduction management. By leveraging advanced technology and comprehensive training, Region 1 is setting an example that will hopefully be replicated across the nation, contributing to a safer and more resilient Philippines. 


# DOST 1 Champions Full-Scale Disaster Readiness Training Across all Provinces in Region 1
