
### Employers' priority focus: Job generation, adapting to technologydriven environment

day and tomorrow, participants at the 45th National Conference of Employers at the Manila Hotel are focusing on Job Generation in a Technology-Driven Environment. Indeed, technology is the defining element for job creation and employment. Employers are seeking to hire young people who are coming out of college, from age 18 or older, were born in 2006, just past the midpoint of Generation Z, reckoned between 1997 and 2012. Members of this generation are characterized as: "Digital natives with global visions growing up in a hyper-connected world, (they) bring digital fluency and a commitment to inclusivity, reflecting a globalized society."

The convenors have adopted the World Economic Forum concept of Industry 4.0 or the Fourth Industrial Revolution that "represents a fundamental change in the way we live, work and relate to one another... a new chapter in human development, enabled by extraordinary technology advances... (that are) merging the physical, digital and biological worlds in ways that create both huge promise and potential peril."

Such unprecedented changes occurring at a frenetic pace are "forcing us to rethink how countries develop, how organizations create value and even what it means to be human." Going further, Industry 5.0 refers to the interface between humans, robots and smart machines that are working together to achieve enhanced resilience and sustainability. The WEF states: "Where Industry 4.0 focused on technologies such as the Internet of Things and big data, Industry 5.0 seeks to add human, environmental and social aspects back into the equation."

The key to unleashing streams of opportunity is adaptation, that is attainable only through constant mindfulness and agility. In a global environment buffeted by armed conflict as well as stealthy competition in





cyberspace, rewards await those that are capable of embracing dynamic changes in a global environment buffeted by armed conflict as well as stealthy competition in cyberspace.

After five decades, the Philippine economy is still hobbled by the inability to offer enough well-paying jobs that will moderate the outflow of Filipinos into overseas job opportunities.

According to the Philippine Statistics Authority (PSA), unemployment dropped to 4.0 percent as of April 2024. This translates to 2.04 million unemployed individuals versus 2.15 million in January 2024 and 2.26 million in April 2023. On a broader scale, if we were to include all employable Filipinos from 15 years old, the labor force participation rate in April 2024 was one percent lower than the 65.1 percent clip attained in April 2023, but 3.0 percent higher than the January 2024 level. The National Economic and Development Authority (NEDA) asserts that the investment in human capital and infrastructure development are the twin imperatives to creating the quality jobs that fit the bill in both Industry 4.0 and Industry 5.0 scenarios. Beyond improving education, human capital investment covers enhancement in the quality of healthcare and social services. A comprehensive employment generation and recovery masterplan entitled Trabaho Para sa Bayan (TPB) is being drawn up "to address unemployment, underemployment, informal working arrangements, and other labor market challenges."

Finally, support will be provided to micro, small, and medium enterprises and industry stakeholders to ensure that all critical value chain components are covered, and that no one is left behind.

## Sore Throat o Masakit Ang Lalamuman

Mag-ingat Sa Tonsillitis:

Ang sintomas ng namamagang tonsils (mula sa bacteria) ay ang lagnat, sipon, at panghihina ng katawan. Para magamot ang tonsillitis, nagbibigay ang doktor ng antibiotics tulad ng Amoxycillin capsules sa loob ng 7-10 araw.

Kapag hindi naagapan ang tonsillitis, puwede itong magdulot ng rheumatic heart disease, kung saan nasisira ang balbula (heart valves) ng puso at puwedeng umabot sa operasyon. Kaya napakahalaga na magpasuri sa doktor.

Home Remedy:

Para mapabilis ang paggaling ng sore throat, heto ang aking payo:

1. Mag-mumog ng tubig na may asin (warm water with salt). Maglagay ng 1 kutsaritang asin sa isang basong maligamgam na tubig at haluin ito. Gamitin ito para mag-mumog ng ilang segundo. Mababawasan ng tubig na may asin ang pamamaga ng tonsils. Magmumog ng mga 4 na beses sa maghapon.

2. Uminom ng maraming tubig, tsa-a o sabaw.



Uminom ng 8 basong tubig sa maghapon para lumabnaw ang plema.

3. Subukan ang chicken soup o nilagang manok . Ayon sa mga pagsusuri ni Dr. Stephen Rennard ng University of Nebraska, ang chicken soup ay tumutulong sa pag-alis ng pagbabara dulot ng sipon at plema. Pinipigilan nito ang pamamaga ng tonsils at paggawa ng plema (anti-inflammatory). Ang chicken soup ay may sangkap na amino acid, ang cysteine, na lalabas sa pagluto ng sabaw ng manok. Ang cysteine ay nagpapalabnaw ng plema (mucus) sa ating baga, at pinapabilis ang ating paggaling. Ang manok ay mataas din sa protina.

4. Kung masakit ang lalamunan, puwedeng gumamit ng throat lozenges. Ito yung mga candy na nakaka-ginhawa sa lalamunan.

Paalala: Hindi lahat ng sore throat at dahil sa impeksyon. Maaari din magdulot ng sore throat ang hyperacidity o pangangasim ng sikmura. Ang allergy ay puwede din pagmulan ng sore throat. Magpacheck-up sa doktor. Good luck po.



Now is the time for

Congress to conduct a thorough assessment of NEA's oversight role on electric cooperatives and to evaluate the effectiveness of the EPIRA. It is essential that empowered member-consumer-owners of a real electric Cooperative take the lead in finding sustainable solutions. The future of Albay hangs in the balance.

It is time for those in power to prioritize the needs of Albay and resolve the energy crisis immediately, ensuring that sustainable energy is not just a vision but a reality for every Albayanon.




