

# Provincial Council of Women Launches Successful Health Program for Women in Cavite

The Provincial Council of Women, under the leadership of its President, Ms. Anne Ferrer, together with council members, and in partnership with the Office of the Provincial Social Welfare and Development Officer, has successfully conducted a series of comprehensive health program titled "Serbisyong Pangkalusugan para sa mga Kababaihan". This initiative took place across various locations in Cavite, including Alfonso, Magallanes, General Trias, Mendez, Tanza, and Cavite City, throughout the month of June.



The program offered free eye check-ups, CHEM12 laboratory tests, and chest x-rays, ensuring that women in these areas had access to essential health services. These services were made possible through the generous support of Health Ridge Medical Services. Additionally, the Office of the Provincial Legal Officer provided free legal consultations to the public.

The initiative aimed to address the health needs of women, providing vital medical screenings and promoting their overall wellness. The program's impact was significant, with a total of 1,592 beneficiaries receiving the much-needed medical services.

# Misamis Oriental plans to harness over 1.2GW of clean energy for 100% renewables

Villanueva, Misamis Oriental-The provincial government of Misamis Oriental (PGMO) formalized its plans to transition to tripling renewable energy by 2030. Misamis Oriental provincial governor Peter M. Unabia made the announcement at the signing of the memorandum of understanding today with the Philippine Movement for Climate Justice (PMCJ), University of Science and Technology of Southern Philippines (USTP), and the Institute of Power Sector Economics (IPSEc).

Through this partnership, the PGMO plans to unleash the province's renewable energy potenestimated at 1,214.48 MW. This is more than triple of the province's peak demand.

The partnership will also endeavor towards the formation of the **Technical Working Group** and the Renewable Energy Roadmap. The roadmap will serve as the basis for potential investments in the province on renewable energy projects.

Gov. Unabia emphasized the urgency of this transition to renewable energy: "Catastrophe struck parts of Mindanao earlier this year, with one region experiencing drought and the other battered by floods and landslides. These are consequences of the climate crisis, global warming brought on largely by our continued reliance on fossil fuels. Misamis Oriental is not exempt from this threat."

"I am proud to say that we are prioritizing the welfare of our citizens by choosing renewables," he added.

This is also an opportunity to empower local communities and businesses to embrace the choice that is good for them in the long run," said Engr. David Tauli, director and treasurer of IPSEc. "We already have the technology to make clean and affordable energy accessible to citizens of Misamis Oriental, and we will utilize all those resources through this partnership."

Clint Django Pacana of the Think Tank Agropolis stressed "The island of Mindanao comparatively sits on the abundance of

renewables. Tapping into this now, will solve the age-old problem of expensive electricity and the externalities associated with the use of of fossil fuels.

Ian Rivera, National Coordinator of PMCJ, praised the province's consistent support for RE. "Gov. Unabia has been an ardent promoter of renewable energy. It is heartening to see this support materialize in energy development plans for the province, even more so as it aligns with the COP28 agreement to triple renewables by 2030. We are already in a climate crisis, and Misamis Oriental shows that we can fight it."

The PGMO and its partners will undertake the formation of the technical working group in the coming days.

## <u>Editorial</u>

### Preparedness and collective action are keys to disaster resilience

he impact of climate change has become more evident. Heat waves a few months ago affected routine, canceling classes in school, prohibiting outdoor activities, and adjusting the way people went along with their daily schedules. When the rains came, the waters flooded streets and destroyed crops, causing billions of pesos in damage, threatening food security, and claiming many lives.

We are familiar with the scenarios that climate change has brought on. After emerging from a long dry spell of El Niño, we are preparing for the La Nina weather phenomenon. The reality of climate change should by now create a deeper awareness on the importance of resilience, or our ability to recover quickly from disaster.

That is the focus of the Climate Change Commission's (CCC) campaign on the role of climate resilience in safeguarding the Philippines from the escalating impacts of climate change. Its observance of National Disaster Resilience Month is focused on the theme "Bantayog ng Katatagan at ang Pagbubuklod sa Layuning Kahandaan" (Pillar of resilience and uniting for preparedness). Programs emphasize the necessity of proactive measures to enhance the country's ability to withstand and recover from climate-related disasters.

Preparedness is the key to resilience and this requires that individuals stay informed of what's happening around them, especially on community programs that have been designed for dealing with climate change. Being connected to one's community can start with volunteer work. Use this day to find out where you fit in your barangay's disaster preparedness programs.

"Solidarity and collective action are fundamental to climate resilience. Building strong connections with neighbors and community organizations, participating in local volunteer efforts focused on climate-related disaster response and recovery, and spreading awareness about climate resilience through schools, workplaces, and social networks are also important," the CCC said.

The agency's programs also include calls to support climate-resilient infrastructure improvement and the adoption of sustainable practices, including recycling, energy conservation, and sustainable transportation. Any effort to lessen one's footprint on this planet - such as reducing waste - can con-

tribute to sustainable practices. Start with avoiding the use of single-use plastic bags and containers, a situation which confront each of us daily.

The crucial role that local government units (LGUs) will play in the implementation of national climate change mitigation and adaptation plans has been highlighted by the CCC during the recent Eastern Visayas Summit on Climate-Resilient Development. Among the programs discussed were the National Framework Strategy on Climate Change, National Climate Change Action Plan, and the National Climate Risks Management Framework.

The Department of Social Welfare and Development (DSWD) is preparing for a significant initiative next year with its new community-led climate adaptation project under the Kapit-Bisig Laban sa Kahirapan-Comprehensive and Integrated Delivery of Social Services (KALAHI-

Now on its initial planning stage, the program is designed to tackle the dual challenges of poverty and climate change in vulnerable areas, particularly those prone to severe climatic hazards and home to indigenous populations.

Already, the DSWD has reported that the KALAHI-CIDSS has achieved "significant milestones, enhancing community resilience by constructing 1,250 community centers, multi-purpose buildings, and evacuation centers, providing safe havens during disasters." It has also provided 928 units of disaster and pandemic response equipment, and built 3,566 quarantine facilities, re-purposed to manage public health emergencies during disasters.

The government programs to build disaster resilient communities need the support of individuals and families who make up the barangays. Start with a disaster preparedness plan in your household.



To efficiently facilitate the processing and timely payment of capitation through the Auto-Credit Payment Scheme (ACPS), accredited Konsulta Package Providers (KPPs) are reminded to encode health data prior to request for generation of the Statement of Accounts Payable (SAP) to LHIOs.

Although check payment is allowed per Phill-lealth Circular 2024-002 to give KPPs time to set up ACPS, compliance of the newly accredited KPPs will not

Likewise, this is to reiterate that PhilHealth Konsulta Encoders should be guided by the following to avoid delay in the payment of capitation

- · Submit complete documents during the creation of My PhilHealth Portal account.
- Documents for PIN registration of member and undeclared dependents
- should be submitted to the LHIO or the KPP group chat for processing. To register through the My PhilHealth Portal, member should already have PIN. If the PIN is not available, search PIN in HCI Portal (Member Inquiry) or contact PhilHealth Konsulta point person through LHIO for
- Ensure to provide complete data as needed during Account Creation of eKonsulta Encoders.
- During the generation of XML Report, make sure that file will not exceed 2MB. Should there be errors, screenshot then send to the KPP group

he said, adding: "Resilience is moving beyond merely surviving the impacts of disasters. But instead making resilience a way of life, embedded in our households, schools, communities, businesses, economy, and governance."

He pointed out that it is not enough that Filipinos continue to have a pleasant disposition even in the face of destruction or damage.

"In most cases, Filipinos are portrayed smiling after any disaster. Mahilig magpapicture ang mga Filipino kahit mayroong baha pero nakangiti pa rin... this is associated with accepting the worst conditions. However, these norms are a deterrent to achieving resiliency as this leads to lowering the standards for the quality of life that we are supposed to have," he added.

Solidum said the Handa Pilipinas campaign seeks to boost the resiliency of local governments through access to the latest technologies developed by the Department of Science and Technology (DOST) and its partner organizations and presents various forums on disaster mitigation, and locally developed and market-ready technologies for disaster preparedness, response, and recovery.

The campaign likewise aims to elevate the awareness of stakeholders about the technologies that can be utilized to enhance the capabilities of local DRRM offices and equip every corner of the country - from the smallest barangay to the largest city - with the necessary technologies, tools, and knowledge to effectively mitigate, prepare for, and respond to hazards

On February 1, 2024, the DOST-10 team provided the 32 members of the Lampakanay Weavers Association with an electric jigsaw, air compressor, nail gunner, circular saw, and heavyduty sander to improve the association's mass production capabilities and product quality. The assistance significantly increased association's output by up to 400% as of this writ-

Additionally, on April 25, 2024, the group received training on synthetic dyeing from DOST—Philippine Textile Research Institute (PTRI).

This approach empowers the weavers with the necessary skills and knowledge to elevate their craft. The activity emphasized enhancing artisans' skills in synthetic and natural dyeing methods. Through hands-on

workshops, participants learned to harness the dyeing potential of lampakanay.

By infusing their creations with vibrant colors, the selling value of their products has increased by 14.6%

"Pasalamat me ug dako gyud kay gumikan lang sa sagbot nga lampakanay. Daghan ang mga tawo nga nahatagan ug panginabuhi-an bisag sa sulod lang sa ilang panimalay, sama sa mga kababaehan, nga naka tabang sila sa ilang mga bana ug income," said Annie Henon, association's president.

["We are so grateful from that the Lampakanay grass. Many people were given a livelihood inside their especially homes, women, who can now help their husbands earn an income.]

In addition to creating a value chain within their local community, the association actively supports part-timers and working students interested in learning how to make these products and earning an income.

"Ang ginabuhat nako sa akong income kay akong ginabayad sa akong tuition fee ug sa akong projects. Ang sobra ana kay gina tabang nako sa akong pamilya," said Jocelyn Cabansag, 18, a student who works part-time with the association by cleaning the products before the finishing touches.

[What I do with my income is use it to pay for my tuition and projects. I use what is left of it to support my family.]
