



# PCC clears Cavite, SDC deal to develop Sangley airport

The Philippine Competition Commission (PCC) has cleared the Cavite provincial government and SPIA Development Consortium (SDC) deal for the development of the Sangley Point International Airport (SPIA) Project in Cavite.

House of Investments, Inc. (HOI), which is part of SDC, said in a regulatory disclosure on July 23 that it received the PCC resolution on the same day. HOI filed the notification with PCC last March in compliance with the Philippine Competition Act in connection with the proposed joint venture (JV) for the SPIA project.

## Is the Divorce Bill unconstitutional?


f course it is. And this according to the most brilliant and illustrious jurist the country has ever produced, former Chief Justice of the Supreme Court, Hilario G. Davide, Jr. One of the framers of the 1987 Constitution, he minces no words in saying that the House Absolute Divorce Bill or House Bill No. 9349 is deeply contrary to the 1987 Constitution, specifically Section 2 of Article XV on the Family which categorically states that "Marriage, as an inviolable institution, is the foundation of the family and shall be protected by the State."

Implicitly, Section 12 un State Policies of the Constitution also renders the Divorce Bill unconstitutional. It states: "The State recognizes the sanctity of family life and shall protect and strengthen the family as a basic autonomous social institution. It shall equally protect the life of the mother and the life of the unborn from conception. The natural and primary right of parents in the rearing of the youth for civic efficiency and the development of moral character shall receive the support of the Government."

And so is Section 1 of Article XV which strongly provides that "the State recognizes the Filipino family as the foundation of the nation. Accordingly, it shall strengthen its solidarity and actively promote its total development.

And this is where the crux of the matter lies. While the 131 representatives who voted affirmative to the Divorce Bill argued from the seemingly insurmountable domestic problems between a husband and a wife, they seem to have glossed over the bigger cost that the country should pay once the divorce bill is unleashed. If the family, as the constitution recognizes, is the foundation of a nation, destroying one ultimately hammers on the destruction of the majority. In trying to save a molehill, one ends up losing a mountain. Yet divorce is not even the real solution to the problem of the molehill.

Hundreds of studies have shown that divorce did not bring any solution to marital hitches. It worsens and compounds it with succeeding marriages and divorces. While the

destruction is heavy enough for the couple, it is doubly heavier for the children who suffer the most due to marital breakup. Children become consequently susceptible to mental health and behavioral issues, to social and even financial insecurity.

According to a study titled "Divorce and its effects on the development of children," (2010) Lisa Barron of the University of Northern Iowa observed that "the factors involved in the pre and post-divorce relationship are just as detrimental to the children as the divorce itself." She adds that children who are not part of the decision making when it come to divorce become innocent bystanders who have no choice but to become an integral part of an adult issue.

As if separation is not destructive enough, one study says that "a lot of children of divorced parents endure ongoing changes to their family dynamics. The addition of a step-parent and possibly step-siblings can be another big adjustments. And quite often both parents remarry, which means many changes for kids. The failure rate for second marriages is even higher that first marriages. So many children experience multiple separations and divorces over the years." Most of the pro-divorce Filipino argument is premised on the fact that aside from the Vatican, the Philippines is the only country in the world that has not yet legalized divorced. Seemingly, it taunts as it mocks an obstinacy of a laidback religious sentiment. But seriously pouring deeper on all those countries that legalized divorce, one notices that not one of those places have addressed a bit the marital problems they were trying to avoid—or have even improved the psychological and the social damage that divorce has inflicted on children—and therefore, on their society itself.

SDC submitted its unsolicited proposal for a joint venture with the Cavite provincial government to develop SPIA in 2021, after the latter declared as failed the second bidding for the project in October 2021.

SPIA is envisioned as a two-runway airport with annual capacity of 80 million passengers, expandable to four runways that can handle as many as 130 million passengers a year.

The airport project aims to provide a prenot just documents; they represent the collective vision and efforts of each community to drive sustainable and inclusive growth.

mium gateway that will initially serve as an alternative to the Ninoy Aquino International Airport (NAIA) and is designed to meet an expected increase in demand for air transport in the next 30-40 years.

The project includes the construction of a four-kilometer connector road with provisions for rail connectivity, as well as fully-integrated logistics and aviation support facilities.

With the development of the first runway, SPIA can operate as a satellite runway to immediately relieve the extreme congestion of the runway at NAIA.

The consortium said the SPIA development is expected to create 50,000 jobs and be a catalyst project to bring in foreign direct investment.

### PMCJ to PBBM: Act with Urgency! Declare National Climate Emergency, Address the Ongoing Impacts of Climate Change, Invest on Clean and Renewable Energy

Quezon City, Philippines – The Philippine Movement for Climate Justice (PMCJ) demanded Philippine President Ferdinand "Bongbong" Marcos, Jr. (PBBM), to declare a national climate emergency in time for his third State of The Nation Address (SONA) today, July 22 due to the intensifying climate impacts the country is facing.

It has been almost a decade since the Paris Agreement in which countries committed to limit global warming to 1.5C, to prevent the worst effects of climate change, and keep it well below the 2C or the aspirational 1.5C over pre-industrial levels that experts consider to be the outer bound of safety. The United Nations (UN) has since been urging countries to declare a national climate emergency.

PMCJ called out the administration on the continued expansion of coal and fossil fuels, conflicting with the Renewable Energy (RE) Act which prioritizes RE deployment. "While PBBM has already set policies on renewables and even did sortie to attract investments, his administration has conflict over its priorities confusing the public and sending wrong signals to business and market," PMCJ National Coordinator Ian Rivera said.

Through the efforts of national and local civil society organizations in the climate talks, the Philippines is set to host the Loss and Damage (L&D) Fund. Its board was inaugurated in 2023 during the Conference of Parties (COP). PMCJ asserted that now is the strategic moment for us to take the lead in delivering climate funds and commitments in an urgent and timely manner to shape a fullswing transition for a complete system change.

"PBBM could have started strongly to deliver climate actions. His renewable energy push and presence in climate talks sets him apart from his immediate predecessor. However, his cabinet failed to deliver his marching orders. His Environment Secretary is unpopular to the civil society and environment think tanks as she is not consultative and very pro-big business. His En-

ergy Secretary had failed to deliver the executive requirements for PBBM's energy transition program necessary to fulfill climate action and energy security," Rivera highlighted.

"His cabinet is imbued with so much conflict of interest, that if he will not address these will make it hard for him to survive the next half," Rivera added.

The Philippine Energy Plan (PEP) 2023-2050 is projected to rely on fossils predominantly and there is also now a push for nuclear energy. PMCJ stands that these are all false solutions that accelerate energy insecurity and danger to the people as it does not address the immediate need to reduce loss and damage. "The PEP lacks specifics on modernizing and expanding the grid to accommodate additional renewable energy capacity, hindering efforts to mitigate loss and damage," PMCJ Senior Energy Officer Larry Pascua said.

On July 18, the Philippine Senate held a public hearing for the fasttracking of bills that support the development of liquified natural gas (LNG) or fossil gas. PMCJ exposed that these gas bills conflict with PBBM's Executive Order No. 21 which pushes for the use of RE.

PMCJ insisted that the government must get serious in the implementation of United Nations Sustainable Goals which essentially expresses the fulfillment of economic, social safeguards and requirements for the people to have a decent standard of living. But into the second half of his administration, it just failed as it has not arrested the dwindling growth and an economy that should provide for the majority. The group believes that the government must transform the People's Survival Fund,

so that it becomes more accessible, democratic, transparent and can serve the vulnerable sectors of society.

Moreover, Pascua stressed that climate negotiations must compel rich countries and corporations to fully pay for the climate debt they owe for causing climate change and devastating poor and vulnerable countries. As the host of the L&D Fund, PMCJ demands the Philippine government to lead and demonstrate strong political will in making rich polluter countries fulfill their historical, legal, and ethical obligations through delivering adequate climate financial obligations.

The public has been reeling from the impacts of climate change; yet, no national policy has been passed to declare a national climate emergency. Just like many countries who already put in front and center the phaseout of fossil fuels, policies and programs must rationalize its economic and financial factors with the science of climate, to prepare the people for the extreme impacts and move towards just transition," Rivera said.

"But we do not expect that the PBBM government will deliver what has been demanded by people to survive and live through this multiple crises. This is the same kind of government that continues with the same policies. Government that pursues the agenda of big business and the elites pursuing the capitalist system of growth. The people must have to wake up and break this cycle of poverty and oppression. The system that has pushed us into oppression and deprivation is the same system that created this climate crisis. We need to change this system for all of us to survive." RIvera stressed.
