A volunteer from New York deposited \$100 into two accounts under the name George Erwin Mojica Garcia in the Cayman Islands, conclusively verifying their existence. This revelation comes after Garcia had consistently denied having any offshore accounts.

# MOMSHIE women's assoc. in Laurel, Batangas trained in using charcoal briquetting tech for livelihood

Members of the MOMSHIE Women's Association in Laurel, Batangas now have the skills and knowledge to produce charcoal briquettes as a sustainable source of income after a two-day technology training held at their production facility in Brgy. Ticub, Laurel, Batangas, July 29-30.



The training, organized by the Department of Science and Technology (DOST)-Batangas, was designed to transfer the charcoal briquetting technology developed by the Forest Products Research and Development Institute (DOST-FPRDI) to MOMSHIE women's association as their livelihood venture. This initiative also seeks to convert agro-wastes such as coconut shells, husks, and other biomass materials from their community into sustainable

charcoal briquettes. MOMSHIE women members were trained in the operation of machines and the utilization of biomass to produce charcoal briquettes. The training also included demonstrations of burning biomass using a drum kiln, mixing charcoal fines with starch, and molding the mixture into briquettes.

This training is part of the science and technology-based interventions under the DOST CALABARZON's Grantsin-Aid Community-based project for MOMSHIE. Through this project, the association received a complete set of charcoal briquetting equipment, including 4 charcoaling drum kilns, 2 charcoal



briquetting machines, a charcoal fines-binder mixer, and a crusher. They also received funding for packaging and label design development to help them start their own charcoal briquetting business. The goal is to empower MOMSHIE members to generate additional income while promoting sustainable and eco-friendly practices in their community. DOST-FPRDI experts Engr. Amando Allan DM

Bondad, Senior Science Research Specialist; Ms. Angela I. Balais, Science Research Specialist I; and Cheyenne Marqueses, Science Research Assistant, served as resource speakers during the training.

Ms. Rechell De Villa, President of MOMSHIE, thanked DOST-Batangas and DOST-FPRDI for their support and guidance in helping establish their charcoal briquetting business. She expressed their commitment to fully utilize the equipment received to produce highquality charcoal briquettes and contribute to a more sustainable environment. To MEND and Defend: Mauban Unites for Sustainable Development, Climate Justice

Quezon City, Philippines – A powerful alliance was formed last August 4, 2024, as the Philippine Movement for Climate Justice (PMCJ) united organizations and concerned individuals in Mauban, Quezon, to tackle the ongoing climate crisis head-on. The Mauban for Environment and Development (MEND) held a pivotal general assembly, setting a clear course for preserving Mauban's rich legacy, and safeguarding its environmental integrity.



MEND's founding organizations are: Heritage Houses, Unahin Natin Lagi ang Damayan at Pagkakaisa Para sa Maubanin (UNLAD), Marginal Fisherfolks of Daungan (Fisher Folks Alliance), Kapit-Bisig (Labor Group residing on Pantalan Port), Ang Saliwsiw, Yes-Õ (MSEMSAT), KAYA NATIN! Youth-Mauban (Youth Sector), SSLG SSLG, Pastrana, MSEMSAT, The Ridge,

Kabataan Partylist Quezon, Brgy. Luya-Luya, and Mauban MENRO.

"There is a need to organize a multi-sectoral network/alliance that will advocate for environmental protection and climate justice, with a vision and mission of advancing our communities towards sustainable development," PMCJ Luzon Coordinator Erwin Puhawan said.

Like other cities and municipalities, Mauban

faces severe impacts from climate change. "The recent Aghon typhoon is a grim reminder of the reality of climate emergency. The flooding and landslides caused by these typhoons have devastated homes and livelihoods, necessitating immediate and sustained action," MEND Convenor Cedrick Mariano said.

MEND's core values are inclusivity and solidarity, respect for human rights and rights of na-



ture; advocate for climate justice, social and sustainable development; watchdog for good governance; environmental defenders and climate justice advocates; and promote people empowerment and peoplecentered development.

MEND Co-Founder Chit Dy Tan highlighted the urgency of organizing such assemblies and discussions. "Wala na tayong panahon para sabihing, 'Saka na'. Wala na tayong panahon para tanungin kung 'bakit' at 'kailan'. Kailangan na nating kumilos ngayon. Nariyan ang kabataan na nag-oorganisa [...] kaya dapat tayong sumuporta sa kanila." [We don't have time to say, 'Let's just do it tomorrow.'. We don't have time to ask 'why' and 'when'. We have to do it now. The youth are pushing for the organization, so we must support], Ms. Tan said.

Yesterday, August 5, 2024, convenors of the MEND had a consultative meeting with Mauban Municipal Councilor Ken Llamas. He reaffirmed his support for the ongoing fight for climate justice and the transition to renewable energy. Hon. Llamas opened the possibilities of partnerships with PMCJ and other concerned groups, aiming to push for promoting policies in protecting the environment.

"As the climate crisis continues to devastate communities, it is imperative to campaign for climate emergency not just by different climate movements but with local governments leading climate actions and solutions. LGUs have a significant role in mobilizing its constituents, and realizing knowledge and experiences of its residents, who are the primary ones affected by the climate crisis," PMCJ Na-tional Coordinator Ian Rivera said. #MENDMauban #ClimateJustice #RenewableEnergyNow

## Olympic champion Carlos Yulo: Authentic Filipino youth hero and role model

The Filipino nation burst in jubilation as gymnast Carlos Edriel Yulo won the gold medal in the floor exercise in the 2024 Paris Olympics last Saturday, Aug. 3, duplicating the feat achieved by weightlifter Hidylin Diaz when she brought home the country's first-ever Olympic gold medal at the Tokyo games in 2021.


The new Olympic champion also bagged the gold medal in the same event at the World Artistic Gymnastics Championships in Stuttgart, Germany in 2019. A year earlier, he became the first Filipino and the first Southeast Asian gymnast to win a medal in the world championships in Qatar, earning a bronze for his feat. In 2021, he won his second world championship gold medal in the vault event of the competition held in Japan. This was after his debut at the Covid-delayed games in Tokyo.

Carlos Yulo's Olympic odyssey started at the age of seven, as he began tumbling at a playground in their neighborhood on Leveriza street in Malate, Manila. As narrated in published reports, his grandfather brought him to the nearby Rizal Memorial Sports Complex where he trained at the Gymnastics Association of the Philippines facilities.

A year later, he began competing at the Palarong Pambansa held in Tarlac City as a member of the National Capital Region delegation that won the team championship. In 2013, he moved up to junior-level competition where he harvested medals.

Then in 2016, he began training in Japan with support from the Federation Internationale Gymnastique and the MVP Sports Foundation that paved his pathways at the senior level of international competition. He credits his stint in Japan as being instrumental in enabling him to become truly competitive in global contests.

The Filipino youth could learn significant lessons from Carlos Yulo's exemplary athletic career.

Recalling how he fared at his first Olympic competition in which he failed to win a medal, he disclosed that he was deeply disappointed and disheartened — considering that he had painstakingly prepared for the event while enduring the loneliness of being separated from his family and friends. In a video documentary, he said: "I prayed hard for guidance to overcome the loneliness of being abroad, for trust in my coach, faith in God."

Eventually, he said, he realized: "As long as you keep trying, even if you make mistakes, that's achievement and progress." This enhanced his sense of self-worth and self-confidence, noting that "true growth comes from hardship and realizing that your time will come." He thanks his coaches — past and present — including Aldrin Castañeda, who had coached him during his junior days; Gymnastics Association of the Philippines Cynthia Carrion; and Japanese mentor Munehiro Kugimiya.

Indeed, Carlos Yulo's time has come — and he has emerged as an authentic Filipino youth hero and role model. As he basks in the glory of his victory, he stands as a worthy role model for embodying the modified Olympic motto: "Citius, Altius, Fortius – Communiter" and "Faster, Higher, Stronger – Together" that underscores the importance of humanity's solidarity in the continuing quest for excellence.

2. Okra – Sa mga gulay, kakaiba ang epekto ng okra para mapalambot ang dumi. Ang okra ay may malapot na likido na nagpapadulas sa pagdaan ng dumi. Ang balat ng okra ay mataas sa fiber na nagbibigay ng anyo (o porma) sa dumi. Dahil dito, mas bibilis ang paggalaw ng dumi. Piliin lamang ang okra na wala pang 4 na pulgada (4 inches) para malambot pa ito kainin.

3. Oatmeal – Puwede kang kumain ng isang tasang oatmeal sa umaga. May sangkap itong beta-glucan (isang soluble fiber) na nagtatanggal ng kolesterol



sa ating katawan at makatutulong din sa pagdumi. 4. Yogurt – Ang yogurt ay may taglay na mabuting bacteria (good bacteria) na may benepisyo sa ating tiyan at bituka.

5. Tubig – Napakahalaga ang pag-inom ng sapat na tubig para sa mga nagtitibi. Ang mga pagkaing mataas sa fiber, tulad ng gulay, prutas at oatmeal, ay kailangang humalo muna sa tubig para maging malambot ang dumi. Subukang uminom ng 8 hanggang 10 basong tubig o likido sa maghapon. Kapag kulang ka sa tubig, siguradong titigas ang iyong dumi.

May iba pang pagkaing mataas sa fiber tulad ng brown rice. Pero kung hindi ka sanay sa pagkain nito ay baka magtae ka naman. Dahan-dahanin lang muna ang pagkain nito para masanay ang iyong tiyan. Sana ay makatulong itong mga payo para malunasan ang iyong pagtitibi. Good luck.




