## From Marikina to Ilocos Norte's first leather success with DOST 1

IN the culturally vibrant province of Ilocos Norte, a remarkable story of entrepreneurial achievement has emerged.

Niña Leather PH, founded by Niña Angelica C. Matias, stands as the first leather production firm in the province, a pioneering venture in an area previously unexplored for leather craftsmanship.



Nina's journey began in Marikina, a city renowned for its high-quality leather goods. Working as a corporate employee, she frequently bought Marikina's leather products as "pasalubong" for her loved ones in Ilocos Norte. This deep

vere challenges, as the non-essential goods sector suffered a decline. In response, Niña adapted by producing "inabel" masks in collaboration with local weavers, supporting her staff and community during a difficult time.

## Toledo Residents Protest TVI Coal Plant Expansion

**Toledo City, Cebu – More than 70 residents in Barangays Bato, Awihao, and Daanlungsod—including seniors and first-time protesters, braved the rain and police surveillance to voice their opposition to the expansion of Aboitiz Power's subsidiary Therma Visayas, Inc. (TVI). The residents submitted a petition to TVI, urging the company to comply with the law by conducting Health Impact Assessments (HIA) for the project.**

"Toledo City is already home to eight coal power plants, the community cannot bear another power plant without knowing the long-term impacts on our health and environment," said Estela Patalinghug, Visayas Coordinator of the Philippine Movement for Climate Justice (PMCJ). "We demand that Aboitiz Power start putting people's health over profit," she stressed.

The protest, organized under the broad multi sectoral anti-coal alliance called Citizens of Coal Communities for Clean Air and Climate Justice (C4CJ), with the Philippine Movement for Climate Justice (PMCJ), submitted a four-page petition to TVI during the protest. Earlier this month, a recent revelation from the Department of Health (DOH) showed that TVI has not submitted the required HIA for its planned third coal power plant. The HIA is mandatory under Section 33 of Republic Act 11223 also known as the Universal Health Care Act.

Under Section 33 of the Universal Health Care Act, a HIA is required for projects posing significant health risks. Joint Administrative Order

(JAO) 2021-0001 by the DOH and the Department of the Interior and Local Government (DILG) further specifies that projects classified as "environmentally critical" by the Environmental Management Bureau (EMB), such as coal power plants, are also considered "health-sensitive" and must undergo an HIA.

However, the petition submitted to TVI was mishandled by the security guards with the receiving guard merely writing "received" without noting the date, time, or recipient's name. No proper coordination details were provided, leaving the residents with no official channel for a response.

"This incident reflects how the power firm handles feedback from its host communities," said Estela Patalinghug, the Visayas Coordinator of PMCJ. "TVI is owned by Aboitiz Power, one of the largest power generators in the country with coal accounting for more than 68 percent of its energy mix compared to 21 percent from renewables. Patalinghug stated that while Aboitiz Power readily assures business groups their power needs, it remains

silent on the communities' demands to comply with the law and conduct health impact assessments for its existing power plants and expansion project.

Lito Vasquez, PMCJ's Senior Executive Officer on Health Impacts added: "Health considerations are not part of Aboitiz's power equation. The company plans to construct a new power plant in Toledo, Cebu within the next three to four years without ensuring compliance with the HIA mandate under the law. Vasquez emphasized that health impact assessments must be conducted to evaluate the cumulative health and environmental impacts typically associated with carbon and toxic gas emissions, heavy pollutants and other water pollutants generated by coal-fired power plants." The Toledo residents are determined to continue their fight. "We won't stop until we put an end to coal," said Vasquez. "Our health and environment are at stake."

The protests will continue until TVI and Aboitiz Power comply with the law and prioritize the well-being of the community.



appreciation for Marikina's craftsmanship inspired her to bring the tradition to her hometown.

In 2016, Niña took a leap of faith and founded Niña Leather PH in her garage. She devoted herself to mastering every aspect of leatherworking, from cutting and stamping to sewing. The business thrived, leading to an increased demand that necessitated hiring additional staff and expanding production capabilities.

However, the COVID-19 pandemic posed se-

As the pandemic waned and demand for her products surged again, Niña Leather PH faced a critical need for expanded production capacity.

This was when the Department of Science and Technology Region 1 (DOST-1) came to their aid. Recommended by Sir Lawrence from T-Shirt Factory, a DOST SETUP beneficiary, Niña Leather PH was introduced to DOST 1-PSTO Ilocos Norte, under the guidance of Provincial Director Benjamin S. Mercado.

The DOST's Small Enterprise Technology Upgrading Program (SETUP) provided vital support through assessments, energy audits,

The impact of DOST 1's support was transformative. Niña Leather PH achieved a 22 percent increase in production, a 6 percent boost in productivity, and a 22 percent rise in sales. Their client base expanded by 13 percent, reaching not only within the province but also nationally and internationally. The firm also contributed to the local community by hiring single parents and elderly individuals and creating valuable employment opportunities.

Niña has said she is grateful to DOST 1 for their crucial role in the firm's growth and encouraged other entrepreneurs to leverage the opportunities provided by DOST.

## Editorial

### Let's all join fight vs dengue

**D**engue cases in the country have increased by 68 percent. This was revealed by Health Secretary

Teodoro Herbosa and that should prompt everyone to act against this mosquito borne disease with a sense of urgency.

To effectively combat dengue, a comprehensive and coordinated approach involving the government, private sector, and the public is necessary. It hinges on robust vector control strategies. The World Health Organization (WHO) recommends an integrated vector management approach, which includes chemical control, biological control, source reduction, and personal protection.

Chemical control involves the use of insecticides to reduce mosquito populations through space spraying, residual spraying, and larviciding. The National Institute of Health defines larviciding as the process of applying pesticides to water to kill mosquito larvae and pupae before they can mature into adult mosquitoes.

Biological control, on the other hand, utilizes natural predators like fish and copepods, and bacteria such as *Bacillus thuringiensis israelensis* (Bti) and *Wolbachia* to control mosquito populations.

Another vector control strategy is source reduction. This involves eliminating mosquito breeding sites by removing or covering water storage containers, proper disposal of solid waste, and cleaning gutters and drains. Another measure is personal protection like using window screens, mosquito nets, repellents, and protective clothing to prevent mosquito bites.

In this battle against dengue, the government must lead the charge by engaging in public awareness campaigns, enhanced surveillance, infrastructure improvements, and research and development.

Public awareness campaigns may include a nationwide drive to educate the public about dengue prevention and control measures. The government should also strengthen dengue surveillance systems to quickly identify and respond to outbreaks. Quick response is key



in the prevention of dengue.

Another step is the improvement of infrastructure like investing in better waste management and drainage systems to eliminate breeding grounds for mosquitoes. Research and development is another vital measure the government should take. It may include supporting research into new vector control technologies and dengue vaccines.

The government cannot do it alone. This is why the private sector can play a crucial role in this battle.

The private sector must include in its corporate social responsibility (CSR) programs initiatives that focus on dengue prevention and community health education. Ensuring workplace safety is another key factor in combating dengue. Making workplaces free from mosquito breeding sites and providing employees with information and resources to protect themselves are vital. The private sector can also collaborate with the government and non-governmental organizations (NGOs) to support large-scale dengue control projects.

In this battle, every individual has a part to play. Regularly cleaning and covering water containers, disposing of waste properly, and ensuring there are no stagnant water sources around the home are simple yet important steps. Using mosquito repellents, wearing long-

sleeved clothing, and installing screens on windows and doors are measures to protect against dengue. Participating in community clean-up drives and spreading awareness about dengue prevention measures could help in the campaign against the deadly mosquito-borne disease.

To strengthen the government's campaign against dengue, it may do well for the Department of Health to visit best practices around the world.

For instance, Singapore is known for its rigorous vector control program that employs a combination of public education, strict enforcement of anti-mosquito regulations, and innovative technologies like Gravitraps to monitor and reduce mosquito populations.

On the other hand, Brazil and Australia use the *Wolbachia* method to reduce the population of *Aedes aegypti*, a strategy that has shown promising results. The strategy involves the release of *Wolbachia*-infected mosquitoes, which are less capable of transmitting dengue and has been proven to be a successful strategy.

The fight against dengue requires a concerted effort from all sectors of society. By implementing these strategies and learning from global best practices, we can significantly reduce the incidence of dengue and protect our communities.

**On Entrepreneurship and Local Innovation Program Management Development**

Mr. Christopher Lenorad T. Casinillo, Senior Trade Industry Development Specialist from the Department of Trade and Industry—X (DTI—X), provided a directory of R&D products and mature technologies in Northern Mindanao ready for industry adoption. There are 110 locally developed technologies in the region, of which 53 are ready for adoption. The first day of the benchmarking activity commenced at Batangas State University's Command Action Center. Led by Mr. Ibrahim S. Panalangin, the MOST-BARMM delegation was introduced to DRRM technologies, including the WISER GUIDE, Digital Twin, and the innovative SIGAW (Solar-Powered Isotropic Generator of Acoustics Wave) system. Engr. Albertson D.

Amante, Vice President for Research, Development, and Extension Services, along with other university officials, showcased the ACTION Center's best practices and ongoing projects.

The BARMM team expressed particular interest in the SIGAW technology and the Master in Disaster Risk Management curriculum, viewing them as potential assets for enhancing information

The benchmarking activity concluded with a tour of the MIS Server Room, providing the delegation with insights into the technical infrastructure supporting the region's DRRM initiatives.
