DOST R02 Strengthens Efforts Against Online Exploitation Through RA 11930 Webinar

In line with the nationwide observance of the 18-Day Campaign to End Violence Against Women and Children (EVAWC), the Department of Science and Technology (DOST) Region 2, led by Regional Director and Regional Gender and Development Committee (RGADC) Chairperson Dr. Virginia G. Bilgera, conducted a webinar on Republic Act 11930 today, November 27, 2024.

This is also otherwise known as the Anti-Online Sexual Abuse or Exploitation of Children (OSAEC) and Child Sexual Abuse or Exploitation Materials (CSAEM) Act. This law strengthens protections against online sexual exploitation and abuse of children.

In her recorded opening message, Dr. Bilgera emphasized the significance of this year's EVAWC theme, "UNiTED for a VAW-free Philippines," highlighting the collective responsibility to eliminate violence and build a just society. She called for intensified efforts to address the alarming increase of online exploitation, em-

phasizing that the fight against violence must begin at homes, in workplaces, and within communities.

"Ang laban kontra karahasan ay isang laban para sa dignidad at Karapatan ng lahat. Sama-sama, magagawa nating lumikhang mas ligtas na kinabukasan arsa ating mga kababaihan at kabataan," she underscored.

Atty. Cecilia M. Lazaro, Chief of the Legal Division at the Commission on Human Rights Region 2, led discussions on the provisions of RA 11930. She emphasized its role in fostering collaboration among parents, educators, law enforcers, and

community leaders to safeguard children.

The webinar provided DOST R02 employees with essential knowledge on the implementation and enforcement of RA 11930, as well as practical steps to help create a safer online environment for children. It also served as a platform to discuss how institutions and individuals can work together to combat these crimes.

This activity is part of DOST R02's initiatives under the EVAWC campaign, reaffirming the agency's commitment to promoting safety, equality, and a violence-free future for women and children.

Editorial

Continue reforms to transform PH as premier investment hub

President Marcos, in a meeting with Canadian Minister of Export Promotion, International Trade, and Economic Development Mary Ng, has pitched the Philippines as an attractive business hub, underscoring the country's ambition to become a leading investment destination.

To make this vision a reality, the Philippines must implement strategic measures to enhance its business environment and attract Canadian businessmen and other foreign investors.

One of the significant steps the country has already taken to improve its investment climate is the signing of the Corporate Recovery and Tax Incentives for Enterprises to Maximize Opportunities for Reinvigorating the Economy (CREATE MORE) Act, which amended CREATE Act to further ease doing business in the Philippines. This landmark law is a crucial part of the government's strategy to ease the burden on businesses and attract foreign investment. By lowering the corporate income tax rate from 25 percent to 20 percent, the law signals the government's intention to make the Philippines a competitive player in the region. It also introduced incentives for businesses that engage in strategic activities, offering tax breaks and other privileges to industries such as energy, manufacturing, IT, and tourism. For instance, CREATE MORE also increased the deductions for power expenses from 50 percent to 100 percent.

The signing of the CREATE MORE Act is a step in the right direction. However, additional efforts are necessary to solidify the country's position as a business-friendly and investment-ready nation.

The passage and the eventual signing of the proposed Green Lane for Strategic Investments Act, which has already hurdled the House Ways and Means Committee, is crucial. This proposed legislation seeks to expedite the processing of permits and licenses for strategic investments, ensuring that high-value projects receive timely approvals. By establishing dedicated "green lanes" in government agencies, the Philippines can significantly reduce delays and enhance investor confidence.

Strengthening digital infrastructure is another vital step to enhance the potential of the country as an investment hub. A robust digital infrastructure is essential to support modern business operations. Enhancing internet connectivity and digital services will facilitate smoother transactions and communication for both local and foreign businesses.

Improving transparency and governance is an



other crucial measure. Ensuring transparency in government dealings and minimizing corruption are vital to creating a trustworthy business environment. Implementing stringent anti-corruption measures and promoting good governance will attract more investors.

Beyond legislative reforms, the Philippines can offer various incentives to attract foreign investors.

Providing tax breaks, reduced tariffs, and other fiscal incentives can make the Philippines more appealing to foreign businesses. These incentives should be targeted at sectors with high growth potential and strategic importance.

Expanding and enhancing special economic zones (SEZs) can provide businesses with favorable conditions, such as tax exemptions and simplified customs procedures. SEZs can serve as hubs for innovation and industrial growth.

While the country has a skilled workforce, investing in education and vocational training programs will further develop this and ensure a steady supply of

skilled labor. A well-trained workforce is a significant draw for companies looking to establish operations in the country.

For Canadian investors in particular, the Trade Commissioner Service of Canada has identified agriculture and processed foods, defense and security, education, information and communications technologies, infrastructure, mining, and sustainable technologies as sectors in the Philippines where they have greatest opportunities.

To realize the Philippines' goal of becoming a premier investment hub, it must continue to implement reforms that enhance ease of doing business, offer attractive incentives, and foster a transparent and efficient government. By leveraging its strategic location, skilled workforce, and growing economy, the Philippines can attract significant foreign investments, Canadian businesses included. With targeted efforts and strategic partnerships, the Philippines can transform its investment landscape and achieve sustainable economic growth.

10 Pinakamasustansyang Prutas

Kaibigan, heto ang 10 pinakamasustansyang prutas na ginawa ng Diyos para sa tao:

1. Saging – Mabuti ang saging sa mga nag-e-ehersiso at sa may sakit sa puso dahil may taglay itong potassium. Para sa hindi makatulog at stressed sa buhay, nakapagpaparelaix din ang saging dahil sa sangkap nitong tryptophan. Kumain ng 2 saging bawat araw para makaiwas sa sakit.

2. Mansanas – May vitamin C at anti-oxidants ang mansanas. Mahalaga na kainin din ang balat ng mansanas dahil may taglay itong pectin na nagtatanggal ng dumi sa ating katawan. Panlaban ang mansanas sa mataas na kolesterol, arthritis at sakit ng tiyan.

3. Maaasim na prutas tulad ng calamansi, dalandan, orange, at suha – Masagana ang mga ito sa vitamin C at panlaban sa sapon, ubo, hika at arthritis. Kapag kumakain ng dalandan, kainin din ang mga maninipis na fibers (pulp bits at membrane) dahil mabuti ito sa ating sirkura.

4. Strawberry – Naniniwala ang mga eksperto na panlaban sa kanser ang strawberry. Mag-ingat lang at may mga taong allergic sa strawberry. Hugasan maigi bago kainin.

5. Papaya – Mataas sa vitamin A at vitamin C ang papaya kaya nakatutulong ito sa ating kutis. Ang papaya ay may papain, isang kemikal na tumutulong sa pagtunaw ng pagkain at sa pag-regular ng ating pagdumi. Mataas din ito sa fiber.

6. Ubas – Ang ubas ay may tannins at flavonoids na puwedeng makapigil sa kanser. Kumain ng ubas kung ika'y nagpapagaling sa sakit. At kapag kulang sa dugo at mahina ang katawan, kumain ng ubas

para manumbalik ang iyong sigla. Kaya paborito itong iregal sa mga dumadalaw sa ospital. Hugasan maigi bago kainin.

7. Pakwan at melon – Panlaban ang mga ito sa sakit sa bato at pantog (kidney at bladder infection). Ang pakwan at melon ay punong-puno ng vitamin C at potassium. At kapag tag-init, ito ang kailangan ng ating katawan.

8. Buko – Ang buko juice at nakatutulong sa may kidney stones (bato sa bato). Nililinis din ng buko ang ating katawan.

9. Abokado – Ang abokado ay may taglay na good fats at healthy oils. Dahil dito, nakatutulong ito sa pag-iwas sa sakit sa puso at istrok. May sangkap din itong vitamin B6 at vitamin E na pampakinis ng ating balat. Para hindi kumulubot ang mukha, kumain ng abokado.

10. Pineapple – Ang pineapple ay may bromelain na makapagpapalakas sa ating resistensya. May sangkap din itong manganese at vitamin B na nagbibigay lakas sa ating katawan.

Tandaan po ang listahang ito. Ipaalam sa magulang at ituro sa anak. Ipakita din sa titser, para malaman ng lahat ang 10 pinakamasustansyang prutas.

able and renewable source of freshwater for the island's community through the launch of the solar-powered water desalination facility on October 22, 2024, under the DOST's Community Empowerment thru Science & Technology (CEST) Program.

Dr. Teresita A. Tabaog, Regional Director of DOST 1, highlighted the importance of collaborative efforts in making the desalination project a success. The project was made possible with the support of various partners, the DOST 1 CEST Program funded the Solar-Powered Water Desalination System: the LGU of Bolinao, which provided the 100-square-meter lot area and construction of the building, and the Rotary Club of Bolinao, which donated water gallons to the residents. Dr. Tabaog emphasized the crucial role of community involvement, stating, "The success of this project hinges on the active participation of the Silaki Island residents."

She expressed gratitude to the community for their cooperation and support.

Santos, Provincial Director of the Provincial Science and Technology Office in Pangasinan, explained that the desalination facility is a direct response to the community's urgent need for clean water, as identified in a needs assessment conducted in March 2023. The project aims to provide a reliable water source, eliminating the need for residents to travel long distances and spend significant amounts on water.

"This is a priceless gift from DOST 1," remarked Hon. Alfonso F. Celeste, Mayor of Bolinao, Pangasinan. He emphasized the significance of this first-of-its-kind solar-powered desalination facility in the region, particularly for Silaki Island. The mayor urged the community to cherish this vital resource and ensure its long-

term sustainability.

To ensure the safety and quality of the water processed in the desalination facility, the water has undergone rigorous testing by Hydrolab Company, a reputable water testing laboratory accredited by the Department of Health and recognized by the Department of Environment and Natural Resources. Dignitaries were the first to drink the desalinated water, setting an example for the community and demonstrating its safety and purity.

Hon. Rufo T. Caasi Sr., Brgy. Captain of Binabalian, and Engr. Olan Roy Celzo, Waterworks System Superintendent I of LGU Bolinao, pledged the local government's commitment to maintaining and operating the desalination facility. They expressed hope for future innovations and projects that would further improve the lives of their beloved community.

Opening Opportunities: Dr. Tabaog envisions a future where the desalination process can yield additional benefits. She highlighted the potential for salt production using the brine byproduct. Mayor Celeste echoed Dr. Tabaog's sentiments, expressing surprise at the nation's heavy reliance on imported salt.

This shortage has resulted in a heavy reliance on salt imports, with over 93% of the country's annual salt consumption coming from countries like Australia and China.

Through a strong partnership between DOST 1, the Provincial Government of Pangasinan, LGU Bolinao, and the Rotary Club of Bolinao, Pangasinan will truly live up to its name, "panag-asinan," as a place where salt is made. Dr. Teresita Tabaog emphasized the crucial role of collaboration, stating,

"We will not achieve this without the support of our partners. Collaboration will be key to our success." (Brenn Justin P. Guevarra)

A Priceless Gift from DOST: 1st Solar-Powered Water Desalination Facility in Silaki Island



Silaki Island, a heart-shaped 10-hectare islet located at Brgy. Binabalian, Bolinao, Pangasinan is renowned as a marine conservation haven, home to a thriving 16-hectare population of giant clams. The beauty of the ocean surrounds Silaki Island, but beneath its natural beauty and marine biodiversity lies a pressing challenge: a scarcity of freshwater. To access potable water, island residents like Mr. Brando Padilla, a member of the Bolinao Task Force Bantay Dagat, often travel on a 15-20 minute boat journey to Santiago Island. The arduous task, combined with additional fuel costs and weather risks, emphasizes the pressing need for a sustainable water solution.
