# Cavite PESO and TESDA Join Forces to Empower Job Seekers Through Contact Center Services NC II Training

In a bid to create opportunities for jobseekers, the Office of the Provincial Public Employment Service Manager, in partnership with TESDA Cavite Provincial Office, has successfully concluded the Community-Based Training on Contact Center Services NC II.

The program, held from November 27 to December 20, 2024, combined 13 days of online learning with 5 days of in-person training at the Cavite Provincial Capitol compound in Trece Martires City. Participants, including displaced POGO workers, OFWs, OFW dependents, and unemployed individuals, were trained to become certified customer service professionals, equipped with the skills to thrive in the fast-growing contact center industry.

## Game over for POGOs; high-profile fugitives fall

At the stroke of midnight on New Year's Day, it's game over for Philippine offshore gaming operators (POGOs) which became a bane to society over its links to a string of criminal activities.

Pursuant to Executive Order (EO) 74 signed by President Ferdinand R. Marcos Jr. in November, Philippine law enforcement agencies launched a crackdown against POGOs to ensure that they cease operations before the end of 2024.

This resulted in the closure of the country's biggest POGO compound located at the former Island Cove resort in the province of Cavite on Dec. 17, led by Interior Secretary Jonvic Remulla, Presidential Anti-Orga-

In 2022, Florey and



### Garbage left behind: The need to foster a culture of environmental responsibility

**T**he day after we welcomed the new year, an all-too-familiar sight confronted us: mounds of garbage in public spaces. Year after year, New Year's Eve celebrations leave public spaces littered with various forms of plastic packaging for food and beverages, firecracker debris, paper wrappers, and food waste.

It is a troubling sign of an environmental problem and the absence of an anti-littering mindset as a duty of every citizen.

Although authorities have not yet stated the number of tons of garbage hauled from parks and other public places after the New Year's Eve celebrations, the videos on social media showing thousands of families welcoming the new year with food and drinks showed the beginnings of the thrash that will be left behind.

In 2023, the Manila local government unit reported that after Christmas Day it collected 41 tons of trash in Luneta Park. In past years, the volume of garbage collected after New Year's celebrations has been staggering. For instance, in 2020, the Metropolitan Manila Development Authority (MMDA) reported collecting 55 tons of garbage from Metro Manila alone within just 24 hours after the festivities.

Although this annual waste problem highlights the broader solid waste management challenge the Philippines continues to grapple with, it shows the need to inculcate the value of anti-littering as the duty of every citizen. This behavior has a slogan – CLAY-Go—which means “clean as you go.” A citizen should be responsible for cleaning up thrash from an activity. It is not only the government's duty to run an efficient solid waste management system.

The Philippines produces between 60,640 and 61,000 metric tons of solid waste per day. With an estimated 2.7 million metric tons of plastic waste generated each year, of which nearly 20 percent ends up in the ocean, the Philippines is ranked as one of the world's



top contributors to marine plastic pollution. A significant portion of the New Year's waste comprises single-use plastics, including bottles, cups, and utensils, as well as non-biodegradable fireworks debris.

Studies have shown how this unmanaged waste impacts the environment. Plastics, in particular, have devastating effects on marine life. A 2021 study found that approximately 36 percent of fish in Philippine waters contained microplastics in their digestive systems, a sobering reminder of how pollution infiltrates the food chain. Additionally, plastic waste in soil disrupts nutrient cycling and plant growth, further compromising agricultural productivity.

Solving this waste crisis requires a multi-pronged approach from both government and private sectors. The implementation of the Ecological Solid Waste Management Act of 2000 (Republic Act 9003), which mandates proper waste segregation and disposal, has been in-

consistent across cities and municipalities. Local governments need to enforce stricter penalties for littering and bolster their waste management systems, particularly during events like New Year's Eve.

Private sector initiatives can play a significant role. Businesses should reduce their reliance on single-use plastics and adopt circular economy models where materials are reused or recycled. Collaborative efforts, such as community cleanups and public awareness campaigns, can also foster a culture of environmental responsibility.

Ultimately, the future generations bear the brunt of today's waste problem. A polluted environment diminishes the quality of life, limits access to clean water and arable land, and accelerates climate change.

It is time for collective action to ensure that the joy of welcoming a new year does not come at the expense of the planet's future.

## Climate justice group slams BFAR's inaction on removal of ban on commercial fishers within municipal waters

**Quezon City, Philippines —** The Philippine Movement for Climate Justice (PMCJ), Oceana Philippines, Pangisda Pilipinas, Pangangisda Natin Gawing Tama (PANAGAT), and other groups, protested in front of the Bureau of Fisheries and Aquatic Resources (BFAR) today, December 30, condemning the latter for its inaction and failure to adequately represent small fisherfolk in a controversial case that sought the removal of the 15-kilometer delineation, which bar commercial fishing vessels from entering municipal waters.

Last Friday, December 27, PMCJ joined a press conference, organized by Oceana Philippines, decrying the Supreme Court (SC)'s affirmation of Malabon Regional Trial Court (RTC)'s decision which allows Mercidar Fishing Corporation, a Malabon-based fishing company, to fish within 15-kilometer municipal waters, except in shallow areas that are less than 7 fathoms deep. The same resolution upheld the Malabon RTC in declaring provisions of the Philippine Fisheries Code otherwise known as Republic Act 8550, as amended, as unconstitutional. The resolution was issued by the Supreme Court First Division which is presided by Chief Justice Alexander Gesmundo.

The ten-page SC resolution stated that the

RTC's decision became final since concerned government agencies, such as BFAR, failed to file their appeal on time. "The resolution essentially declares our municipal waters 'free for all,' by a mere technicality, pushing our small-scale fisherfolk to battle big corporations in catching fish," Atty. Aaron Pedrosa, Sanlakas Secretary-General said.

Pedrosa, who heads PMCJ's Legal Team, stressed that allowing commercial vessels into the municipal waters would not only legitimize a grossly lopsided and unfair competition but would result in a grave injustice; as the SC resolution in effect annulled relevant protections afforded to fisherfolk under the Philippines' Fisheries Code.

"By declaring the 15-

km municipal waters provisions unconstitutional, and removing the bar for commercial vessels to come in, relevant social justice measures enshrined in the Constitution will be severely diminished and eroded. Laws protecting the rights of the marginalized, especially the fisherfolk, considered the country's poorest, should be treated with supreme and utmost regard and not be simply overturned by default," Pedrosa lamented.

PMCJ, together with various organizations, expressed their condemnation of BFAR, and other concerned agencies for letting this alarming situation happen, endangering the lives and livelihood of artisanal fisherfolk, who are the backbone of the country's fight against food insecurity.

"Small-scale fisherfolk are the ones that put food on our tables, as big corporations, like Mercidar, operate to fish for export," said Laica Rayel, PMCJ's Food, Land, Water, and Climate Change (FLWC) campaign officer. Rayel emphasized that the PMCJ has 43 fisherfolk and coastal community organizations spread all over the country with an estimated membership of 140,000 families which will be greatly affected by the SC resolution.

"These families are just a fraction of the 60 percent of the population living in coastal communities, where survival and livelihood depend on marine and aquatic resources. Allowing commercial fishers will exacerbate the destruction of many protected sea-

scapes and marine biodiversity in the country," Rayel added.

PMCJ sees this decision as a serious setback for hundreds of thousands of fisherfolk and violates the constitutional guarantee of social and environmental justice. "This is clearly a rights issue, an issue of social and climate justice. It manifests the indifference of community-based solutions for climate justice, as the participatory process of the sectors who will be greatly affected by the resolution were absent," Rayel stressed.

Groups call on the Government to actively pursue the case before the Supreme Court, instead of shifting the burden on fisherfolk and ordinary citizens. The SC Resolution may still be recon-

sidered upon proper motion by the Government. Pangisda Pilipinas also expressed their plea to BFAR to take action in a statement. If BFAR is truly serving the national interest and is dedicated to ensuring a fair and just resolution is reached, we demand the agency to take accountability for their concerning lapses and fast-track concrete actions to seek further review from the Supreme Court.

PMCJ, together with other organizations, showed force that they will not take this sitting down. This should be pursued to attain justice however rigorous, and protect fisherfolks and other constituents' rights and livelihood. **#ProtectOurSeas**

By emphasizing the importance of thorough evaluation and collaboration, the region looks forward to an even brighter future for its enterprises and communities.

The SJA is a science communication advocacy of the Department of Science and Technology through its Science and Technology Information Institute. The program aims to expand science communication at the grassroots to capacitate young communicators to dive deeper into science and technology by creating awareness and communicating its benefits to the public.

She offered additional tips, such as focusing on positive notes and offering solutions, emphasizing the balance of compelling factors with accuracy, and the use of case studies to support data.

"The structure of a news story should be an inverted pyramid. Make sure to include quotations, further explanation, and the context of the topic," Espinosa said.

Additionally, Espinosa provided tips for student interviews: "It's important to do your research and plan. Don't be afraid to ask simple questions. Summarize to confirm, recheck quotes, and keep questions short and easy to understand."

As part of the participants' immersion, Espinosa prepared a mini press conference for the

students, allowing them to ask questions about Buddybetes, an application that helps manage blood sugar.

She commended the students for their active participation and ability to apply the interviewing techniques.

One participant asked whether quotations should be direct or paraphrased. Espinosa responded that direct quotations should be used when the statement is noteworthy and "magandang pakinggan" (pleasant to hear) in one sentence. Paraphrase when the quote is used for an explanation.

Another participant inquired about the ideal length of a news article. Espinosa explained that news articles are typically 300 to 500 words long, while feature articles range from 500 to 800. "Anything beyond that is considered a long-form article," Espinosa emphasized.

When asked if there is a pattern in feature writing, Espinosa clarified that features do not follow the inverted pyramid structure of news articles and are usually free-flowing. "You can tease a bit more and be playful," she said.

Lastly, Espinosa reminded the students to consider various factors when writing articles, including diversity, background, power, interest, sensitivity, SOGIE (Sexual Orientation, Gender Identity, and Expression), and stigma, as these aspects may affect readers' reactions.

She also reminded the participants to answer the questions, "Who is my audience?" and "What do I want them to do/feel?"

Espinosa was one of the three resource speakers that included Rosemarie Señora, Science Research Specialist I who discussed mobile photography and photojournalism, and Allan Mauro Marfal, Information Officer III both of the DOST-STII who lectured on the topic social media content creation.

The second day of the event included a site visit, where participants gathered data and interviewed the beneficiaries of DOST Small Enterprise Technology Upgrading Program in Lipa, learning about the technologies, products, and services offered by these firms, which they could use to write science articles and produce photos and reels for the workshop. **(By Ryan Spencer P. nized Crime Commission (PAOCC) Executive Director Undersecretary Gilbert Cruz, Philippine Amusement and Gaming Corp. (PAGCOR) chairperson Alejandro Tengco and Philippine National Police (PNP) chief Gen. Rommel Francisco Marbil.

The Remulla family sold the resort to a real estate developer in 2017. The facility then started operations as a POGO hub in 2019.

The POGO facility on the 33-hectare property is the biggest in the country with 30,000 employees, half of whom were Filipinos.

The compound consists of 57 buildings, including employee dormitories, gaming hubs, cafés, groceries, clinics, restaurants, spas and beauty salons.

Meanwhile, the PAOCC is intensifying the campaign against guerrilla POGO operations throughout the country.

Law enforcers would also mount inspections of special class business process outsourcing (BPO) facilities to ensure that no POGO hubs are concealing operations.

Guo, Quiboloy fall

The year 2024 also saw the downfall of two high-profile individuals linked to a string of crimes -- dismissed Bamban, Tarlac Mayor Alice Guo and Kingdom of Jesus Christ (KOJC) leader Apollo Quiboloy.

Guo was deported to the country after being arrested in Indonesia in September.

The dismissed mayor, her siblings Wesley and Shiela, and their parents were earlier ordered arrested by the Senate for their refusal to appear in its investigation into the operations of the Zun Yuan Technology Inc., the Philippine Offshore Gaming Operators (POGO) hub in Bamban which was raided by authorities in March.

The investigation also led to questions on the nationality of the dismissed mayor, after the Philippine authorities revealed that her fingerprints matched that of a certain Chinese national identified as Guo Hua Ping.

In an Aug. 12 order, the Ombudsman dis-

missed Guo from the service for grave misconduct and perpetually banned her from holding public office.

This was in connection with the charges filed by the DILG against Guo for her alleged involvement in the operations of POGO.

Guo and her co-accused face charges of qualified human trafficking in connection with a June raid on a POGO hub in Bamban, Tarlac, where 800 Filipino and foreign workers were rescued.

In September, non-bailable criminal charges for qualified trafficking were filed before the Pasig Regional Trial Court (RTC) against dismissed Guo and 13 others.

Aside from Guo, the DOJ also charged Dennis Cunanan and 12 other executives and founders of three companies, who are allegedly Guo's business partners.

Meanwhile, Quiboloy was arrested on Sept. 8 at the KOJC compound in Davao City after more than two weeks of operation.

Quiboloy is currently facing a non-bailable qualified human trafficking charge. He is also accused of child and sexual abuse, along with five of his aides.

Following the arrest, his lawyers immediately sought a hospital or house arrest due to his medical history, including two previous heart-related procedures.

The court denied the petition after the Philippine National Police General Hospital declared that his condition is not life-threatening.

Last November, Quiboloy was transferred to the Pasig City Jail from the Philippine Heart Center where he is confined after being granted a medical furlough.

### Bloodless anti-drug drive gains

The Marcos administration's anti-drug campaign has so far netted PHP51.14 billion worth of narcotics and arrested 119,022 drug suspects for the period of July 2022 to Oct. 31 this year, the Philippine Drug Enforcement Agency (PDEA) reported.

Records also showed that among those ar-

rested were 7,567 high-value targets in 87,802 operations across the country.

A total of 1,217 drug dens and 2 clandestine shabu laboratories were dismantled during the same period.

Meanwhile, 29,211 out of 42,000 villages have been declared "drug-cleared" while 6,292 are in the process of being cleared.

During his third State of the Nation Address in July, President Ferdinand R. Marcos Jr. pledged to continue the bloodless anti-narcotics drive, emphasizing that extermination is not a part of his administration's anti-drug campaign.

Meanwhile, the PNP Drug Enforcement Group (PDEG) seized nearly PHP2.4 billion worth of narcotics from Jan. 1 to Dec. 18, 2024.

PDEG chief Brig. Gen. Eleazar Matta said the amount includes 168 kg. of shabu, 3,866,600 fully grown marijuana plants, 1,830 kg. of dried marijuana leaves, 48.672 kg. of ketamine, 36.9 kg. of kush, 1,343 tablets of ecstasy and 90 grams of cocaine.

The illegal drugs were seized in 698 operations, including buy-busts, service of search warrants, and marijuana eradication drive which also led to the arrest of 809 drug suspects and 232 wanted persons.

Matta said efforts now focus on interdiction and that the PDEG remains proactive in executing coordinated, high-impact operations and ensuring integrity and transparency in all operations, consistently using body-worn cameras.

He said actions are documented, with airtight cases prepared to ensure the prosecution of offenders.

Matta also paid tribute to police operatives who died in the line of duty.

"The heroism of these operatives inspires the entire force to press on, ensuring that their sacrifices were not in vain," Matta said.

The iSULAT has a microcontroller within the pen, which transmits data to a mobile application. The raw signal undergoes filtering, feature scaling, engineering data, and analyses before it is forwarded to the occupational therapist for diagnosis.

Through the pen, the occupational therapist can efficiently assess one's handwriting based on the alignment of letters, spacing, and consistency.

A separate report mentioned that the number of handwriting problems in developing children reached an approximate 5 to 25 percent range. Handwriting is still the most immediate form of graphic communication and failure to attain proficiency during the school-age year may result in far-reaching negative effects on both the academic success and self-esteem of a

child.

This project was funded by the Department of Science and Technology-Philippine Council for Health Research and Development (DOST-PCHRD), with a budget of PHP3.2 million for its initial phase.

"Yung mga ganitong invention, kailangan niyan ng testing. Hindi lang isa. Dapat tine-test siya ng mas marami para mas ma-check kung accurate or kung maganda na yung pine-perform ng prototype," said Engr. Jomel Herras, Project Manager of iSULAT.

Engr. Herras added that his team is looking for more enthusiasts and partners who will help them promote iSULAT to gain more users from various locations.

The iSULAT is one of the technologies featured in the recently concluded

2024 National Science and Technology Week, held in Cagayan de Oro City from 26 November to 01 December 2024.

According to DOST-PCHRD, standardized assessments of children with developmental delays are quite expensive and must be done with the aid of an occupational therapist or handwriting experts. The therapy usually runs from 20 minutes up to one hour.

"Basically ina-address na problem ni iSULAT is yung kakulangan natin ng occupational therapists at mahal na cost ng therapy," said Engr. Herras. "Siguro yung pinaka rootproblem ay yung problema ng mga bata sa kanilang handwriting. They do it in their everyday lives. Nagsusulat sila even in Math, Arts, and English subjects. Yung ibang mga bata, hindi sila enthusiastic kaya akala natin tamad lang sila magsulat."

With the help of iSULAT, children with handwriting problems can undergo si-

multaneous testing in batches or groups.

During phase I, the project team conducted pilot testing for children ages 6-10 in three sites across Luzon namely Villa Maria Elementary School in Porac, Pampanga; Juan Sumulong Elementary School in Metro Manila; and Bulacan Montesorri School Inc. in Bulacan.

Herras said that phase I of the project started in 2022 and ended last 31 October 2024.

"Hopefully by 2026 ay mayroon nang phase II na kung saan ay maiiapply na natin ito hindi lang para sa mga bata," Herras explained. He added that the project targets those with Attention Deficit Hyperactivity Disorder or ADHD and autism. This year, the project team has secured a partnership with the Department of Education (DepEd) Division of Metro Manila for future testing.
