DOST-PTRI Pushes for Innovation and Collaboration at TELACon 2025

The second day of the 2025 National Textile Convention (TELACON), held at the Philippine International Convention Center (PICC), gathered key industry leaders, policymakers, and stakeholders to discuss the future of the Philippine textile industry. Organized by the Department of Science and Technology – Philippine Textile Research Institute (DOST-PTRI), the event highlighted the importance of sustainability, authenticity, and industry collaboration in shaping a resilient textile sector.

Batangas Cacao Growers Association secures DOST's assistance for cacao processing facility establishment

The Batangas Cacao Growers Association (BCGA), a federation of cacao farmers in Batangas province, has secured support from the Department of Science and Technology (DOST)-Batangas through a Grants-in-Aid Community-based Project aimed at establishing a cacao processing facility and formalized with the signing of a Memorandum of Agreement (MOA) held at the DOST-Batangas Office in Kumintang Ilaya, Batangas City, January 23.



The MOA was signed by Mr. Cayo Casanova, President of the BCGA; Provincial S&T Director Felina C. Malabanan, representing DOST-Batangas; and Dr. Rodrigo Bautista, Jr., Batangas Provincial Agriculturist. The project is

designed to enhance the cacao industry in Batangas by improving product quality and providing local farmers with a reliable market for their beans. Additionally, the facility will serve as a hub for cacao processing, where farmers can

use state-of-the-art equipment to produce high-quality chocolate products, including 70% dark chocolate and 50% milk chocolate bars.

The project also aims to create job opportunities within the production process and provide



technical training on food safety, standardization, equipment use, and maintenance to members of the association.

The Batangas Provincial Agriculture Office

committed to provide the facility, while DOST-Batangas will supply the equipment and training needed for the project implementation. This collaboration marks a signifi-

cant step in empowering local farmers, improving the quality of cacao products, and fostering growth within Batangas' cacao industry. *(By John Maico M. Hernandez)*

DTI-Laguna intensifies price and supply monitoring of BNPCs in San Pedro City

VICTORIA, LAGUNA – The Department of Trade and Industry - Laguna Provincial Office (DTI-Laguna), through its Consumer Protection Division (CPD), conducted a routine monitoring of price and supply of basic necessities and prime commodities (BNPCs) on January 28, 2025 in San Pedro City, Laguna.



Four (4) private supermarkets and grocery stores were monitored to ensure that the prices of BNPCs under the jurisdiction of DTI are within the suggested retail prices (SRPs).

The DTI-Laguna CPD Monitoring Team observed that majority of the BNPCs are compliant with the SRP. Whereas, Letters of Inquiry (LOI) were issued for a BNPC item that was observed to have a price higher than the SRP. Accordingly, retail establishments that were issued with an LOI have to submit a written explana-

tion within 72 hours from receipt of the letter.

As outlined in the Section 6-7 of the Republic Act No. 7581 (RA 7581), otherwise known as the "Price Act", the prices of some BNPCs fall under the jurisdiction of DTI including, but not limited to, canned fish and other marine products, processed milk, coffee, laundry soap, detergent, candles, bread, salt, portable water in bottles and containers, locally manufactured instant noodles, processed and canned pork, processed and canned beef and poultry meat, vinegar, fish sauce, soy sauce, toilet soap, among others. Moreover, the RA 7581, as amended by the RA 10623, mandates the DTI and other implementing agencies such as the Department of Agriculture, the Department of Health, the Department of Environment and Natural Resources, and the Department of Energy to ensure the availability of BNPCs at reasonable prices at all times without denying legitimate businesses a fair return on investment. Editorial

Making healthcare more accessible and sustainable

Health is wealth. This is why the passage of House Bill (HB) No. 11357, which proposes significant amendments to the Republic Act No. 11223, more commonly known as the Universal Health Care (UHC) Act, is crucial in ongoing efforts to reform healthcare in the country. This bill aims to address some of the longstanding challenges in the nation's healthcare system, with the goal of making healthcare more accessible, affordable, and equitable for every Filipino. While the UHC law was a landmark piece of legislation when it was enacted in 2019, the proposed amendments signal that healthcare reform is an evolving process that requires continuous enhancement.

One of the key features of HB 11357 is ensuring financial sustainability, especially with regards to the Philippine Health Insurance Corporation (PhilHealth). Determined to guarantee financial sustainability, the bill prohibits the transfer of PhilHealth reserve funds or income to the national government or any government-owned or controlled corporation. The passage of the bill comes almost a year after the Department of Finance (DOF) directed government-owned and controlled corporations (GOCCs) to transfer their excess funds to the national treasury.

The bill also caps administrative expenses at 7.5 percent of the benefits given to its members the previous year, from the previous cap of 7.5 percent of total premium collections. Other features of the proposed law include cutting the premium contribution rate for PhilHealth members to 3.5 percent, down from the current five percent; and waiving premium contributions for migrant workers — both land- and sea-based. Instead, their employers will shoulder 50 percent of their contributions, while the national government will cover the other half. The bill also mandates that unused portions of premium subsidies for indirect contributors must be allocated exclusively for benefit increases.

The measure also allows component cities and municipalities to establish and/or main-



tain their own Special Health Fund.

Under the proposed law, a Universal Health Care Coordinating Council will be created to intensify and expedite the implementation of the UHC Act, as embodied in Republic Act No. 11223, at the national and sub-national levels, and provide a venue for policy discourse and operational collaboration among relevant agencies and organizations.

With these proposed amendments, more financial resources will be directed toward making health insurance more inclusive, which is crucial in ensuring that vulnerable populations are not left behind. This will improve the financial protection that PhilHealth offers to Filipinos, ensuring that health-related expenses do not push individuals and families deeper into poverty.

While the passage of this bill is a step in the right direction, it is important to recognize that the true success of the UHC reforms will depend

on their effective implementation. The government must ensure that the additional resources and policies translate into tangible improvements on the ground. This includes building the necessary infrastructure, expanding the reach of healthcare services to remote areas, and ensuring that the healthcare workforce is adequately supported and compensated.

The amendments to the UHC law offer hope for a healthcare system that is not only more inclusive but also more sustainable and responsive to the needs of the Filipino people. As the country continues to grapple with the challenges of a growing population and an evolving public health landscape, these changes reflect a forward-thinking approach to building a healthier, more resilient society. With proper implementation and political will, these amendments have the potential to significantly improve healthcare outcomes and make quality health services a reality for all Filipinos.

sustainability of the Philippine textile industry. She stressed the need to integrate environmental responsibility, cultural preservation, and economic resilience into the industry's foundation, urging stakeholders to seize the opportunity to drive meaningful change.

One of the key discussions of the day was the Philippine Tropical Fabrics (PTF) Technical Committee Panel Discussion, which highlighted the industry's accomplishments, challenges, and future plans. Mr. Jo-Dann N. Darong, Assistant Director of the Department of Trade and Industry's (DTI) Bureau of Competitive Development, emphasized the importance of consumer vigilance in ensuring high-quality textile products. Mr. Arnold Atienza, Executive Director of the Philippine Fiber Industry Development Authority – Department of Agriculture, addressed the pressing need for more raw materials in the local industry, noting that while a significant portion of production is geared toward exports, strengthening local supply chains requires a collaborative effort. Atty. Katherine Limare-Delmoro, Director IV of the Civil Service Commission's Commission Secretariat and Li-

aison Office, reassured that government agencies are continuously being informed on how to effectively procure Philippine Tropical Fabrics (PTF) to ensure compliance with national policies. Dr. Julius L. Leaño, Jr., Director IV of DOST-PTRI, called on the private sector to take a more active role in reestablishing and expanding businesses within the country, with the government playing a key role in driving this growth.

In a significant announcement, DOST-PTRI unveiled its plans to launch the Non-Wovens Innovation Program in 2025, focusing on applications in industries such as footwear manufacturing. This initiative aims to harness the country's abundant textile resources through strategic partnerships and research-driven innovations. With TELACon 2025 serving as a platform for dialogue and collaboration, the discussions on Day 2 highlighted the potential of the Philippine textile industry to drive sustainable innovation and enhance global competitiveness.

DOST Secretary Renato U. Solidum, Jr. also underscored the importance of transitioning to a circular economy, emphasizing that

sustainability does not require disruptive overhauls but rather a shift in mindset, clear goals, and commitment. He cited examples of small, deliberate actions making a significant impact, such as the adoption of eco-friendly care labels, low-impact dyes, and Philippine Tropical Fabrics (PTF), as well as responsible sourcing and streamlined manufacturing. The shift towards sustainability, he noted, must be a collective effort across sectors, fostering a value chain that benefits all while bridging economic and social divides. Secretary Solidum further shared that on February 5, DOST will publicly launch eight high-impact, big-ticket R&D programs for socio-economic development, including the Circular Economy initiative, which integrates science, technology, and innovation to drive a sustainable, green economy.

As government agencies, private sector players, and industry stakeholders continue to work together, the vision of a stronger and more sustainable textile sector is steadily taking shape. With new technologies, a growing awareness of sustainability, and a stronger policy framework supporting home-grown innovations, the Philippine textile industry is poised for transformative growth. **(Nelson Santos)**

the cities and municipalities of Kawit, Imus, General Trias, and Tanza.

Phase 2 will involve the construction of one terminal and 20 stations, which will be interconnected to Trece Martires via the New Cavite Provincial Capitol building, with the system to be aligned to connect to PITX and other central business districts via a P2P system.

Megawide said that construction of Phase 1 would start this quarter and was expected to be operational by the third quarter.

"The initial phase will serve close to 10,000 passengers daily, with a target to increase ridership five-fold within three years, depending on Cavite's progress," he added.

The project seeks to build a 42-kilometer (km) BRT system traversing the cities and municipalities of Cavite and providing a link to Metro Manila via the Parañaque Integrated Terminal Exchange (PITX). It includes the development, financing, design, operation and maintenance of a BRT and point-to-point (P2P) route.

Project development will be in two phases. Phase 1 will involve the construction of three terminals with 27 stations and the operation of a BRT and P2P bus system crossing

DOST 1 Regional Director Dr. Teresita A. Tabaog expressed strong support for the initiative, highlighting its critical role in disaster risk reduction and innovation in coastal infrastructure.

"As we inaugurate this facility today, let us celebrate not just the structure before us, but the endless possibilities it represents—the knowledge we will gain, the solutions we will create, and the future we will shape together," Dr. Tabaog stated.

The Wave Flume Facility is part of the Coastal Engineering and Management Research and Development Center (COASTER) and was developed through the collaboration of MMSU, the

DOST-Philippine Council for Industry, Energy and Emerging Technology Research and Development (DOST-PCIEERD), and other key stakeholders.

The potential applications of this facility include wave-structure interaction studies, beach and shoreline erosion analysis, harbor and port engineering, and wave energy conservation for renewable energy. Additionally, it will support tsunami and storm surge monitoring, as well as research on river and estuarine hydrodynamics.

Among those present at the inauguration were DOST-PCIEERD Director Dr. Enrico Paringit, MMSU Officer-in-Charge Dr.

Prima Franco, COASTER Program Leader Dr. Nathaniel R. Alibuyog, and Engr. Joseph Samonte of the Department of Public Works and Highways-Unified Project Management Office-Flood Control Management Cluster.

DOST Secretary Renato Solidum Jr. and Undersecretary for Research and Development Dr. Leah J. Buendia also delivered messages of support, emphasizing the facility's significance in strengthening the country's resilience to coastal hazards.

With this pioneering project, DOST Region 1 reaffirms its commitment to promoting scientific advancements that drive sustainable development and disaster preparedness in the region and across the nation. **(Carla Joyce B. Cajala)**



Cavite Water and Wastewater Testing Laboratory maintain its ISO/IEC 17025:2017 Accreditation

The Philippine Accreditation Bureau (PAB) - Laboratory Accreditation Division team composed of Ms. Marieson A. Trinidad, as the leader together with its team member/ technical assessors Mr. Joe Mar Balbuena for Biological testing and Mr. Aljon Bagting for Chemical testing, conducted the 1st Surveillance Visit (SV) of DOST- Cavite Water and Wastewater Testing Laboratory (CWWTL). The objective of the assessment is to ensure the continuous compliance of CWWTL to the requirements of ISO/IEC 17025:2017, PAB Supplementary Requirements, Guidance Document, and the implemented laboratory quality management system. The surveillance visit ensures that the laboratory consistently maintains its high standards of quality based on regulatory and international standards.

The Philippine Accreditation Bureau (PAB) formerly the Philippine Accreditation Office is the national accreditation body of the Philippines and the central body to accredit inspection, testing, and certifying bodies and other bodies offering conformity assessment services in accordance with Executive Order 802.

After the two-day audit, it was concluded that the existing signatories, namely Ms. Anna Marie S. Daigan and Ms. Joan Mae A. Aure for Biological testing and Ms. Verjo Angelie M. Sisante and Thea Mary Joyce M. Diloy for Chemical testing are still recommended by the technical assessors. This conveys a formal demonstration of its competence, impartiality, and consistent operation in performing laboratory testing.
