J.C. Macatangay Goat Farm enhances production with cheese, yogurt processing training

In a bid to diversify its product offerings and maximize its production capacity, J.C. Macatangay Goat Farm underwent a two-day technology-based training on cheese and yogurt processing at their production facility in Brgy. Abiacao, San Luis, Batangas, held recently.



The farm, which houses four breeds of goats—Anglo-Nubian, Saanen, LaMancha, and Alpine—currently produces 23 to 25 liters of goat milk daily. While they are already known for their pasteurized goat milk, the farm's management

recognized the potential to further utilize their milk supply by exploring the production of value-added dairy products.

To help achieve this goal, the Department of Science and Technology (DOST)-Batangas orga-

nized the training program, aimed at equipping the farm's employees with the skills and knowledge needed to produce a variety of goat milk-based products.

The comprehensive training introduced employees to the step-by-



step procedures for making white cheese, feta cheese, ricotta cheese, and yogurt. Key topics covered included milk handling practices, quality control, pasteurization methods, and proper equipment usage. Trainees also learned essential techniques for enhancing the flavor, quality, and shelf life of the products, such as fermentation methods and pasteurization time estimation.

Hands-on activities provided participants with practical experience which helped ensure they understood the production process and how

to troubleshoot common issues.

Ms. Aida B. Lanaca, Plant Manager of the Dairy Training and Research Institute - University of the Philippines Los Baños (DTRI-UPLB), facilitated the sessions and provided insights into maintaining product consistency while adhering to stringent food safety standards.

At the conclusion of the training, Mr. Jayson Macatangay, owner of J.C. Macatangay Goat Farm, expressed his sincere gratitude to DOST Batangas and DTRI-UPLB for sharing their expertise. "This training will

truly benefit our business as we venture into new product lines," said Macatangay. "We are excited to introduce our new products to customers and are confident they will be a point of pride for our farm and the municipality of San Luis," he added.

With the new skills gained from the training, J.C. Macatangay Goat Farm is now poised to offer a wider range of goat milk products, meeting the growing demand for high-quality, value-added dairy items in the local market. (By John Maico M. Hernandez)

In light of the recent flooding, PMCJ, Palawan Orgs call to stop mining, end coal plant ops

Quezon City, Philippines — Chest-deep floods swamped Puerto Princesa City and the Municipalities of Narra and Aborlan in Palawan yesterday, February 9, displacing more than 600 families during the heavy rains caused by the shear line—a catastrophe worsened by environmental degradation, caused by mining, coal plant development, and poor waterway management.

The shear line is the intersection of the easterlies, or warm winds from the Pacific Ocean, with the cold air from the northeast monsoon, also known as Amihan. This doesn't usually cause massive floods—indicating the state of climate emergency we are in.

"Upang maiwasan ang baha at maisalba ang huling paraiso, ating ikundina at ipatigil ang mga mapanirang aktibidades gaya ng pagkakaroon ng coal [plant] at tahasang pamumutol ng punong kahoy sa Palawan!" urged Professor Marlene Jagmis of Palawan Alliance for Clean Energy (PACE), where Philippine Movement for Climate Justice (PMCJ) is a member organization. [To avoid flooding and save our last paradise, let us condemn and stop destructive activities like mining, operating coal plants, and illegal logging in Palawan!]

PMCJ National Coordinator Ian Rivera stated that the 15 MW coal-fired power plant of the DMCI Power Corporation in Narra has defied both the country's coal moratorium and the insistent calls of the people of Palawan to stop its construction.

"We have previously expressed serious concern regarding the DMCI coal plant not only because of the environmental damages it causes but also the serious risks the plant poses to the health and livelihood of the residents of Narra," he said. Rivera further explained that the coal plant built by the coastal area of Narra, when operational, will release coal fly and bottom ash. These are hazardous as these con-

tain toxic chemicals CO₂, SO₂ and PM10 and PM2.5. These toxic substances are also found in all other coal plants in the Philippines including heavy metals like lead, arsenic, mercury, and cadmium. potentially contaminating the waters and the air of the municipality.

Despite this, the Department of Energy (DOE) announced its support for the construction of the coal plant in Narra despite the existing moratorium, citing the country's development and "energy security" as the reason for its necessity.

Projects aimed at "development" were also a key factor in the flooding of Puerto Princesa, as explained by Atty. Grizelda "Gerthie" Mayo-Anda of the Save Palawan Movement and the Environmental Legal Assistance Center (ELAC).

"Kailangan ang maayos na Comprehensive Land and Water Use Plan dito sa siyudad. At dahil lumalaki ang siyudad at umuunlad, kailangan ng masusing pag-aaral kung saan batayato itong mga buildings.

At lumabas sa ilang taon, na ang mga creeks dito ay tinatakpan," she said. [There has to be a proper Comprehensive Land and Water Use Plan in the city. And because the city is growing and expanding, detailed study should be needed before a building can be built. It's been found over the years that the creeks in the city have been blocked.]

Atty. Mayo-Anda suggested studying where the creeks are located and unblocking clogged waterways. "Mag-isip din ang alternatibong paraan

[para] yung waterways ay tuloy ang daloy. Marami namang paraan para magawa 'yon," she added. [They should also come up with alternative ways to keep the waterways clear. There are many ways to do this.]

"Development and progress should be just and equitable. It should take into consideration the carrying capacity of the planet and the island-province, particularly that we are now in a climate emergency situation. Therefore there is no excuse for letting our lands be submerged by rainfall just for the select few who will benefit from the project. Several LGUs have already sworn to transition to more sustainable means of energy generation like the Municipality of Sablayan in Occidental Mindoro," Rivera stressed. The town recently entered into a Memorandum of Understanding with the PMCJ to fully transition its energy generation into 100% renewable energy sources.

A few years ago citizens and environmental groups in Aborlan had won their fight to stop the coal plant being built in their municipality, forcing DMCI to find a new site for their plant. It was, then, constructed in Narra despite continuous opposition from residents and groups.

"We cannot let development be a justification to destroy Palawan and for 'progress' to drown its people. As one of the world's wonders and the last frontier of biodiversity, Palawan and its people have all the right to protect its future," Rivera ended. #ClimateJusticeNow #ClimateEmergencyNow #SavePalawan #NoToCoal

Strengthening the Anti-Bullying Law for safer school environment

Bullying remains a nagging issue in our schools, adversely affecting the well-being and academic performance of countless students. Defined as repeated aggressive behavior intended to harm, intimidate, or humiliate a student, bullying can take many forms, including verbal abuse, physical assault, social exclusion, and cyberbullying.

Unfortunately, despite the passage of the Anti-Bullying Act of 2013 (Republic Act No. 10627), bullying remains a problem highlighting the need for stronger regulations and enforcement.

Recent data underscores the severity of the issue. The 2018 Program for International Student Assessment (PISA) revealed that 65 percent of Grade 5 learners in the Philippines experienced bullying a few times a month. While the 2022 PISA showed a slight decline, one in three students still reported being bullied weekly. The country has consistently recorded the highest bullying rates among the member nations of the Organization for Economic Cooperation and Development (OECD). Alarming, between November 2022 and July 2024, only 38 out of 339 reported bullying cases were resolved, with Metro Manila reporting the highest number of cases.

The consequences of bullying extend beyond the distress or fear a bully creates for other students. Its effects are profound. Based on the five studies conducted by De La Salle University and the Philippine Institute for Development Studies (PIDS), Dr. Alan Bernardo noted that "bullying does not impact mental health so much, however, the substantial effects on learning are very noticeable." He said the worst consequence of bullying is student disengagement, which "not only hampers their academic performance but can also lead to long-term educational disinterest."

A bullied student may experience declining grades, absenteeism, and a diminished sense of self-worth.

Examples of bullying in our schools are distressing. Incidents range from verbal taunts



about appearance or socioeconomic status to physical altercations in school corridors. Social media has also become a platform for harassment, amplifying the reach and impact of bullying. The rise of cyberbullying further complicates efforts to protect students, as it often goes unnoticed by school authorities.

In response to these alarming trends, the Department of Education (DepEd) and the Second Congressional Commission on Education (EDCOM 2) have initiated a comprehensive review of the Anti-Bullying Act's Implementing Rules and Regulations (IRR). This move, supported by DepEd Secretary Sonny Angara, aims to strengthen policies, ensure greater compliance, and align the revision with other mental health and career guidance laws. Among the proposed changes are an expanded definition of bullying, enhanced prevention and intervention programs, and the provision of adequate guidance counselors and discipline officers in schools.

DepEd has established the Learner Rights and

Protection Office in 2022 to receive reports of bullying and other forms of violence. Sec. Angara said they have strengthened the office to ensure that more people are available to help victims.

The completion of the revised IRR before the 2025-2026 school year signals hope for a safer learning environment.

Strengthening the IRR of the Anti-Bullying Act is crucial to creating a culture of respect and inclusion in schools. Educational institutions must prioritize preventive measures, provide immediate support to victims, and hold bullies accountable. Parents, teachers, and school officials should work collaboratively to foster a safe and nurturing environment where students can thrive academically and emotionally.

A safer school environment is not just a legal mandate but a moral responsibility to ensure every child's right to learn, grow, and succeed without fear. That is our obligation to the next generation.



Pangilinan, Aquino to start campaign in Cavite
