## SC STRIKES DOWN COMELEC RULING DECLARING INDIGENOUS PERSON NUISANCE CANDIDATE

The Supreme Court (SC) on Tuesday reversed the resolution of the Comelec, which declared Zambales gubernatorial aspirant Chito Bulatao Balintay as a nuisance candidacy for the 2025 midterm elections.

In a press release, the high court noted that the poll body committed grave abuse of discretion when it refused to allow Balintay, a member of the indigenous peoples of Zambales, to run for governor.

The order stemmed from the Comelec's decision rejecting Balintay's candidacy on the grounds that he filed his COC past 5 pm on the last day of filing. The poll body initially refused to accept his documents as they were incomplete—missing a required fifth copy and documentary stamps—SC STRIKES • 4

## DMW Region IV-A explores collaboration with DOST-CALABARZON for iFWD PH

On February 26, 2025, the Department of Migrant Workers (DMW) Region IV-A visited the Department of Science and Technology (DOST)-CALABARZON to conduct an exploratory meeting on the Innovation for Filipinos Working Distantly from the Philippines (iFWD PH) program.



The meeting focused on future partnerships and collaboration between DMW

and DOST to enhance support for overseas Filipino workers (OFWs) through

science, technology, and innovation (STI)-based reintegration solutions.



Key attendees included Atty. April R. Casabuena, DMW Regional Director; Ms. Karen M. Quilao, DMW Assistant Regional Director; and representatives Mr. Lito C. Doblado, Mr. Romwell Q.

Aguilar, and Mr. Joel M. Gustino. Discussions centered on potential initiatives to maximize the impact of STI-driven programs for OFW reintegration and livelihood development.

The iFWD PH was a DOST program that aimed to provide support and opportunities for OFWs and their immediate families to establish technology-based enterprises in the country.

## DTI and Local Partners Support Footwear MSMEs with Tech Development

Liliw, Laguna — The Department of Trade and Industry (DTI) - Laguna Provincial Office, in collaboration with DTI Ilocos Norte and the Local Government Units of Vintar in Ilocos Norte and of Liliw in Laguna, successfully conducted a benchmarking activity focused on "Technology Development Support for the Footwear Industry" on February 26, 2025.



The activity aimed to provide insights regarding the various types of footwear that can be produced and the methods for making different shoes and slippers.

Nine (9) micro, small, and medium enterprises (MSMEs) from the Siawer Local Council for Women and Dream Weavers of Vintar, Ilocos Norte, participated in the said visit. These MSMEs were able to observe the production processes of several footwear MSMEs in Liliw, Laguna, including Leigh Ann Footwear,

Monedo's Footwear, Grinter Footwear, Jhaz Footwear, and Ai-She Fashion. This hands-on experience allowed the participants to learn firsthand about the production techniques and innovations driving the local footwear industry.

The group was joined by Vintar Municipal Mayor Richard A. Degala and Liliw Municipal Mayor Ildefonso D. Monleon. Together, they explored various footwear businesses in Liliw, gaining exposure to different production methods and innovations that could potentially be applied in Ilocos Norte. DTI Ilocos Norte Provincial Director Amelia E. Galvez also participated, offering her full support to the MSMEs from Vintar and ensuring that they have the resources and guidance needed to succeed in the footwear industry.

This benchmarking activity provided valuable insights to the MSMEs from Ilocos Norte, sparking ideas for potential new business ventures. It also offered an opportunity to highlight Liliw, Laguna's expertise in



footwear production.

## Editorial

### World Wildlife Day: Protect PH natural treasures

Every March 3, the global community comes together to celebrate World Wildlife Day, a crucial occasion to reflect on the importance of protecting the world's biodiversity. For the Philippines—an archipelago renowned for its rich ecosystems and endemic species—this observance underlines the urgent need to safeguard our natural heritage from the growing threats of habitat destruction, climate change, and human encroachment.

Member-countries of the United Nations are called upon to participate in achieving the Strategic Vision of the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES), the 2030 Agenda for Sustainable Development, and the Kunming-Montreal Global Biodiversity Framework.

Considering that more than half of global gross domestic product (GDP) is nature-based, it is imperative that sustainability of biodiversity becomes a priority concern of governments. Further decimation of biodiversity translates into threats to livelihood at the grassroots and financial stability of nations.

According to latest studies, more than one million species of Philippine wildlife are threatened with extinction; thus, the urgency of innovative finance for wildlife conservation cannot be overemphasized.

The Philippines is home to several UNESCO World Heritage Sites that exemplify our country's unique and fragile biodiversity. Among them is the Puerto Princesa Subterranean River National Park, a marvel of nature that supports a diverse range of flora and fauna, including the endangered Palawan hornbill and the Philippine cockatoo. Another iconic site is the Tubbataha Reefs Natural Park, an underwater sanctuary teeming with marine life and serving as a vital breeding ground for various fish species, sea turtles, and sharks.

Equally significant are the Mount Hamiguitan Range Wildlife Sanctuary, a haven for rare species such as the Philippine eagle and the pygmy fruit bat, and the Ifugao Rice Terraces, which, beyond their cultural



significance, sustain diverse ecosystems and traditional farming practices that promote environmental balance. These sites are more than just picturesque landscapes; they are vital ecological zones that support both wildlife and human communities.

These precious sites face mounting threats. Deforestation, often driven by illegal logging and agricultural expansion, continues to diminish crucial habitats. Pollution, particularly plastic waste and chemical runoff, endangers marine ecosystems and the species that depend on them. Climate change accelerates coral bleaching in Tubbataha and disrupts ecological cycles, while poaching and illegal wildlife trade further deplete already endangered species.

If left unaddressed, these threats could lead to irreversible biodiversity loss, undermining not only ecological balance but also local economies that depend on ecotourism and sustainable natural resources.

Protecting the Philippines' wildlife and natural heritage requires a collective effort from

government agencies, local communities, private enterprises, and individuals. Strengthening environmental laws and enforcement is essential, particularly against illegal logging, mining, and wildlife trafficking. Investments in sustainable ecotourism can provide livelihood opportunities while promoting conservation.

Additionally, community engagement and education are key to fostering environmental stewardship. Indigenous knowledge and traditional practices should be integrated into conservation strategies to ensure that local communities become active partners in protecting their natural surroundings. Climate resilience measures, such as reforestation and coral reef restoration, must also be prioritized to mitigate the impacts of global warming.

As we mark World Wildlife Day 2025, let this be a clarion call for Filipinos to champion the protection of our UNESCO World Heritage Sites and the vast biodiversity they nurture. The responsibility to conserve our environment does not rest solely on policymakers or conservationists. It is a duty we all share.

he was advised to complete his documents but returned late.

"The SC has recognized that elections are not conducted under laboratory conditions—the Comelec must be prepared to make quick decisions in response to unforeseen circumstances that could undermine or subvert the will of the voters," the SC said.

The high court clarified that although Section 37 of Comelec Resolution No. 11045 provides that the incomplete COCs will neither be accepted nor stamped "received," even if submitted on time. But the

court suggested the poll body to "reexamine" whether its rules serve the interest of justice and fair play.

"Given these considerations, along with Balintay's unique circumstances, the SC found that the Comelec's strict application of its rules was unjustified, warranting the reversal of its decision," the SC said.

It can be recalled that on January 14, 2025, the SC had issued a temporary restraining order (TRO), preventing the COMELEC from implementing its decision rejecting Balintay's candidacy. **#batasph**
