PBBM inspects CALAX Cavite segment

Reaffirming his administration's commitment to enhance the country's infrastructure, President Ferdinand R. Marcos Jr. on Friday inspected the ongoing construction of the Cavite-Laguna Expressway (CALAX) Subsection 3, or the Governor's Drive Interchange in Cavite.

Subsection 3 of CALAX is the first in the Cavite segment and is targeted for full operation by the third quarter of 2025. Currently, it is 44 percent complete.

The other subsections of the Cavite segment are Cavitex Connection and Open Canal Interchange, while the fully operational Laguna segment includes Sta. Rosa, Tagaytay, Laguna Boulevard, Laguna Technopark, and Mamplasan Toll Barrier interchanges.

Once the Cavite segment is completed, the 44-km CALAX will significantly reduce travel time between CAVITEX and South Luzon Expressway (SLEX) by about 45 minutes and benefit up to 95,000 motorists daily.

It will also provide a seamless link between Metro Manila and Region IV-A (Cavite-Laguna-Batangas-Rizal-Quezon), improving the region's competitiveness as an investment destination. (PND)

PuroKalusugan Brings Essential Healthcare Services to Cavite



In celebration of World TB Day, Barangay Tua in Magallanes became the latest site for the Department of Health's (DOH) PuroKalusugan services on March 25, 2025. The community-based initiative aims to bring essential healthcare services directly to underserved communities, ensuring accessible and quality medical care for all.

During the event, a range of vital health services was provided. A total of 137 residents underwent chest X-ray screenings, while 80 individuals received skin consultations under the Kilatis Kutis program. The National Historical Commission of the Philippines (NHCP) condemned on Monday a photo of a Philippine flag taken during a peace rally of Filipino supporters of former president Rodrigo Duterte in Melbourne, Australia, where they imprinted a symbol of an eagle on the flag.

The NHCP cited Republic Act No. 8491, or the Flag and Heraldic Code of the Philippines, which punishes acts of adding any word, figure, mark, picture, design, drawing, advertisement, or imprint on the Philippine flag.

In return, customers who choose to skip plastic utensils will receive coupons per transaction. These coupons can later be redeemed for a free juice upgrade on the third order and a free Yum Burger on the fifth.

"We are not calling this a promo, but a campaign, because our goal is to create long-term behavioral change," said Eloise Anne Siccion, Assistant Vice President of

Trade Marketing Group, Jollibee Foods Corporation.

Building on the success of its 2023 launch in Batangas, Project 2.0 is now expanding its reach

across South Luzon, with DTI's CALABARZON, MIMAROPA, and Bicol Region offices joining the initiative alongside 280 Jollibee stores.

Stop Nukes and Listen: Building nuclear reactor won't solve the power crisis, push for renewables instead

Quezon City, Philippines — False narratives on dirty energy sources will not fly and fool the people. Climate justice groups have been saying: Nuclear energy, like other fossil fuels, is dirty, costly, and deadly.

The Philippine Movement for Climate Justice (PMCJ) strongly condemns the Philippine Nuclear Research Institute (PNRI), and other concerned government agencies, in partnering with a US nuclear energy company Valar Atomics with planning to build a "proof-of-concept" small micro reactor (SMR) in the Philippines.

SMRs, advanced nuclear reactors that have a power capacity of 300 MW per unit, were hoped to help bring down the cost of electricity in the Philippines. However, the Commonwealth Scientific and Industrial Research Organisation (CSIRO) reported that the cost of electricity generated from nuclear reactors by 2040 would be about \$145-\$238 per MWh, compared to \$22-\$53 for solar, and \$45-\$78 for wind; amounting to at least twice as much for nuclear, or up to 10 times when compared to the lowest-cost solar.

The PMCJ reiterates how, mortifyingly, the current administration of President Ferdinand "Bongbong" Marcos, Jr. (BBM) lacks all seriousness in pushing for renewable energy. Last 2023, BBM's administration signed the Agreement for Cooperation Concerning Peaceful Uses of Nuclear Energy or the 123 Agreement with the US. The agreement lays the legal framework for potential nuclear power projects with US providers.

Department of Energy (DOE) Undersecretary Sharon Garin shared in 68th International Atomic Energy Agency General Conference that the country targets to have

commercially operational nuclear power plants by 2032, with at least 1,200 MW initially entering the country's power mix, gradually increasing to 4,800 MW by 2050. This proves how dubious, if not ironic, the BBM administration is when it comes to the energy industry.

The push for nuclear energy is not only irrational, but also impractical. Aside from its limited life—it can only last for 30 to 40 years—decommissioning it will also cost as much. The Bataan Nuclear Power Plant was completed in 1984 but never operated. The Philippines borrowed approximately \$2.1 billion to build the plant, and the Filipinos finished paying for it in 2007—making the people pay for a good-for-nothing power plant that didn't even light a bulb.

The company, Valar Atomics, failed to provide pertinent information, not only on its history, but also the credibility of the SMR per se. In 2023, the DOE reported that it is looking for possible sites that can host small nuclear power plants.

The Philippines refuses to be a testing ground for these extremely harmful projects. Why does the government have the penchant to be sweet-talked by unverified, without any track record to speak foreign companies? What is the real deal here?

In times of crisis, our government should not prioritize profit and business over its people and the environment. Additionally, the Philippines does not possess the professional expertise of those who know how to run nuclear facilities

Zero-remittance week may do more harm than attain its goal


The planned zero-remittance week by supporters of former president Rodrigo Duterte, especially among overseas Filipino workers (OFWs), is sparking both concern and debate. This move, aimed at protesting Duterte's arrest and his eventual turnover to the International Criminal Court (ICC), seeks to send a bold message.

While the plan represents the passionate stand of Duterte's supporters, it is important to consider its long-term effects on the Philippine economy, the OFWs' families, and the future of the country's political landscape.

OFWs have long been hailed as the backbone of the Philippine economy. According to the Bangko Sentral ng Pilipinas, remittances from OFWs through banks alone amounted to \$34.49 billion, accounting for 8.3 percent of the country's gross domestic product (GDP) in 2024. The money sent home supports millions of Filipino families, providing for basic needs, education, healthcare, and even investments in small businesses. A week without remittances could create an immediate economic ripple effect that is certain to affect these families. Just imagine, a disruption in the steady flow of money could lead to missed payments for housing, tuition, or medical bills. The Philippine banking system and financial institutions could face challenges processing remittances, further complicating the situation for families who rely on this money for survival.

In addition to the immediate consequences for Filipino families, the protest could damage the broader economy. The Philippine peso, which has fluctuated in recent months, could experience additional volatility. The absence of remittance inflows could contribute to a weakening of the currency, leading to inflation and higher living costs for all Filipinos. Moreover, the financial institutions that rely on the steady stream of remittances could face significant disruptions, hurting not just families but local businesses, real estate, and the overall financial sector.

Beyond these practical concerns, what im-



pact would a zero-remittance week actually have on Duterte's legal predicament? It is unlikely to influence the ICC's actions or sway international opinion. The case against Duterte for alleged crimes related to his drug war is a matter of international law. The ICC, which operates independently of domestic political pressures, will continue to move forward based on its mandate. Duterte's detention in The Hague, or his legal battle in the Philippines, will not likely be altered by a week-long disruption of financial flows.

Moreover, the political landscape in the country is complex. While Duterte has significant support among certain sectors, the international community's stance on human rights violations is unlikely to be swayed by domestic protests of this nature. In fact, such actions could weaken the argument for Duterte's supporters, as they risk alienating other sectors of society who might not share the same viewpoint on his leadership.

Perhaps the most important question to consider is whether a zero-remittance week is the

most effective form of protest. While it may garner attention, the long-term effects on OFWs and their families may be counterproductive. The protest, though symbolic, risks isolating the very people whose livelihoods are being put in jeopardy. A more thoughtful form of protest could involve raising awareness about the issues surrounding Duterte's case through peaceful rallies, petitions, or digital campaigns. These actions would allow supporters to express their discontent without creating hardship for vulnerable families.

It is understandable that Duterte's supporters feel strongly about his ICC predicament, but the potential damage of a zero-remittance week should not be underestimated. Rather than resorting to actions that may harm OFWs and their families, it would be more constructive to pursue alternative means of protest that foster dialogue and awareness without inflicting unnecessary pain. In the end, the fight for justice should prioritize the well-being of all Filipinos, not just a few.

PCG probes Cavite ship collision

The Philippine Coast Guard (PCG) is investigating the collision between landing craft LCT Nicia and cargo ship MV Sangko Uno 66 in waters near Rosario, Cavite on Wednesday.

In an incident report, the PCG said LCT Nicia was traversing the said waters bound for Cebu while MV Sangko Uno 66 was on its way to the Pasay Reclamation Project from Zambales province when the incident occurred.

"No casualties were recorded and no oil spillage was observed in the vicinity waters of Rosario. However, the two vessels sustained minor damage," it said.

PCG Commandant, Adm. Ronnie Gil Gavan, ordered both vessels to go to Manila and cooperate with the PCG's Marine Casualty Investigation.

PCG aids Chinese crew off Basilan

Meanwhile, the PCG has also responded to a medical evacuation request of the Hong Kong-registered vessel MV Voy Trust in waters off Basilan Strait.

"The National Maritime Center received the vessel's request for medical evacuation as it transited near Zamboanga City," it said.

In response, PCG District Southwestern Mindanao deployed BRP Capones to attend to the injured crew member.

The injured crew member was given first aid and later transferred to a vehicle to travel by land to Brent Hospital in Zamboanga City.

The Chinese national has since been turned over to the ship's local agent, Albert Abanilla, for further assistance. (PNA)
