Remulla's unopposed running mate, Sen. Bong Revilla's son Ram Revilla Bautista, was proclaimed vice governor-elect.

Speaking to the media, Remulla said he and

Revilla Bautista have big shoes to fill, given their families' political backgrounds.

"We're standing on the shoulders of giants. Our job here is to make sure we forge our own paths, create our own legacies, while taking into consideration the steps that our forefathers have done before," Remulla stated.

Biography of Pope Leo XIV, born Robert Francis Prevost

Prior to his election as Pope Leo XIV, Cardinal Robert Francis Prevost was Prefect of the Dicastery for Bishops. Here is the biography of the 267th Bishop of Rome:

The first Augustinian Pope, Leo XIV is the second Roman Pontiff - after Pope Francis - from the Americas. Unlike Jorge Mario Bergoglio, however, the 69-year-old Robert Francis Prevost is from the northern part of the continent, though he spent many years as a missionary in Peru before being elected head of the Augustinians for two consecutive terms.

First Augustinian Pope

The new Bishop of Rome was born on September 14, 1955, in Chicago, Illinois, to Louis Marius Prevost, of French and Italian descent, and Mildred Martínez, of Spanish descent. He has two brothers, Louis Martín and John Joseph.

He spent his childhood and adolescence

with his family and studied first at the Minor Seminary of the Augustinian Fathers and then at Villanova University in Pennsylvania, where in 1977 he earned a Degree in Mathematics and also studied Philosophy.

On September 1 of the same year, Prevost entered the novitiate of the Order of Saint Augustine (O.S.A.) in Saint Louis, in the Province of Our Lady of Good Counsel of Chicago, and made his first profession on September 2, 1978. On August 29, 1981, he made his solemn vows.

The future Pontiff received his theological education at the Catholic Theological Union in Chicago. At the age of 27, he was sent by his superiors to Rome to study Canon Law at the Pontifical University of Saint Thomas Aquinas

(Angelicum).

In Rome, he was ordained a priest on June 19, 1982, at the Augustinian College of Saint Monica by Archbishop Jean Jadot, then pro-president of the Secretariat for Non-Christians, which later became the Pontifical Council for Interreligious Dialogue and then the Dicastery for Interreligious Dialogue.

Prevost obtained his licentiate in 1984 and the following year, while preparing his doctoral thesis, was sent to the Augustinian mission in Chulucanas, Piura, Peru (1985-1986). In 1987, he defended his doctoral thesis on "The Role of the Local Prior in the Order of Saint Augustine" and was appointed vocation director and missions di-

province remains vibrant, resilient, and forward-thinking, supporting both new and existing enterprises.

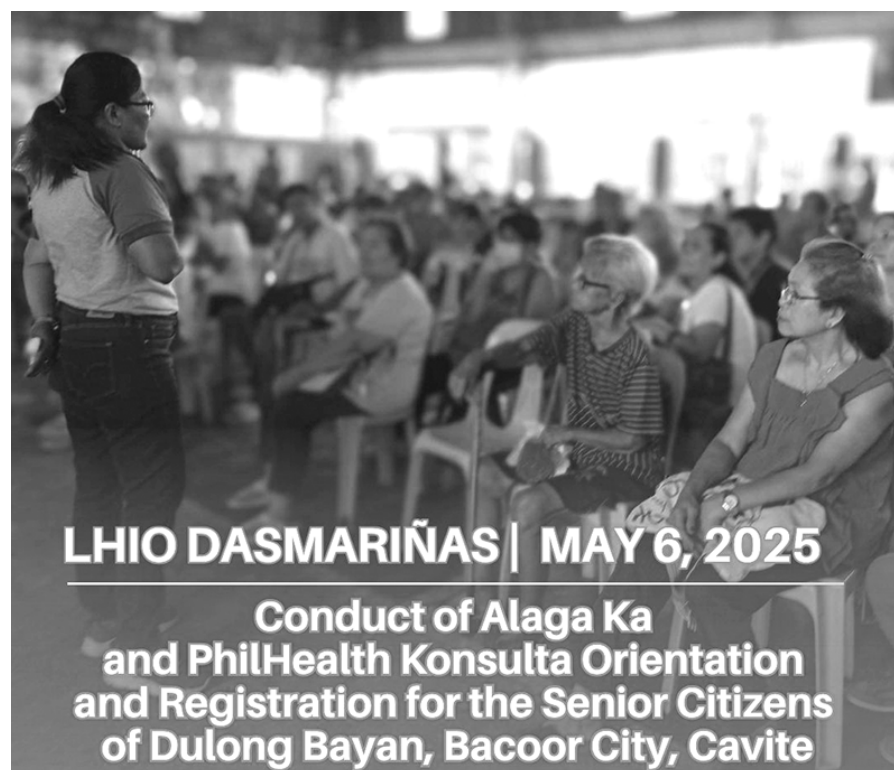
As the event concluded, DTI-Laguna reiterated its dedication to supporting the growth

Editorial

Govt finally getting on track with the economy

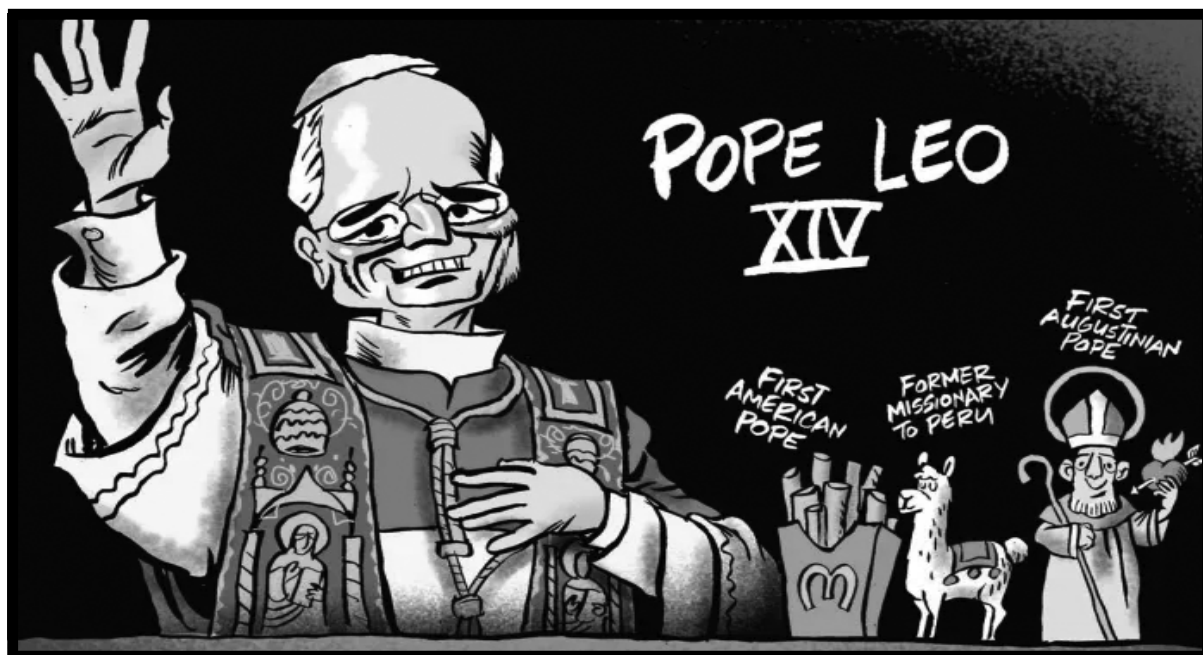
The gross domestic product (GDP) growth data for the first quarter (Q1) of the year (January through March) was released by the Philippine Statistics Authority, and the news was largely encouraging. Although the 5.4-percent GDP growth rate for Q1 fell below the government's target and almost every expert forecast, there were some positive signs in the outcome, not least of which are some welcome indications that our policymakers are finally looking at the chaotic global environment with some realism.

The 5.4-percent GDP growth rate was significantly lower than the 5.9 percent recorded in the same quarter a year earlier, although it was slightly higher than the 5.3-percent pace in the fourth-quarter 2024. The first-quarter result was significantly below the 6.0- to 8.0-percent target set by the government for 2025, and well below the consensus of analysts polled by The Manila Times, who expected a 5.8-percent result.

Socioeconomic Planning Undersecretary Rosemarie Edillon provided what could be considered the official government take on the Q1 GDP result, saying that it showed a "measured start" to the year, one that has "many layers."

"While this pace (5.4 percent) falls short of our initial expectations, it reflects developments from the broader global context of tempered economic activity amid persistent uncertainties," she added.

To better understand the first-quarter result and what it means for the Philippines' economy going forward, it is helpful to recall what was happening in the world during the first three months of the year. Broad economic uncertainty formed almost instantly upon the inauguration of United States President Donald Trump. Trump immediately got to work creating chaos by ordering massive cuts to US foreign aid spending, the gutting of numerous US government agencies with mass layoffs and the closure of a number of key offices, launching a campaign of mass deportations and issuing threats of invasion — in one form or another — of Canada, Panama and Greenland. Trump also warned of impending punitive tariffs the US would impose



on almost every country, although that would not actually happen until the beginning of April.

Elsewhere in the world, the Israeli campaign to destroy Gaza proceeded unabated, as did the war in Ukraine, neither helped by Trump's fumbling attempts to act as a mediator. Critical election campaigns in Canada and Australia were also in full swing, with some uncertainty about the eventual outcome of those, and there was a federal election in Germany, the campaign for which featured, most alarmingly, open but ultimately unsuccessful interference by Trump partner and "unofficial" US official Elon Musk in support of the neo-fascist Alternative for Germany party.

There was also one large-scale natural disaster during the quarter, a powerful earthquake that struck Myanmar on March 28. At least 3,700 people were killed, including a number in neighboring Thailand.

Against this backdrop, which encouraged most of the world to begin preparing itself for worse to come in the rest of 2025, the Philippine economy did rather well. It was likely supported to some extent by businesses and consumers "front-loading" purchases in anticipation of Trump's tariffs, and it was certainly supported by increased spending ahead of

Monday's (May 12) midterm election. As Undersecretary Edillon pointed out, below target or not, the Q1 growth pace was second only to Vietnam's 6.9 percent and equal to China's first-quarter result.

While the government's 6.0- to 8.0-percent growth target for this year continues to be unreasonably optimistic, we take encouragement from some statements made by the government that indicates it is looking at the first quarter's largely positive result as a stable foundation on which to build a response to whatever might happen in the rest of the year. These include a focus on developing trade, improving the investment environment, and supporting small and medium enterprises. Efforts to keep inflation low are also continuing, which may seem unnecessary given the historically low current rate of 1.4 percent, but most external indicators point to higher inflation in the coming months, so this is a proactive stance on the part of the government.

All in all, the sense we have from the government's current perspective on the economy is that it is focusing on maximizing what the country has to work with in an uncertain environment. That is the right way to look at things at this time.

rector of the Augustinian Province of "Mother of Good Counsel" in Olympia Fields, Illinois (USA).

Mission in Peru

The following year, he joined the mission in Trujillo, also in Peru, as director of the joint formation project for Augustinian candidates from the vicariates of Chulucanas, Iquitos, and Apurímac.

Over the course of eleven years, he served as prior of the community (1988-1992), formation director (1988-1998), and instructor for professed members (1992-1998), and in the Archdiocese of Trujillo as judicial vicar (1989-1998) and professor of Canon Law, Patristics, and Moral Theology at the Major Seminary "San Carlos y San Marcelo." At the same time, he was also entrusted with the pastoral care of Our Lady Mother of the Church, later established as the parish of Saint Rita (1988-1999), in a poor suburb of the city, and was parish administrator of Our Lady of Monserrat from 1992 to 1999.

In 1999, he was elected Provincial Prior of the Augustinian Province of "Mother of Good Counsel"

in Chicago, and two and a half years later, the ordinary General Chapter of the Order of Saint Augustine, elected him as Prior General, confirming him in 2007 for a second term.

In October 2013, he returned to his Augustinian Province in Chicago, serving as director of formation at the Saint Augustine Convent, first councilor, and provincial vicar—roles he held until Pope Francis appointed him on November 3, 2014, as Apostolic Administrator of the Peruvian Diocese of Chiclayo, elevating him to the episcopal dignity as Titular Bishop of Sufar.

He entered the Diocese on November 7, in the presence of Apostolic Nuncio James Patrick Green, who ordained him Bishop just over a month later, on December 12, the Feast of Our Lady of Guadalupe, in the Cathedral of Saint Mary.

His episcopal motto is "In Illo uno unum"—words pronounced by Saint Augustine in a sermon on Psalm 127 to explain that "although we Christians are many, in the one Christ we are one."

On September 26, 2015, he was appointed Bishop of Chiclayo by Pope Francis. In March 2018, he was elected second vice-president of the Peruvian Episcopal Conference, where he also served as a member of the Economic Council and president of the Commission for Culture and Education.

In 2019, Pope Francis appointed him a member of the Congregation for the Clergy (July 13, 2019), and in 2020, a member of the Congregation for Bishops (November 21). Meanwhile, on April 15, 2020, he was also appointed Apostolic Administrator of the Peruvian Diocese of Callao.

Prefect of the Dicastery for Bishops

On January 30, 2023, the Pope called him to Rome as Prefect of the Dicastery for Bishops and President of the Pontifical Commission for Latin America, promoting him to the rank of Archbishop.

Created Cardinal in 2024

Pope Francis created him Cardinal in the Consistory of September 30 that year and assigned him the Diaconate of Saint Monica. He officially took possession of it on January 28, 2024.

As head of the Dicastery, he participated in the Pope's most recent Apostolic Journeys and in both the first and second

sessions of the 16th Ordinary General Assembly of the Synod of Bishops on synodality, held in Rome from October 4 to 29, 2023, and from October 2 to 27, 2024, respectively.

Meanwhile, on October 4, 2023, Pope Francis appointed him as a member of the Dicasteries for Evangelization (Section for First Evangelization and New Particular Churches), for the Doctrine of the Faith, for the Eastern Churches, for the Clergy, for Institutes of Consecrated Life and Societies of Apostolic Life, for Culture and Education, for Legislative Texts, and of the Pontifical Commission for the Vatican City State.

Finally, on February 6 of this year, the Argentine Pope promoted him to the Order of Bishops, granting him the title of the Suburbicarian Church of Albano.

Three days later, on February 9, he celebrated the Mass presided over by Pope Francis in St. Peter's Square for the Jubilee of the Armed Forces, the second major event of the Holy Year of Hope.

During the most recent hospitalization of his predecessor at the "Gemelli" hospital, Prevost presided over the Rosary for Pope Francis's health in Saint Peter's Square on March 3. **(Source: Vatican News)**
