

DOST and PEZA Complete Nationwide Orientation of 33 HEIs to Propel Innovation-Driven Regional Economic Growth through KIST Ecozones

The Department of Science and Technology (DOST), in collaboration with the Philippine Economic Zone Authority (PEZA), successfully completed the Virtual Orientation Series on the Knowledge, Innovation, Science and Technology (KIST) Ecozone Program. Held every Tuesday from May 13 to June 17, 2025, the series aimed to guide higher education institutions (HEIs) in preparing their applications to become registered KIST Ecozone Developers.



The KIST Ecozone Program is a strategic initiative by DOST and PEZA that seeks to establish special economic zones within HEIs. Formally

recognized through PEZA registration and Presidential Proclamation under Republic Act 7916 (Special Economic Zone Act), these university-

based ecozones will foster interdisciplinary collaboration, promote technopreneurship, and accelerate commercialization of research and

development outputs. By linking academe, industry, and government, these ecozones are envisioned to drive innovation, create quality jobs, support high-value industries, and contribute to advancing the goals of the Philippine Development Plan 2023–2028.

The virtual orientation series was part of the joint effort of DOST and PEZA to operationalize the DOST-PEZA Joint Memorandum Circular No. 2023-001 and DOST Memorandum Circular No. 001 s. 2024, which provides the policy and

procedural framework for the establishment of KIST Parks/Ecozones across the country.

The series opened with strong support from national leaders. DOST Secretary Renato U. Solidum Jr., PEZA Director General Tereso O. Panga, and DOST Undersecretary for Regional Operations Sancho A. Mabborang underscored the transformative potential of KIST Ecozones in turning HEIs into innovation hubs, strengthening university-industry linkages, and driving inclusive, regional economic growth.


Each weekly session offered comprehensive guidance on the KIST Park/Ecozone application process, including the requirements and evaluation procedures. The sessions also featured an open forum where participants from HEIs engaged with resource persons from both DOST and PEZA.

Representing DOST were Ms. Emelita P. Bagsit (Regional Director, DOST CALABARZON) and Engr. Melvin P. Jusi (Project Development Officer IV, DOST Office of the Undersecretary for Regional Operations). From PEZA's Ecozone Development Department, participating offi-

cials included Mr. Ludwig O. Daza (Department Manager), Ms. Liza S. De Vera (Division Chief III), and Ms. Nancy F. Vargas (Project Evaluation Officer IV). Together, they addressed technical, procedural, and policy-related concerns, and offered practical guidance to support HEIs in navigating the KIST Ecozone application and development process.

Throughout the six-week program, a total of 33 HEIs/SUCs were successfully oriented nationwide, with participation from 17 DOST Regional Offices and select local government units across various regions. The orientation series marks a critical step in accelerating the implementation of the KIST Ecozone Program and building a more innovation-driven economy.

With sustained collaboration and growing interest among academic institutions, DOST and PEZA remain hopeful that by 2028, at least seven KIST Parks will be proclaimed and/or established across the country—anchoring a future where science, technology, and innovation serve as the foundation for inclusive, sustainable, and globally competitive regional development. *(By Jeric H. PH hydrogen potential should be explored, but sensibly


LAST week, we reported on the discovery of a substantial apparent reserve of natural hydrogen gas in the ground around the small town of San Antonio, Zambales, as detailed in a research study led by the Department of Science and Technology-Philippine Nuclear Research Institute (DOST-PNRI). As natural hydrogen is somewhat rare, this discovery could represent a valuable energy asset for the Philippines. Its potential should be carefully studied, and the government should give such research as much support as it requires.

However, the study should be approached with reasonable expectations, and above all, should carefully avoid treading the path of sensationalism in informing the public of developments. Unfortunately, the speculative conclusions of the initial study have already leaped some distance down that path, and some correction and clarification are in order.

The significance of a discovery of natural hydrogen is that it is relatively rare; hydrogen is the most common element in the universe, but it is also the most reactive, and is usually found in combination with other atoms, such as in water. Hydrogen is most commonly produced as a by-product of oil and gas refining, and can be produced through electrolysis of water using either renewable or nonrenewable energy sources. It has a number of industrial uses, one of the most common being in the production of ammonia for fertilizer, and is the "fuel" in electricity-producing fuel cells, where it is combined with oxygen across a catalyst to produce electricity, water vapor and heat. On its own, hydrogen is a poor fuel for use in things like engines, heaters or stoves, but it can be combined with other fuels such as natural gas to reduce greenhouse gas emissions in power plants or metal refineries.

As the use of hydrogen in energy production does not produce carbon dioxide emissions, it is considered a critical resource for the transition to sustainable green energy, as the DOST-PNRI study quite rightly points out.

A great deal of research and development into the production and use of hydrogen is



already being carried out worldwide, and the Philippines would be remiss not to do the same, given the potential for having a large reserve of natural hydrogen beneath our own feet.

However, "potential" is the key word in that assertion. The presence of natural hydrogen is usually detected by gas seeps, which seems to be the case in the Zambales discovery, but the size of the gas deposit producing those natural leaks can only be inferred through the presence of specific geologic formations and processes, or the presence of natural gas or oil. Thus, estimates of natural hydrogen reserves are at best highly uncertain; the apparent Zambales reserve may indeed be the "world's largest," but there is no way to credibly make that claim without inserting the word "estimate" in there somewhere.

In any event, the size of the reserve is not as relevant as whether or not it is economically accessible, and unfortunately, at the moment there is no natural hydrogen reserve in the world (others exist in the African nation of Mali, Australia, Spain and France) where that is the case. The best technology available at the moment is fracking, or injecting high-pressure water into

rock layers to drive out the gas; it is an energy-intensive and highly polluting method of gas extraction, and something that may be too expensive, too environmentally damaging, or simply infeasible in Zambales. For the DOST-PNRI study to make a claim that the hydrogen seep "could potentially supply a significant portion of the town's electricity needs, a welcome prospect for many households in the area that still has no supply of electricity," is an irresponsible promise, even if it is a qualified one.

The Zambales hydrogen discovery is not "a historic milestone" or a "game changer in the quest for clean energy." What it is instead is a golden opportunity for the Philippines to take a leading role in hydrogen, and green energy research and development, and presenting the discovery in that light would not only be more honest, it would help to gain the public support needed for sustained government investment into that research and development. We certainly hope the government and interested private-sector partners will pursue it, because any new knowledge gained will benefit not only the Philippines, but the entire world.

4. Gawin komportable ang kuwarto - Gawing maaliwalas o hindi mainit sa pakiramdam ang kuwarto, maaring bumili ng aircon kung kinakailangan. Linisin ng madalas ang aircon para maiwasan ang pagdami ng bacteria at amag.

5. Paginhawahin ang lalamunan - Magmumog ng maligamgam na tubig na may halong asin sa umaga. Uminom ng maligamgam na lemon na may halong honey, dahil ito ay nakatutulong na mapaginhawa ang sakit ng lalamunan pati na rin ang ubo.

6. Gumamit ng pang-patak sa ilong (nasal spray) - Ang saline spray sa ilong ay epektibo, ligtas gamitin at hindi naka-i-irita. Puwede din gamitin sa bata, para guminhawa ang baradong ilong.

of Director for Visayas, Giecel Albar, publisher of Akeanon News Publishing Services; and Re-elected Board of Director for Mindanao Elpedio Bermas Soriano Jr., publisher of Peryodista Publications, and Joseph Denmarc Miranda Avila, publisher of Eagles Journal.

Held concurrently with its national elections and the mid-year general assembly, bearing the theme 'Fighting Fake News as a United Mission,' National Press Club President Leoniel Abasola, Dr. Lily Lim, and the Presidential Task Force on Media Security (PTFMS) Undersecretary, Joe Torres Jr. extended their message of support towards the organization, expressing their immense gratitude to PAPI for their enduring partnership over the years.

In his speech, Torres ensured that the status of the late-Chairman Emeritus of PAPI, Juan "Johnny" P. Dayang Sr., is taken into careful investigation to obtain justice in its right order. Dayang was shot and killed in the evening of April 29 by now-identified gunmen at his house in Kalibo, Aklan, where he served as its former officer-in-charge mayor after the 1986 Philippine Revolution.

Additionally, veteran broadcast journalist and

re-appointed Secretary of the Presidential Communication Office (PCO), Jay Ruiz, showed his full support to the outgoing President, Nelson Santos, and PAPI by attending the event and delivered a speech that empowered wise and critical decisions among the publishers in the age of digital media and the need to forge a collaborative effort in fighting relentlessly with fake news, hence imposing penalties to fake news peddlers.

"Kailangan tayo magkaisa, labanan natin itong fake news, at i-impose na dapat sila rin magbayad ng buwis, magkaroon [ng] kahit na papaano regulasyon o pananagutan kung yung plataporma mo ay nagagamit sa fake news," Ruiz mentioned.

"Maganda po yung relationship ng PAPI at ng PCO, at 'yan po ay magpapatuloy habang nandito po kami. Tiyak po 'yan. Kasi nais naming ipa-abot sa mamamayang Pilipino - hindi lang dito sa Metro Manila, kundi sa buong Pilipinas na ang gobyernong Marcos ay para sa tao. Magtulungan po tayong ipa-abot ang mga programa, aktibidades, at mga polisiya ng gobyerno," he added.

Hence, alongside the assembly and elections,

PAPI then paid tribute to the 90th birthday of Dayang where his son, Consul General to Turkey Juan "Jed" Dayang Jr., expressed his heartfelt thanks to the organization through a video message emphasizing that remembering is not enough - if his father were truly honored, shall the memories, contributions, and the legacy left by his father, not only with the organization, but also all over the country that had helped flourish the press freedom, must be carried forward.

"He believed that journalism was never about comfort, it is about courage. So I ask of you now, let's not reduce his death to a headline, let's not treat this tribute as a farewell - let it be a signal, a challenge, a commitment to speak when it is dangerous, to write when it is unpopular, to never trade truth for access, or silence for safety," Dayang said.

In high hopes for the new board members, Jed Dayang also mentioned in his video to continue fighting for press freedom, and moving forward, as their family will always be there to support the organization, just like what his father used to do.

The newly elected officials are set to take office after their oath-taking, which is yet to be announced by the new board, and will serve until 2028. **(Binsoy Velasquez)**

Inspired by her experience abroad and the increasing demand for affordable, high-quality printing services in her hometown, Ms. Saldo established Medmed Prints to offer a wide range of personalized items including mugs, T-shirts, vinyl stickers, and invitation cards. Her application to the iFWD PH Program in 2024 marked a turning point; after completing Phase 1, which focused on core business development capacity building, she proceeded to Phase 2, requesting DOST's innovation support to upgrade her enterprise and improve production facilities.
