Gaokao opens the door wider for all

Amid China's 2025 national college entrance examination, known as gaokao, scenes of quiet determination played out across the country.

In Suzhou, east China's Anhui province, Wang Ziwen, a student with osteogenesis imperfecta, also known as "brittle bone disease", was gently assisted into the exam hall by staff. In Ziyang, southwest China's Sichuan province, Jiang Xintong, paralyzed from the waist down due to myelitis, arrived at the examination room 30 minutes early via a special access route. In Shenzhen, Guangdong province in south China, Chen Xinhe, the only fully blind candidate in the province, took his braille exam with the support of special education teachers, a counselor, and medical staff arranged by the test center.

These touching moments reflect not only the resilience of the examinees, but also the progressive enhancement of inclusivity measures within China's education system.

Reasonable accommodations for examinees with disabilities are now systematically standardized: Blind candidates receive 150% of the standard exam duration; those with hearing impairments may utilize assistive devices such as

hearing aids or cochlear implants; candidates with severe upper limb disabilities or those with severe writing difficulties are granted a 30% time extension.

This year, among the 13.35 million students who registered for gaokao, over 14,000 candidates with disabilities qualified for specialized support - a stark contrast to the mere 100 students in 2012 - representing a 140-fold increase in just over a decade.

Gaokao has long been regarded in China as one of the most equitable systems for talent selection. This perception stems not only from its rigorous procedures and transparent mechanisms, but also from its institutional inclusiveness - offering individuals from all socioeconomic backgrounds an equitable pathway to pursue academic aspirations. For candidates with disabilities, this educational access constitutes a profound motivator.

The rights to survival and development are among the most fundamental human rights. As China advances economically while strengthening public services and

social security systems, the basic needs of people with disabilities are increasingly met. Building upon this foundation, more attention now focuses on fulfilling their self-actualization aspirations. The once-exceptional practice of requesting examination accommodations has evolved into standardized practice, exemplifying how a modern society elevates vulnerable populations through systemic compassion..

Education is essential to the holistic human development. As of 2024, China has more than 915,900 students enrolled in special education programs. Initiatives such as assistive device access in schools, large-print textbooks included in the national curriculum, as well as flexible programs like home-based instruction and remote learning, have helped special education steadily advance, creating a pathway for students with disabilities to achieve personal growth and success. While individual journeys differ, inspiring stories multiply of students overcoming physical challenges to lead fulfilling lives.

Beyond education,

China is working to improve support across the full spectrum of life.

In employment, tailored job assistance for college graduates with disabilities and local job creation projects have been rolled out, and more than 9 million people with disabilities were employed across China in 2024.

In healthcare, dynamic adjustment mechanisms for severe disability care subsidies are being refined, and participation in disability-inclusive health insurance programs continues to rise. A more comprehensive and tightly woven support network, ranging from daily care to medical treatment, is

being built to better empower people with disabilities in their pursuit of aspirations.

Through equitable, inclusive, and accessible approaches to public welfare, China is striving to ensure that the benefits of development are shared by all, regardless of physical conditions. (By Li Xinshu)

Clarin town in Misamis Occidental declares climate emergency; commits to addressing the climate crisis

Quezon City, Philippines — The Philippine Movement for Climate Justice (PMCJ) lauds the local government unit (LGU) of Clarin, Misamis Occidental, for doing its part in addressing the global climate crisis by declaring a climate emergency through a resolution.

LGUs across the province of Misamis Occidental to adopt similar declarations and take urgent climate action.]

This was made possible through the coordination of Gitib, Inc., Youth for Climate Justice (Y4CJ) Misamis Occidental, the Children and Youth Movement in Misamis Occidental, PMCJ Western Mindanao Chapter, and the Clarin LGU.

"Tukma sa panahon ang deklarasyon sa climate emergency aron epektibong maatubang sa katawan ug sa mga LGU ang maong hulga. Angayang suportahan ang kasamtangang deklarasyon for climate emergency sa LGU Clarin, Misamis Occidental ug naga commit ang PMCJ chapter sa pakigtinabangay sa LGU ug ubang mga grupo para mahimong epektibo ug beneficial sa mga katawan ug kabataan sa Clarin ang maong lakang. Hagit usab kini sa ubang LGU sa tibuk probinsya sa Misamis Occidental sa paghimo og susamang deklarasyon," said Roldan Gonzales, chairperson of PMCJ Western Mindanao Chapter. [The declaration of a climate emergency is timely and necessary so that the people and local governments can respond effectively to this growing threat. We strongly support the current Climate Emergency Declaration of the LGU of Clarin, Misamis Occidental, and the PMCJ chapter commits to working in solidarity with the LGU and other sectors to ensure that this declaration becomes effective and truly beneficial for the people—especially the children and youth of Clarin. This also serves as a challenge to other

communities who are already experiencing the harsh impacts of climate change. Thank you for listening to the voices of the youth, for walking alongside us, and for prioritizing the safety and well-being of future generations. [...] Let Clarin inspire other communities across the country—showing that change is possible when we act together.]

The people of Misamis Occidental have staunchly fought against fossil fuels. In 2021, the province was one of the areas that had confirmed derailed coal projects in the pipeline.

"In 2022, the Department of Environment and Natural Resources (DENR) canceled the environmental compliance certificate (ECC) of Ozamiz Power Generation Inc. (OPGI) for its proposed 300-megawatt facility in Ozamiz City. Over the years, Misamis Occidental has actively participated in and initiated discussions, forums, and other activities to sustain its commitment to advancing the global fight for climate justice. Just last March 2025, PMCJ, Gitib, Inc., and other local organizations successfully hosted a forum in Sinacban, focusing on the just transition to renewable energy," PMCJ National Coordinator Ian Rivera said.

Rivera emphasized the importance of these types of advancements undertaken by subnational governments in our push for a national declaration of a climate emergency. "The communities in the provinces are experiencing the worst climate crisis impacts. We welcome and commend the LGUs that actively protect and fight alongside their constituents in attaining climate and social justice. Together, we challenge the national government to look at the efforts of the LGUs and try to keep up," he stressed.

Editorial

Transparency would help

To say that China has no love lost for Defense Secretary Gilberto Teodoro Jr. would be an understatement. Since he assumed the defense portfolio in 2023, Teodoro has been a vocal and passionate voice in defense of Philippine sovereignty in the West Philippine Sea, and a consistent and outspoken critic of Chinese aggression in our waters.

He has also been at the forefront of a military buildup in response to China's belligerent behavior toward our ships and boats in areas that are clearly within our exclusive economic zone. It was no surprise, then, that the good secretary questioned the motives behind an exclusive story in The Manila Times on July 14 that revealed he obtained a Maltese passport in 2016, suggesting he once held dual citizenship, which would have disqualified him from holding high government positions.

In response to the story, the Department of National Defense (DND) issued a terse statement saying Teodoro had, in fact, surrendered his Maltese passport in 2021 and that he had renounced his dual citizenship before he ran for the Senate in 2022.

The DND said the passport's existence was disclosed to the Bureau of Immigration and the Commission on Elections before the 2022 polls, and to the Committee on Appointments before Teodoro's confirmation as defense secretary. "The motive of this rumor is clear and known to Secretary Teodoro. The timing of the article adds to this motive," it added.

The short response did two things. First, it confirmed that the secretary did, in fact, hold a Maltese passport. Second, it left important questions unanswered, such as why he felt the need to obtain a second, foreign passport, and how he went about acquiring it.

Perhaps unsatisfied with the DND response, Teodoro told a radio interview that the Maltese passport issue was "not just fake news, but a smear campaign." Teodoro said someone had told him the issue would be raised, but he had brushed it off, as he was no longer a dual citizen.

"Now that I'm thinking about it, how it was done was very comprehensive because it was planted in a newspaper known for criticizing our policies against China," Teodoro said in English and Filipino.

It is, perhaps, important at this point to as-



sure the good secretary that we at The Manila Times despise "fake news" as much as he does, and that while our opinion pages are home to a wide range of views, our editorials have consistently been pro-Filipino and often critical of Chinese aggression in the West Philippine Sea. This is not fake news; anyone can check the archives to verify this point.

If the secretary was concerned he would be a target of a smear campaign, he could have simply responded to the numerous attempts that The Manila Times made to obtain his comment. The reporter assigned to the story contacted several numbers obtained from reliable sources said to be associated with Teodoro, but the calls went unanswered (Saturday, July 12). Our reporter also tried to reach DND spokesman Arsenio Andolong through the mobile number he is officially known to use. However, those calls were either not answered or the messages sent had not been read up to July 14, the day the story in question was published.

In his message to Andolong and phone conversations with personnel on July 12 and 13, the reporter explicitly stated that The Manila Times was preparing a sensitive and urgent story involving the DND, and respectfully requested an official contact number or any means by which Secretary Teodoro could be

reached to provide his side or an official statement. This request was also left unanswered.

Given the sensitive nature of the issue, we suggest some candor and greater transparency should have been shown.

For instance, did the secretary obtain his passport through Malta's controversial "golden passport" program, which allows wealthy individuals to obtain Maltese, and by extension, European Union citizenship, in exchange for substantial financial investments? Reports say Malta's scheme required a minimum contribution of €600,000 (roughly P39.7 million) to the Maltese government. Did the secretary, in fact, become a substantial investor to obtain his dual citizenship, before the European Court of Justice compelled Malta to terminate the said program in 2025? In the pursuit of truth and in the spirit of transparency, we would certainly welcome having the secretary speak with us face-to-face to clear the air. This would be far better than issuing press statements that leave no room for clarification.

For, in truth, we support many of Secretary Teodoro's actions to protect Philippine interests in the West Philippine Sea. This does not mean, however, that any questionable actions should be swept under the rug, simply because they might be used by opposing interests.

4. Sa breastfeeding, mababawasan ang pagtataas at pagsusuka ng bata. Hindi ito katulad ng gatas sa bote na hinahaluan pa ng tubig na posibleng kontaminado ng bacteria. Malinis pa ang suso ng nanay kumpara sa bote.

5. Sa breastfeeding, mababawasan ang

pagkakaroon ng hika, ubo, pulmonya, allergy at eczema. Makaiwas din sa pagkasira ng ngipin.

6. Mas matalino ang bata na nagpapa-breastfeed. Ayon sa pagsusuri, tataas ang kanilang pagkatalino ng 10 to 12 IQ points.

Benepisyo Para sa Nanay:

1. Kapag nagpapadede ang nanay, hindi siya agad mabuntis.

2. Ang nanay ay magiging mas malapit sa kanyang anak. Kakaiba ang kanilang bonding.

They are legally supported and encouraged. The 1987 Philippine Constitution clearly states that the state shall give priority to education, arts, culture, and sports to promote human development. Every game and activity at the local level is backed by this national vision.


