DOT launches Philippine Golf Experience to boost PH tourism promotion

Clark, Pampanga—Positioning the Philippines as a premier golfing destination, the Department of Tourism (DOT) officially launched the first-ever Philippine Golf Experience (GolfEx) on Friday (August 29) at Clark, Pampanga, one of the country's emerging golf and leisure hubs—marking a major step in integrating golf into the country's tourism agenda.

GolfEx is a pioneering initiative of the Department designed to showcase the country as a premier golf destination. It is modeled after the DOT's flagship Philippine Experience Program: Heritage, Culture, and Arts Caravans (PEP) launched nationwide.

Tourism Secretary Christina Garcia Frasco led the ceremonial tee-off at the scenic Mimosa Plus Golf Course, where she was joined by Senator Lito Lapid, members

The Department of Science and Technology Region 02 (DOST), under the leadership of the Regional Director Dr. Virginia G. Bilgera, conducted a two-day monitoring activity for Small Enterprise Technology Upgrading Program (SETUP) beneficiaries in Cagayan Province on August 26–27, 2025.

The activity, organized by the Regional Project Management Office (RPMO) in collaboration with the Provincial Science and Technology Office (PSTO)—Cagayan and with the participation of the Commission on Audit (COA), was carried out to evaluate the progress of funded projects and ensure the proper use of government resources.

As part of the monitoring, the team visited project sites, validated

implementation milestones, and inspected equipment provided under the program. These efforts allowed the group to measure the impact of SETUP on local enterprises and to identify additional areas where support is needed to strengthen business competitiveness.

Since 2023, a total of 26 micro, small, and medium enterprises (MSMEs) in Cagayan have received ₱32 million

in SETUP support. With this assistance, enterprises have been able to adopt innovative technologies, boost productivity, and expand their market reach.

Through these initiatives, DOST Region 02 reaffirmed its commitment to continuously support MSMEs by providing regular monitoring, technical guidance, and science- and technology-based solutions to drive sustainable enterprise growth.

class golf destination. What was needed was a deliberate effort to place golf within our broader national strategy, not only as a sport, but as an experience that brings together play, culture, as well as community," Secretary Frasco emphasized in her speech.

The tourism chief said that under the Marcos Administration, the DOT pivoted to an innovative approach that not only counts the country's tourist arrivals but also puts a premium on measuring the value of tourist offerings.

"Tourism, after all, is not only about how many people have arrived, but rather about how many livelihoods it sustains, how many enterprises it strengthens, and how deep the pride of place it nurtures across our communities. Golf captures this most beautifully—for when done sustainably, golf is a high-value, low-impact form of tourism that draws travelers to stay longer, spend more, and engage more deeply with our destinations, not to mention come back again and again," she noted.

With the presence of partners from the public and private sectors, as well as members of the Diplomatic Corps, she said that the event strengthens partnerships among all stakeholders by likewise campaigning for the Philippines as a

destination for tourist source and opportunity markets.

Furthermore, the Secretary described that the launch of GolfEx in Clark "is no coincidence" as the emerging leisure golf and leisure hub now has a world-class international airport and facilities.

For her part, Atty. Devanadera expressed confidence in Clark's readiness to host major golf tournaments and other sporting events.

"Clark is ready for the golf tournaments and all kinds of sports tournaments, and we would like to inform you, and to show you, that the secret here is synergy—synergy among the locators, synergy with the government agencies, synergy with our foreign friends, and above all, the leadership of the Department of Tourism, under, of course, the guidance of our President," she said.

Also present at the kickoff event are Global Tourism Business Association (GTBA) Founder and Chairman Michelle Taylan, Tourism Congress of the Philippines President (TCP) James Montenegro, and DOT Undersecretaries Shahlimar Hofer Tamano and Ferdinand Jumapao, Tourism Infrastructure and Enterprise Zone Au-

thority (TIEZA) Chief Operating Officer Mark Lapid, Assistant Secretaries Judilyn Quiachon and Ronald Conopio, Director for Golf Tourism Lyle Uy, DOT-3 Regional Director Richard Daenos, and other officials of the DOT Central and Regional Offices.

The event highlighted basic golf lessons facilitated by the Professional Golfers Association of the Philippines, Inc. (PGAP) through the Mimosa Plus Golf Academy. While the members of the Diplomatic Corps, professional golfers and enthusiasts, engaged in an 18-hole friendly golf tournament, allowing them to experience the country's world-class golf facilities and scenic courses.

'BAD BOY' IN ETHICS COMMITTEE

Out of all the 24 senators who took their oath of providing service to their nation, one of them was a television star being considered to take the position as the Chairman of the Committee on Ethics and Privileges. And he was an ex-convict.

On August 11, Senate Majority Leader Joel Villanueva shared that Senator Robin Padilla—famously known as the “Bad Boy” of Philippine cinema—is being considered to head the Senate Committee on Ethics and Privileges. However, Villanueva clarified that the appointment isn’t final yet, as it still needs to be approved by the plenary.

Villanueva also floated the idea of Padilla possibly leading the Senate Committee on Constitutional Amendments and Revision of Codes to Senator Francis “Kiko” Pangilinan, but noted that having a legal background, specifically, being a lawyer, is also an important factor in deciding who should take on the role.

As stipulated on the Senate’s website regarding the powers vested upon the Committee on Ethics and Privileges and to its Chairman, the body has “jurisdiction on all matters relating to the conduct, rights, privileges, safety, dignity, integrity and reputation of the Senate and its Members.” The Chairman, however, has the jurisdiction to designate its Vice Chairperson, appoint subcommittees, hold special meetings, and punish/cite in contempt any witness before the Committee who refuses to testify to a proper question by the Committee or any of its members.

With the power given to being a chairman of a committee, the question that continues to loom along the lines of morality and popularity, is Robin Padilla the right candidate for the committee’s chairmanship?

Well, his records tell otherwise. While most of his “Bad boy” portrayals as an actor in his films, starting from 1985 down to 2022, projected, or as what the Gen Zs are calling it: foreshadowed, perhaps, in his real-life events.

In 1992, Robin was apprehended by authorities in a hit-and-run accident that led to a discovery, upon car inspection, of several firearms with reported live ammunition. He was sentenced 17 to 21 years in prison for illegal possession of firearms in 1994, but was granted by conditional pardon by then-president Fidel Ramos in 1998, and now, after he supported and campaigned the past Duterte administration, Padilla then received from



Duterte’s post an absolute pardon – completely restoring his civil and political rights like nothing happened – allowing him to run as a senator in 2022 senatorial race.

Following his controversy in 1992, his wife, Mariel Padilla, was seen having an IV drip session inside the Senate last February 22, 2024. This controversy was clearly a disrespect and dishonouring of the office’s formality, where Robin only laughed off the misconduct as a response. How about him being called out countless of time by senators for his lack of decorum, for example, the plenary session on May 16, 2023, where Sen. Joel Villanueva pointed out the concern to observe proper decorum in the Senate after the misused of words made by Robin Padilla in answering the legislators; and the combing of his mustache when Senator Raffy Tulfo was giving his privileged speech during a Senate hearing on May 15, 2023?

Although there was still more to illustrate in providing unethical cases that Robin Padilla was involved, like his former Senate staff, Nadia Montenegro, who was included in the incident report made by Senate Office of the Sergeant-at-Arms (OSAA) that explains the alleged use of marijuana inside the premises, then later resigned; and when the same person who pointed out his concern for a lack of decorum

in the office, Joel Villanueva, was also the one who “almost came into blow” with Padilla regarding the hearing on VP Sara’s impeachment last June 10, 2025 – it only means one thing: recalibration of the imposed qualification on who are responsible and best fit to run for the office.

Because by virtue of service and right conduct as lawmakers and legislators of policies, there should be a deep and real understanding of how to be a good, responsible, and ethical leader, first and foremost, especially if you will be the one to head the ethics body.

It’s ironic for someone with a history of unethical conduct to be the head of an ethics body, especially when they secured the position based on popularity. The integrity, accountability, and public trust that a person builds over the years are sacrificed every time we choose a popular figure from the entertainment industry.

The legislative office is not a laughingstock or a form of entertainment.

There should be a clear distinction between being a celebrity and a legislator, once and for all. Reconsideration is not the solution; instead, the requirements for becoming a legislator and the qualifications for committee chairs should be recalibrated.

the sector.

Mr. Paul John Profeta, Amadeo LGBTQIA+ President, set the tone with his message, stressing the value of respect and empathy shown to every gender.

Likewise, Hon. Jojo Domingo expressed his hope for openness and understanding among his constituents, saying "Sana po sa bayan ng Amadeo, magkaroon po tayo ng openness. Mr. Timothy Joshua Vargas, President and Co-founder of Mobility Vision+, showcased smart mobility solutions that leverage digital platforms and data analytics to improve transportation efficiency in cities.

Dr. Audy R. Quebral, Project Leader of eTram and CEO of Aparri Campus, discussed the development of an eco-friendly transport system aimed at cutting carbon emissions and supporting sustainable urban growth.

These presentations were followed by an engaging open forum where participants exchanged ideas on blending science, culture, and technology for sustainable progress.

R&D Summit 2 centered on community-focused research tackling social welfare, disaster preparedness, and agriculture:

Dr. Noel S. Gunay of Mindanao State University-General Santos introduced "ItWatcher," an AI-powered 24/7 traffic monitoring system designed to enhance road safety and traffic flow in General Santos City.

Dr. Mary Jane K. Balawag of Notre Dame University presented her study on the psychosocial impact of maternal incarceration on children, highlighting the need for stronger social support systems.

Engr. Christopher A. Benito of the University of Southern Mindanao presented the "USM Center for Flood/Landslide Preparedness and Mitigation," a project aimed at strengthening community resilience through disaster risk reduction and early warning systems.
